




## Preparing To Play

- 1 Use a coin to remove battery door. Push screw in and turn coin counterclockwise to lift battery door.



- 2 Insert 4 AA alkaline batteries (included).



- 3 Place battery door back in place and use coin to turn screw clockwise to tightly close battery door. Do not over tighten.

- 4 Remove the lid by placing your finger in the circular slot and pressing down on the latch release. Store your letters in the playset when not in use.



- 5 To interact with the Square Panda™ games for the iPad®, place the letters, silver side down, in one of the eight letter slots as instructed by the game.



- 6 Download Square Panda™ games for iPad® from the App Store®.


- 7 Launch a Square Panda™ game.


