Test Procedure:

1)9 kHz to 30 MHz emissions:

For testing performed with the loop antenna, testing was performed in accordance to ANSI C63.10. The centre of the loop was positioned 1 m above the ground and positioned with its plane vertical at the specified distance from the EUT, During testing the loop was rotated about its vertical axis for maximum response at each azimuth and also investigated with the loop positioned in the horizontal plane.

2)30 MHz to 1 GHz emissions:

For testing performed with the bi-log type antenna, testing was performed in accordance to ANSI C63.10. The measurement is performed with the EUT rotated 360°, the antenna height scanned between 1m and 4m, and the antenna rotated to repeat the measurement for both the horizontal and vertical antenna polarizations.


3)1 GHz to 25 GHz emissions:

Test site with RF absorbing material covering the ground plane that met the site validation criterion called out in CISPR 16-1-4:2007 was used to perform radiated emission test above 1 GHz.

For testing performed with the horn antenna, testing was performed in accordance to ANSI C63.10. The measurement is performed with the EUT rotated 360°, the antenna height scan between 1m and 4m, and the antenna rotated to repeat the measurement for both the horizontal and vertical antenna polarizations.

For the radiated emission test above 1GHz:


Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.








The specifications for the measuring instrument using the CISPR quasi-peak detector can be found in Publication 16 of the International Special Committee on Radio Interference (CISPR) of the International Electrotechnical Commission. As an alternative to CISPR quasi-peak measurements, the responsible party, at its option, may demonstrate compliance with the emission limits using measuring equipment employing a peak detector function, properly adjusted for such factors as pulse desensitization, as long as the same bandwidths as indicated for CISPR quasi-peak measurements are employed.



When average radiated emission measurements are specified in this part, including average emission measurements below 1000 MHz, there also is a limit on the peak level of the radio frequency emissions. Unless otherwise specified, e.g., see §§ 15.250, 15.252, 15.255, and 15.509-15.519 of this part, the limit on peak radio frequency emissions is 20 dB above the maximum permitted average emission limit applicable to the equipment under test. This peak limit applies to the total peak emission level radiated by the device, e.g., the total peak power level. Note that the use of a pulse desensitization correction factor may be needed to determine the total peak emission level. 
1). The field strength is calculated by adding the Antenna Factor. Cable Factor & Preamplifier. The basic equation with a sample calculation is as follows:

Final Test Level = Receiver Reading + Antenna Factor + Cable Loss – Preamplifier Factor.

- 2). As shown in Section, for frequencies above 1000 MHz. the above field strength limits are based on average limits. However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation.
- 3). The test only perform the EUT in transmitting status since the test frequencies were over 1GHz only required transmitting status.
- 4). For Radiated Emissions fall in the restricted bands (2400MHz is worse case than 2390MHz and report it as above), which set out in Section 15.205 Restricted bands.

Also there is not any other emission which falls in restricted bands can be detected and reported.

Test result: The unit does meet the FCC requirements.












Test in the frequency 2460MHz (20 dB bandwidth)





For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage.

Pre-Scan has been conducted to determine the worst-case mode from all possible combinations between available modulations, data rates and antenna ports (if EUT with antenna diversity architecture).




Test procedure:

- 1. The mains terminal disturbance voltage test was conducted in a shielded room.
- 2. The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a $50\Omega/50\mu\text{H} + 5\Omega$ linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.
- 3. The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane, but separated from metallic contact with the ground reference plane by 0.1m of insulation.
- 4. The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0,4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0,8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0,8 m from the LISN 2.

7.2.3 Measurement Data

Remark: Because the EUT employ battery power for operation and which do not operate from the AC power lines or contain provisions for operation while connected to the AC power lines. Measurements to demonstrate compliance with the conducted limits are not required for devices.









8.1 Radiated Emission Test Setup
