5 Test results and Measurement Data

5.1 Antenna Requirement

15.203 requirement: An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. 5.2 Worst-case configuration and mode

The fundamental of the EUT was investigated under three orthogonal orientations X, Y, and Z. The X orientation was determined to be the worst-case orientation.
Although these tests were performed ther than open area test site, adequate comparison measurements were confirmed against 30m open are test site. Therefore sufficient tests were made to demonstrate that the alternative site prduces results that correlate with the ones of tests made in an ope field based on KDB 414788.




Figure 1. Below 30MHz




Figure 1. Below 30MHz




Figure 2. Above 30MHz


