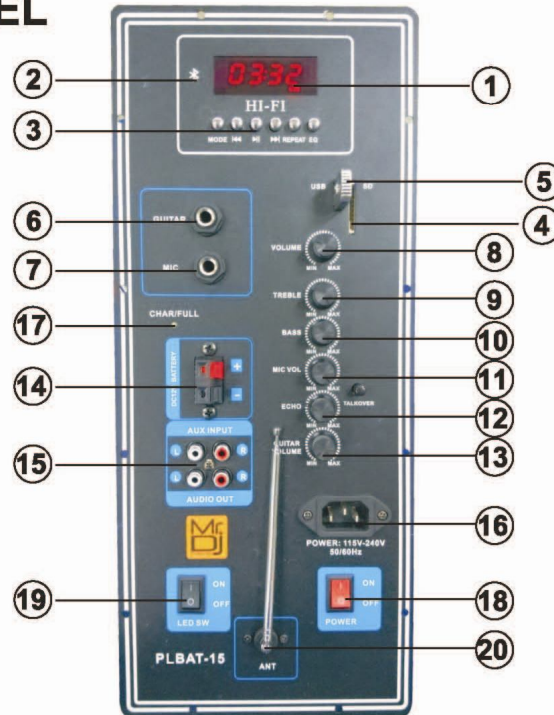

Basic Operating Instructions

Before connecting the speaker, make sure the system is in “OFF” position and the controls on the minimum level, to prevent speaker damage / abuse.

- 1. Plug the Microphone (Included in Package) into the Quarter Mic Input
(Refer to Page 4- Illustration No. 6)**
- 2. Connect Your Selected Audio Source (CD, DECK, Mp3, DVD, etc) on “LINE IN/LINE OUT” input/output
(Refer to Page 4- Illustration No. 15)**
- 3. Turn on the systems. Mp3 LED will light up to indicate the speaker is on
(Refer to Page 4- Illustration No. 16 and 18)**
- 4. Insert USB or SD Card for MP3 Player (May Not Support Large Storage Cards - 16GB Tested)
(Refer to Page 4- Illustration No. 4 and 5)**
- 5. Set TREBLE and BASS controls to equalize the sound.
(Refer to Page 4- Illustration No. 9 and 10)**
- 6. Monitor LED Red Light (CHARGING)- When light comes on your speaker is detecting an overload
(Refer to Page 4- Illustration No. 17)**
- 7. Connect power cord to wall outlet then to the back of the unit
(Refer to Page 4- Illustration No. 16)**
- 8. Default Power Selected is 110-240V (For Asia / European Market) Please choose correct voltage.

- 9. Select the Audio Player Mode to either USB / SD / FM*or Bluetooth® * through the selector.
