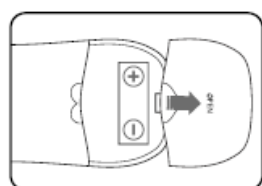
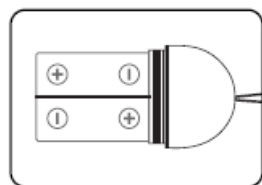


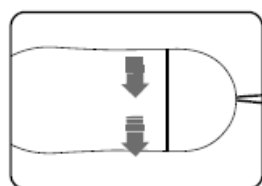

## PRODUCT CHARACTERISTICS

Cry baby is a vibrating egg which can be remotely controlled by means of a wireless remote control handset.

- Material: 100% ABS

## INSTRUCTIONS FOR USE

1. Insert the LR23 12V battery in the remote control
  2. Insert the 2 LR03 AAA 1.5V batteries in the egg.
  3. Carefully close the casing, ensuring that the seal is in place and that your egg is fully watertight.
- Your Cry baby is now ready to be used.

## RECOMMENDATIONS AND WARNINGS

- We recommend the use of lubricant.
- Do not use your vibrator on swollen areas or if you have small cuts. Stop using if you feel pain or discomfort.
- If, after a long period of use, the product gets hot, stop using it and leave to cool.

**/!\ Pregnant women: we strongly recommend against using this product**

## CLEANING AND CARE

Your vibrator will last longer if you look after it.

- Clean it before and after each use with antibacterial cleaner.
- Do not use an alcohol-based, acetone-based or petrol-based cleaning product.
- Keep it away from dust, light and heat.
- Keep it away from toys made of other materials.
- Always remove the batteries from the egg casing and the remote control to avoid them losing their charge.
