OPERATIONS**To set up the charging station:**

Insert the USB-C end of the included power cable into the USB-C port on the back of the charging station. Insert the other end into the included 30W PD wall adapter and plug it into an appropriate wall outlet.* The charging station will automatically power on, and the LED indicator light will turn solid green to show it is ready to charge your device(s).

LED INDICATOR LIGHT BEHAVIOR

Green Solid Light	The charging station is powered on.
Blue "Breathing" Light (the light fades in and out slowly)	Your device(s) are charging.
Blue Blinking Light	There is an issue with charging (see troubleshooting section).
Blue Solid Light	Your phone is done charging.**

**NOTE: The indicator light behavior may vary depending on the type of phone and number of devices being charged. In some cases, the light will continue "breathing" even after charging is complete.

**To operate the touch-activated motor:**

Press the touch activation button to rotate the iPhone charging pad between two positions, upright and flat.

Important:

Do not attempt to manually turn the motor, as this may cause damage to the device.

*For optimal performance, use the included 30W PD wall adapter. If you use a different wall adapter or plug the USB cable directly into a compatible charging port, be sure to verify that it supports PD charging at 9 volts.

IMPORTANT: TO PREVENT DAMAGE TO THE DEVICE, DO NOT MANUALLY TURN THE CHARGING AREA. ONLY TURN USING THE TOUCH ACTIVATION BUTTON.

CAUTION: To prevent damage to the phone or the charger: Remove metal cases, or cases with any magnet/metal components, from phone before charging. Do not place metal objects on the charger during charging. Qi wireless chargeable phones with metallic looking finishes will charge normally.

Note: Very thick phone cases can obstruct wireless charging. For effective charging, it may be necessary to reposition the phone or remove the case.

Note: Wireless chargers generate heat when charging, and the charger may temporarily stop charging if it gets too hot.


- Place the product on a sturdy, flat surface during use.
- Use the specified power source and voltage.
- Do not use a voltage converter/travel adapter.
- Make sure the USB cable is inserted fully in the product and the power source. When not in use, unplug the USB cable from the power source.
- Do not cover the product with paper or other materials. Use in a well-ventilated area when charging.
- Do not place magnetic strip cards or similar magnetically sensitive item between the phone and the charger. Wireless charging uses magnetic induction that could damage these items.
- Do not expose the product to extremely high or low temperatures.
- Keep the product away from heat sources and direct sunlight.
- Do not expose the product to open flames.
- Do not let the product come into contact with water or liquid. If it becomes wet, immediately, and safely, unplug from the power source.



This wireless charging station is used for charging compatible iOS devices. These include:

- iPhone® series 12 and higher
- AirPods® Pros, 1st and 2nd generation, AirPods® 3rd and 4th generation
- Apple Watch® series 1 and higher

NOTE: This product may work with other Qi-compatible devices, but certain features including the magnetic snap function & fast charging may not be available.

OPERATIONS**To use the retractable charging platforms:**

Gently press on the retractable slots to open the charging platforms. When you are done using them, gently press them inward until they retract back into the charging station and click into place.

TO OPEN**TO RETRACT****TIPS**

To prevent damage to the device or the charger:

- Remove metal cases, or cases with any magnet/metal components, from phone before charging (unless it is a case intended for use with magnetic wireless chargers)
- Do not place metal objects on the charger during charging
- Qi wireless charging phones with metallic looking finishes will charge normally.

NOTE: Very thick phone cases can obstruct wireless charging. For effective charging, it may be necessary to reposition the phone or remove the case.

TROUBLESHOOTING

The LED indicator light is blinking blue (error message).

1. Make sure you are charging your device on the correct charging platform, and that the device is properly aligned with the platform.
2. Remove metal cases from your device and be sure there are no foreign metal or metal-containing objects (e.g., keys, coins) on the charging platforms.
3. Check your power adapter and confirm it is PD compatible and outputs at 9 volts.
4. Confirm you are using the provided USB-C cable. Note that other USB-C cables may not provide enough power and could affect performance.
