

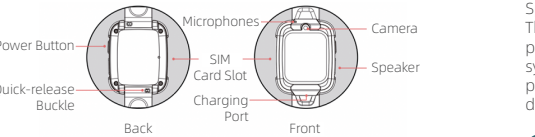

02 Supported SIM Card Type: Nano-SIM Card

Thank you for choosing IDK01 Kids Smart watch!The wrist phone supports 4G network. Make sure a SIM card is inserted.
(1)Make sure the calling line identification presentation service has been activated.
(2)Make sure the Internet service has been activated, with the data traffic of 200 MB and above.
(3) Make sure the 4G service has been activated.For a new SIM card, please activate it by inserting the SIM card into the wrist phone or with the help of the carrier.Please use a standard Nano card (do not independently cut the card using a card cutter).

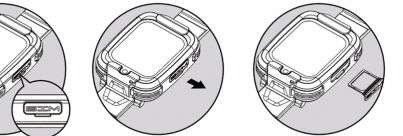

Please choose the appropriate network operator. The positioning and calling functions of this product rely on

the signal quality provided by the network operator. It is prohibited to use a card cutter to insert the SIM card into the watch card slot, as this may cause waterproof failure, damage to the card slot, and the SIM card may not function properly. 03 Installation of SIM Card

1. Use a SIM card removal tool to pry the card tray out of the watch body.
2. Place the Nano-SIM card inside the tray, and then insert the tray back into the watch body. Make sure insert it firmly to ensure water-resistance effect



04 Install Mobile App

Search "VeryFit Kids" in the smart phone's app store, download and install.



05 Power on

Power on: Press the power button for 3 seconds, the watch will display an animation to indicate that it has successfully powered on.

Power off: Long press the power button for 3 seconds to bring up the confirmation page when it is in the powered-on state and then Click "power off".



06 Charging the Watch

Please correctly insert the Type-C charging cable into the charging port of the watch until the charging indicator appears on the watch screen.

Please use a power adapter that has been certified by the national 3C certification to connect the cable to charge the watch.

- Note:
1. Do not charge the watch in a damp or water-filled environment.
 2. Please make sure that there is no dirt or corrosion on the metal parts of the watch and the charging cable.
 3. This product does not come with a power adapter. To ensure the safety of your family and property, you can use a

computer's USB port or choose a power adapter with CCC certification for charging. Please purchase a power adapter from a reputable source and avoid using low-quality or counterfeit adapters to prevent explosions or fires.

If the binding process fails due to poor network or signal, try again in a different environment with better connectivity.

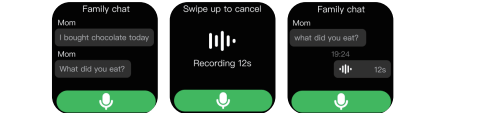
11 Activate SOS

12 Voice chat

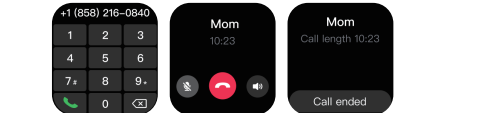
Swipe to the voice chat interface in the function list. After entering, select the corresponding contact or group to send and receive voice messages.
