Limit:	In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.
Exploratory Test Mode:	Hopping and Non-hopping transmitting with all kind of modulation and all kind of data type
Final Test Mode:	Only the worst case is recorded in the report.
