




The Description Of The Product



Connection Mode

① On/Off


Pressing power key for 2 seconds.
Z1 Bluetooth speaker will be Bluetooth mode automatically.



② Connecting with mobile device

Turn on the mobile device and Z1 speaker's bluetooth, then connecting "Z1" on the digital device.

Function




1. Bluetooth Player
Connecting your smartphone with the speaker, then you can control the speaker by your smartphone.

2. 3.5mm Audio Input Port

Playing music through connecting the speaker with digital device by audio cable.


* Now, if the Bluetooth music has been input, you can switch the Bluetooth mode.



3. TF Card Reading

It automatically switches into playing TF card music after the TF card is input

4. Smartphone
Z1 speaker will have voice prompt when there have phone call during the phone connecting with the speaker.
And you can answer the call by Z1 speaker.
