## Instruction Manual (Read before proceeding)

### Power:

- Please charge your Bluetooth speaker fully before its first use.
- Operates using an internal rechargeable Lithium battery.  
To charge the battery:
  - Using a Micro USB cable (included), insert the USB power cable into the micro USB port located on the back of the speaker. Connect the other end of the USB cord into a powered USB source such as a computer, laptop or USB AC adapter (not included).
  - When your Bluetooth speaker is charging, the indicator light will turn red.
  - Once your Bluetooth speaker is fully charged, the red light will turn off.

### Playing Music Via Bluetooth

- Turn your Bluetooth speaker on by sliding the power switch located on the back of the speaker to 'ON' position.
- The indicator light will turn blue. This indicates that the speaker is in pairing mode and is searching for your Bluetooth device.
- Make sure the Bluetooth function on your device is turned on.
- Search the speaker named, "BT-09".
- Once you have selected the speaker, your device will pair without a password. (If your device prompts for a password, enter the password "0000".
- Once your speaker is paired, the indicator light will begin to flash blue slowly.
- Start playing music on your device. Make sure that you keep your device within a 33 feet range of your Bluetooth speaker.
- Adjust the volume of your device to a comfortable level.
- Turn off the unit when it is not in use.

### Universal Speaker Operation:

- For devices that are not Bluetooth enabled, use the audio input cable (not included)
- Insert the 3.5mm input jack into the "AUX" port
- Turn on the unit by sliding the power switch located on the back of the speaker to 'ON' position and start listening to music.

### Warning:

- This is not a toy. Please keep away from small children.
- Please keep away from water and heat.
- Low battery may cause poor connection and/or may cause the Bluetooth function to not work.
- Do not over charge the battery.
