#### GETTING STARTED

Before using this device, fully charge it.

#### CHARGING

1. Open the Port Protective Cover located on the right side of control panel.
2. Connect the small end of the USB Type-C charging cable (included) to the USB Type-C charge port.
3. Connect the larger end of the cable to your computer's USB-A port or an AC adapter (not included). The LED indicator will turn red while charging. When fully charged the LED red light will disappear.
4. Unplug the charging cable from the power source.

#### PAIRING

1. Turn on your Speaker and push the ON/OFF button for 5 seconds to put it in pairing mode.
2. On your pairing device go to Settings and select Bluetooth® connection.
3. Turn on Bluetooth® if it's not already on.

4. Select the "CL-BS-115" Speaker name to connect from the list of available devices. "Connected" message will appear to indicate it is connected successfully. The Speaker will connect automatically the next time.

#### USING THE SPEAKER

A magnetic surface on a back of the Speaker allows it to quickly attach to metallic surfaces like refrigerators or gym equipments, providing a convenient way to attached the Speaker hands-free in various locations.

#### "+" Button

Short press: Next song

Long press: Increase volume

#### Switch Mode Button:

Short press: Ultra Micro SD card/FM Radio

Long press: Change LED light effects

#### • Power Button

Long press: Power ON/OFF

Short press: Play/Pause the music

Double press: TWS function

Press once: Answer/Hang up a call

Long press for 2 seconds: Reject a call

#### "—" Button



Short press: Previous song

Long press: Decrease volume


#### PHONE CALLS

When there is an incoming call, the unit will pause the playback and ring to alert you of the call.

To operate the incoming calls, see instruction above for the Power Button function. Volume controls may not work during phone calls with some smartphone models.

**TROUBLESHOOTING**

No power:  
Recharge your speaker using the included USB Type-C charging cable. Try using a different cable.

Music is not playing or the volume is too low:  
Make sure your Bluetooth® device has A2DP profile. Check the volume of your smartphone or the Speaker and adjust the volume. Check if the battery level is too low, please recharge it. Check if both devices are paired and connected over Bluetooth®. Restart the Speaker to reconnect to Bluetooth® device.

Make sure you are within 33 ft of the effective connection distance. Check if there is any obstacle between the speaker and your device.

Bluetooth® device will not reconnect with the Speaker:  
Navigate to your Bluetooth® settings menu on your device, tap "CL-BS-115" and select "Forget". Now follow the steps to pair your device again.
