Predication of MPE limit at a given distance

$$S = \frac{PG}{4\pi R^2}$$

Where: S = power density (in appropriate units, e.g. mW/cm²)

P = power input to the antenna (in appropriate units, e.g., mW).

G = power gain of the antenna in the direction of interest relative to an isotropic radiator, the power gain factor, is normally numeric gain.

R = distance to the center of radiation of the antenna (appropriate units, e.g., cm)

For the antenna manufacturer provide only used limited to ERP/EIRP or radiated spurious emission test. The MPE evaluation as below:

The maximum peak output power (turn-up power) is 16dBm

Maximum peak output power (turn-up power) at antenna input terminal: 39.8 (mW)
