## 5 SAR Evaluation

### 5.1 RF Exposure Compliance Requirement

#### 5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v06

##### 4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### 5.1.2 Limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$$\left[ \frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt{f(\text{GHz})} \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

$f(\text{GHz})$  is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 5.1.3 EUT RF Exposure

The Max Conducted Peak Output Power of UWB is -10.00dBm in highest channel(4.5GHz), The Max Conducted Peak Output Power of UWB is 2.16dBm in lowest channel(2.402GHz);

The best case gain of the UWB antenna is 0dBi. And the best case gain of the Bluetooth LE antenna is 0.5dBi.

$$\text{EIRP}_{(\text{UWB})} = -10.00\text{dBm} + 0\text{dBi} = -10.00\text{dBm} = 0.1\text{mW}$$

$$\text{EIRP}_{(\text{BLE})} = 2.16\text{dBm} + 0.5\text{dBi} = 2.66\text{dBm} = 1.84502\text{mW}$$

According to the formula. calculate the EIRP test result:

$$\left[ \frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt{f(\text{GHz})}$$

$$\text{General RF Exposure}_{(\text{UWB})} = (0.1\text{mW} / 5 \text{ mm}) \times \sqrt{4.5\text{GHz}} = 0.042 \quad (\text{I})$$

$$\text{General RF Exposure}_{(\text{BLE})} = (1.84502\text{mW} / 5 \text{ mm}) \times \sqrt{2.402\text{GHz}} = 0.572 \quad (\text{II})$$

$$\text{I} + \text{II} = 0.614 \quad (\text{III})$$

SAR requirement:

$$S = 3.0 \quad (\text{IV});$$

$$\text{III} < \text{IV}.$$
