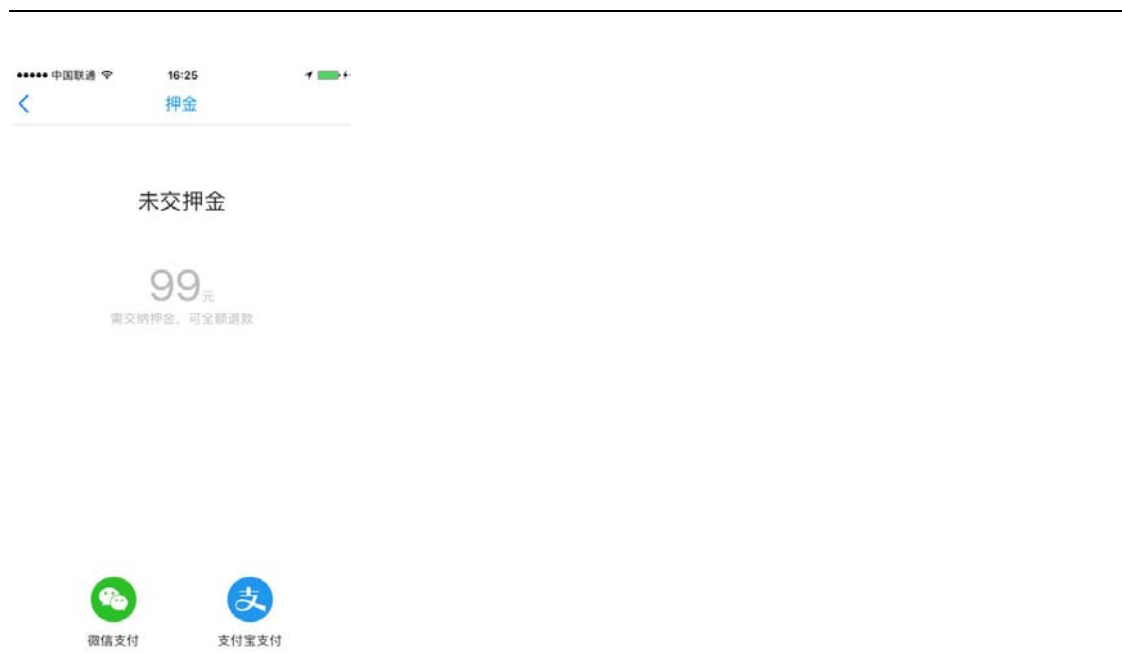
## 2.2 Registered prepaid phone

Enter the phone number, get after verification code to enter the password to determine account registration.

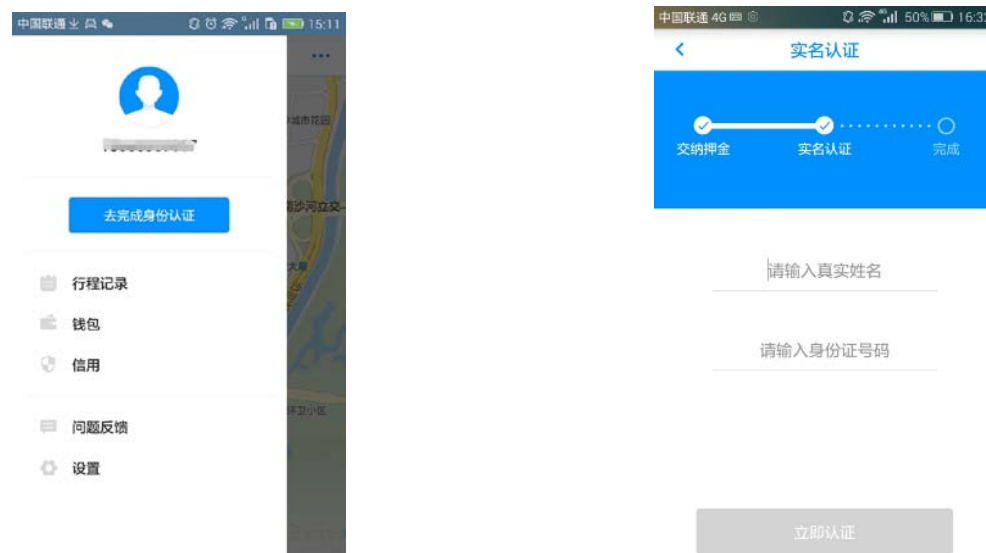


After the success of the account registration, needs 99 yuan deposit, the deposit payment after the success of real-name authentication.
