

## 7.2 Antenna Requirement


For intentional device. According to 15.203. an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

The antenna is chip antenna and no consideration of replacement. The best case gain of the antenna is -0.5dBi.




1. Remove the antenna from the EUT and then connect a low attention attenuation RF cable (cable loss =1.5dB) from the antenna port to the spectrum.
2. Set the spectrum analyzer: RBW=100 kHz. VBW = 300 kHz. Sweep = auto; Detector Function = Peak. Trace = Max Hold, Set span to encompass the entire emission bandwidth of the signal.
3. Mark the peak power frequency and -6dB (upper and lower) power frequency.
4. Repeat until all the test status is investigated.
5. Report the worse case.








## 7.4 Maximum Peak Output Power

Test Requirement: FCC Part 15 C section 15.247  
(b)(3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt.  
Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b) (1), (b) (2), and (b) (3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

Test Method: ANSI C63.10: Clause 11.9  
Test Status: Enter test mode for the product. Test in Channel lowest (2402MHz), middle (2442MHz) and highest (2480MHz), keep in continuously transmitting status.

Test Configuration:



**Test Procedure:**

1. Remove the antenna from the EUT and then connect a low attention attenuation RF cable (Cable loss =1.5dB) from the antenna port to the spectrum.
2. Set the RBW = 1 MHz.
3. Set the VBW  $\geq$  3 x RBW
4. Set the span  $\geq$  1.5 x DTS bandwidth.
5. Detector = peak.
6. Sweep time = auto couple.
7. Trace mode = max hold.
8. Allow trace to fully stabilize.

Use the instrument's band/channel power measurement function with the band limits set equal to the DTS bandwidth edges (for some instruments, this may require a manual override to select peak detector). If the instrument does not have a band power function, sum the spectrum levels (in linear power units) at intervals equal to the RBW extending across the DTS bandwidth.






Channel 0:2.402GHz:


## 7.5 Peak Power Spectral Density

Test Requirement: FCC Part 15 C section 15.247  
(e) For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.  
This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.






Channel 0:2.402 GHz:




Channel 20:2.442GHz





#### Test Procedure:

Test site with RF absorbing material covering the ground plane that met the site validation criterion called out in CISPR 16-1-4:2010 was used to perform radiated emission test above 1 GHz.

The receiver scanned from the lowest frequency generated within the EUT to 25GHz. When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was

1. The mains terminal disturbance voltage test was conducted in a shielded room.
2. The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a  $50\Omega/50\mu\text{H} + 5\Omega$  linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.
3. The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane, but separated from metallic contact with the ground reference plane by 0.1m of insulation.
4. The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0,4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0,8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0,8 m from the LISN 2.




