

Product Manual

We're so thankful for your interest in this revolutionary product and cannot wait for you to try it out. We hope this manual will get you started quickly.

What's in the box

A smart garment, with a built in battery. There is no need to charge your smart garment, the built in battery should last for plenty of measurements under typical conditions.

Setting up your garment

Download LikeAGlove free App from Apple store or Google play. Sign up and create your LikeAGlove account. Note that personal information provided during sign up helps the App provide better size recommendations. Follow the tutorials within the App.

The logo and the orange patch indicate the front of the garment. In the middle of the orange patch there is an ON button. Tap it to turn the garment on. No need to turn the garment off, it turns itself off automatically after use.

Garment care

The garment is intended to measure you; put it on, measure, take it off. You are putting it on just for a minute to measure yourself, so it should stay clean and fresh over time.

Do not wash, dry wash or iron the garment, as it will damage it. Consider keeping it in original box to prolong its life. Do not wear it as clothing or work out in it.

Safety

- Do not wash the garment!

It might damage it and pose a hazard as the garment contains a coin cell lithium battery.

- Keep away from children!

Do not tear off the protective orange patch, coin cell battery inside is a choking hazard for kids. If battery is removed and swallowed seek immediate medical assistance.

- This product is not intended for use by children under 16 years of age.
- Do not expose the garment to fire or heat, lithium batteries might ignite.
- Do not use this product if you have a pacemaker or other medical device.
- Do not use this product if you are pregnant or have a medical condition.
- Do not dispose of your smart garment in a fire. The battery could explode.
- Do not tamper with your smart garment.
- Do not use abrasive cleaners to clean your smart garment.
- Do not place your smart garment in a dishwasher, washing machine or dryer.
- Do not remove the orange patch. Substances contained in this product may damage the environment or human health if disposed of or handled improperly.
- Never allow children to play with the smart garment; the small components within the garment may be a choking hazard.

How to use the Garment


Sign up

Download LikeAGlove free App from Apple store or Google play. Sign up and create your LikeAGlove account. Note that personal information provided during sign up helps the App provide better size recommendations. Watch the tutorials within the App.

Measure

- Run the LikeAGlove App. Log in. Make sure Bluetooth is on. Go to measure screen. (App runs on ios and android mobile phones and tablets only).
- Put the garment on (orange patch goes in front), make sure that the inseam stitch is straight, if its leggings. Turn the garment on, by pushing the ON button in the center of the orange patch.
- Stand up straight. Press “measure” on the App and stand still for five seconds and the garment measures you. Once measure is done, a “save” button will highlighted. Re-measure again if you wish or save your measurements.





Jeans Catalog
