




Indicator

Waiting for connection: the red and blue indicators flash alternately
Connection succeed: the blue indicator blinks 7 times then no blinks.
Playing music: when playing music , the blue indicator blinks 3 times then no blink.
Charging: the red indicator is on the blue indicator blinks 7 times then no blinks.
Charging completed: the red indicator off and blue indicator is on
Low power: the red indicator is on with voice hint

Operation manual

- Turn on or off: press the multi fuction button 3 secs for on or off
- Pairing: when it's off , press the multi fuction button for 4 secs
- Answer/hang up: click the multi fuction button .
- Hang up the in call: press the multi fuction button for 2 secs
- Previous/next song: click the button+/button- twice
- Sound volume +/-: long press the button+/button-
- Microphone mute: while speaking in a call , click the button- twice , then microphone won't work
- Call the latest person you called:when connected , click the multi fuction button twice to call the latest person you called before
- Answer in phone: when you are having a call, long press the multi fuction button to answer the call with your mobilephone
- Reboot it: when it was connected , long press the multi fuction button , button- and button+ for 5 secs until it vibrates
- Massage: click the button+ and button- twice in the same time

How to connect

When it turns off , long press the multi fuction button 4 secs, then open the Bluetooth in your mobile , search the device and click the name of WBT-02
