
- To prevent fire or electric shock hazard, keep away from rain or moisture. The Bridge must not be exposed to dripping or splashing.
- Never use any liquid (including water) or cleaning fluid or similar chemicals on or near the Bridge. Do not spray cleaners on the Bridge. To clean simply wipe the Bridge with a soft cloth.
- Do not cover the Bridge or block the airflow to the Bridge.
- Do not expose the Bridge to temperatures below freezing.
- Do not connect the plug into an extension cord, receptacle, or other outlet unless the plug can be fully inserted with no part of the blades exposed.
- Do not overload outlets or extension cords, as this can result in a risk of fire or electric shock. Overloaded AC outlets, extension cords, frayed power cords, damaged or cracked wire insulation, and broken plugs are dangerous. They may result in a shock or fire hazard.

Wireless Bridge Status Indicators

Wireless Bridge Status Indicators

When plugged into an outlet with power, there are three LED lights on the front of the bridge that will communicate bridge status.

- Top LED blinks once, about 10-12 seconds after the boot process is complete.
- Middle LED is normally on. If it is blinking, that suggests the device has been physically reset (by pin), and needs to be set up again.
- Bottom LED suggests the device is powered. It is almost always on. The moment the unit is plugged in, it will come on.



Note: You will need to restore to factory settings any time you change your wireless network or credentials. To restore to factory settings, press the *Reset* button by inserting a pin into the small hole on the side of the bridge for 10 seconds. After the 10 seconds, the device will flash slowly 3 times and restart. Please contact support@phin.co should you need a detailed pHin user manual.

ConnectedYard, Inc. (“pHin”) warrants to the original purchaser that your pHin Devices will operate in accordance with pHin’s applicable documentation under normal use in all material respects as long as you have an active, paid subscription for the pHin pool services (the “Warranty Period”). If a defect arises during the Warranty Period, your sole and exclusive remedy and pHin’s

sole and exclusive obligation to you, at its option will be to either (1) repair the defective pHin Device at no charge using new parts or parts that are equivalent to new in performance and reliability should the hardware revision allow for such repair, (2) replace the defective pHin Device. This Limited Warranty is valid only in the jurisdictions where the applicable pHin Device is sold by pHin itself or through its authorized reseller or agent, and is valid to the extent permitted by the applicable laws of such jurisdictions. Any pHin Device that has either been repaired or replaced under this Limited Warranty will be covered by the terms of this Limited Warranty for the remaining Warranty Period.

This Limited Warranty applies only to the original purchaser of the pHin Device that was purchased from an authorized retailer or sales channel and manufactured by or for pHin that can be identified by an authorized “pHin” trademark, trade name, or logo affixed to it. Without limiting the foregoing, the Limited Warranty does not apply to any (a) pHin products and services other than the pHin Devices, (b) non-pHin hardware products, including without limitation any knock off or counterfeit version of a pHin Device, or (c) pHin Devices that are, or pHin reasonably believes to be, stolen, or (d) pHin Devices with unsupported hardware revisions. Further, this Limited Warranty does not apply if you do not have an active, paid subscription to the pHin pool service, as the pHin Devices will not function without such subscription service.

This Limited Warranty does not apply to a pHin Device or part of any pHin Device that has been altered or modified (e.g. to alter functionality or capability) by anyone who is not a representative of pHin. In addition, the Limited Warranty does not cover damage to pHin Devices (or any part thereof) due to problems caused by your or a third party’s negligence, abuse or misapplication, other external causes (including, without limitation, third party hardware or software, accident, abuse, misuse, problems with electrical power, servicing or modifications not authorized by pHin) or usage not in accordance with these terms or any other documentation provided by pHin. Recovery and reinstallation of software programs and user data are not covered under this Limited Warranty.

To obtain warranty service, please contact pHin at support@phin.co. Proof of purchase may be required to verify eligibility. pHin may restrict warranty service for pHin Devices to the country where pHin or its authorized distributors originally sold the applicable pHin Device. No pHin reseller, agent, or employee is authorized to make any modification, extension, or addition to this Limited Warranty. If any term is held to be illegal or unenforceable, the legality or enforceability of the remaining terms shall not be affected or impaired.

IN NO EVENT WILL pHin'S TOTAL LIABILITY TO YOU FOR ALL DAMAGES, LOSSES OR CAUSES OF ACTION EXCEED THE AMOUNT YOU HAVE PAID pHin IN THE LAST SIX (6) MONTHS, OR, IF GREATER, ONE HUNDRED DOLLARS (\$100).

IF YOU ARE DISSATISFIED WITH THE pHin DEVICES OR ANY PORTION OF THE SERVICES PROVIDED IN CONNECTION THEREWITH OR WITH THESE TERMS, YOUR SOLE AND EXCLUSIVE REMEDY IS TO DISCONTINUE USE OF THE pHin DEVICES.

If you are a California resident, you waive California Civil Code Section 1542, which says: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor." If you are a resident of another jurisdiction, you waive any comparable statute or doctrine.

APPLICABLE LAW

This Limited Warranty shall be governed by the laws of the State of California, USA, without giving effect to any conflict of laws and principles that may provide the application of the law of another jurisdiction. Consumers in some jurisdictions may have legal rights under applicable national legislation governing the sale of consumer goods, including, without limitation, national laws implementing EC Directive 99/44. These rights are not affected by the warranties in this Limited Warranty.

YOUR USE OF THE pHin DEVICES IS SUBJECT TO ADDITIONAL TERMS AVAILABLE BELOW, WHICH MAY BE UPDATED FROM TIME TO TIME.
