




# 2 Charging

After unboxing MAD Gaze smart glasses, charge for at least **1 Hour** before use. Aligning the charger metal connection point with the one on MAD Gaze main body. After ensuring the two points are aligned, gently connect them together.





# 3 Cautions

- 3.1 Some users might experience skin irritation or skin allergies with prolonged use of the product. If you notice any symptoms, please discontinue wearing or using the product. - 3.2 This product contains electronic equipment, improper use might result in injury.





- 3.3 Do not wear this product while it is charging.
- 3.4 To avoid exceeding the weight-bearing limit of this product, do not put this product inside bags directly or expose to any other heavy objects.
- 3.5 This product has lower liquid ingression grade, avoid direct contact with water.
- 3.6 Keep this product clean and dry regularly.
- 3.7 Do not open the product case or disassemble it.



- 3.8 Stop using the product immediately if any cracks were found.
- 3.9 Substances contained in this product and its battery might jeopardize the environment or cause injury, pleas handle and dispose properly.
- 3.10 Do not exert force, shake, or place this product in environment with excessive dust, or fluctuating temperature and humidity. Protect this product from vigorous shock or vibration.

## Warranty Description

- 5.1 We will provide an all-round Three Guarantees Service for your product according to "The War-ranty Regulations of Three Guarantees" enacted by relevant authorities in the People's Republic of China.
- 5.2 Warranty period will be counted from the day the product is activated, for one year.





#### Warranty Description (Cons')

5.3 Within 7 days after the product is activated, if the product is malfunctioned, you can either return or replace your product, or you may wish to have it repaired by an authorized maintenance service provider.

5.4 From the 8th to 30th day after the product is activated, if the product is malfunctioned, you can either replace your product, or you may have it repaired by an authorized maintenance service provider.

#### Warranty Description (Cons')

5.5 Within 1 year after the product is activated, if the product is malfunctioned, you can have it repaired by an authorized maintenance service provider.

5.6 From the 30th day to 1 year after the product is activated, if the product is malfunctioned, and is still under malfunction after repairing for twice, you can exchange for another device with same model number and specification for free, by providing the maintenance records.





# Limited Warranty Policy

Your warranty services are valid under normal usage/application only, the following conditions are excluded from the Three Guarantees and there will be reasonably charge for the warranty service:

- 6.1 Fail to provide valid invoice
- 6.2 The free maintenance period of the product has expired.

- 6.3 Mechanical failure due to application of fittings not recognized by our company.
- 6.4 Damage caused by using non-original fittings or accessories, fail to operate the product according to the manual, or incorrect/improper handling of the product.
- \6.5 Damage caused by disassembling the product by repairer who is unauthorized by our company.

### Operation

The four icons at the top-left corner of MAD Gaze main interface are, from left to right respective—ly, Setting, Live-stream, Voice Input, and Remote



Input. When the icon turns RED, the function that icon represents is activated. Leaving the function on for long time will consume more energy, turn off the function if it is not in use.

#### Control - Tracker Bal

MAD Gaze is equipped with an in-built laser tracker ball, this tracker ball consists of a substantial button and touch-sensitive panel. The substantial button serves the "HOME" function of MAD Gaze, press this button in any interface can back to main interface. Swiping or lightly touching on the surface of the panel can perform the function of ENTER, ESCAPE or DRAGGING. Single tap (a light single touch) means (ENTER); Double tap means (ESCAPE); Single tap and swipe on the tracker ball means DRAGGING.



# Sleep Mode

The product will enter sleep mode in two conditions: Firstly, when there is no operations and idle for 15 seconds (Time can be adjusted in Setting); Secondly, when solely pressing the power button shortly.

To end the sleep mode, you can hold the power button shortly, press the tracker ball, or voice out the wake-up cue "ARES" to awaken the system immediately.
