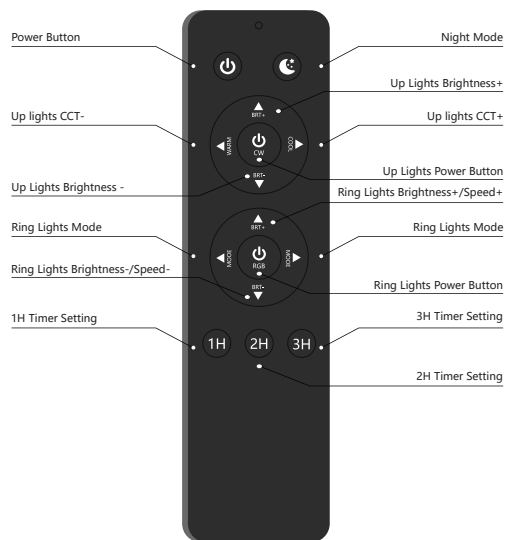

Button	Function
Power Button	Turn ON/OFF all the lights
Night mode	Night light mode
Up Lights Power Button	Turn ON/OFF the Up Lights
Up lights CCT-	Short touch: Cool white to Warm white by steps Long touch: Cool white to Warm white smoothly
Up lights CCT+	Short touch: Warm white to Daylight by steps Long touch: Warm white to Daylight smoothly
Up Lights Brightness+	Short touch: Dim Up Lights brighter by steps Long touch: Dim Up Lights brighter smoothly
Up Lights Brightness -	Short touch: Dim down Up Lights by steps Long touch: Dim down Up Lights by smoothly
Ring Lights Power Button	Turn ON/OFF the Ring lights
Ring Lights Mode	Short touch: Browse previous Ring lights modes Long touch: N/A
Ring Lights Mode	Short touch: Browse later Ring lights modes Long touch: N/A
Ring Lights Brightness+/Speed+	Short touch: Increase the Brightness or Speed by Steps Long touch: Increase the Brightness or Speed Smoothly

Button	Function

1H 1H Timer Setting	Lights turn off automatically in 1 hour
2H 2H Timer Setting	Lights turn off automatically in 2 hours
3H 3H Timer Setting	Lights turn off automatically in 3 hours
