1.7 Description Of Test Modes

Bluetooth operates in the unlicensed ISM Band at 2.4GHz. With the introduction of the enhanced data rate (EDR) feature, the data rates can be up to 3 Mb/s. An increase in the peak data rate beyond the basic rate of 1 Mb/s is achieved by modulating the RF carrier using GFSK techniques, resulting in an increase of two to three times the number of bits per symbol. The 2 Mb/s EDR packets use $\pi/4$ -DQPSK modulation and 3 Mb/s EDR packets use 8-DPSK modulation. The EUT works in the X-axis. The following operating modes were applied for the related test items. All test modes were tested, only the result of the worst case was recorded in the report.

Worst-case mode and channel used for 150kHz-30 MHz power line conducted emissions was the mode and channel with the highest output power, that was determined to be TX(1Mbps).

Worst-case mode and channel used for 9kHz-1000 MHz radiated emissions was the mode and channel with the highest output power, that was determined to be TX(1Mbps-Low Channel).

2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10-2013, FCC CFR PART 15C 15.207, 15.209, 15.247 and DA 00-705.

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209, 15.247 under the FCC Rules Part 15 Subpart C.

2.3 General Test Procedures

2.3.1 Conducted Emissions

The EUT is directly placed on the ground. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

2.3.2 Radiated Emissions

The EUT is placed on a turntable, which is directly placed on the ground. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013

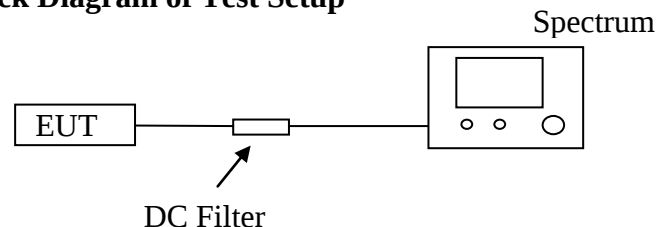

6.1.1 Block Diagram of Test Setup



6.1.2 Limit

According to § 15.247(b)(1), For frequency hopping systems operating in the 2400–2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725–5850 MHz band: 1 watt. For all other frequency hopping systems in the 2400–2483.5 MHz band: 0.125 watts.

6.1.3 Test Procedure

Use the following spectrum analyzer settings:

Span = approximately 5 times the 20 dB bandwidth, centered on a hopping channel

RBW > the 20 dB bandwidth of the emission being measured

VBW ≥ RBW

Sweep = auto

Detector function = peak

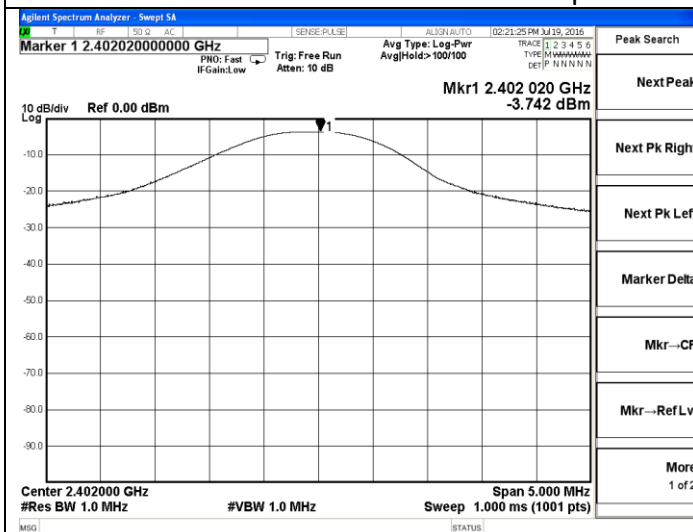

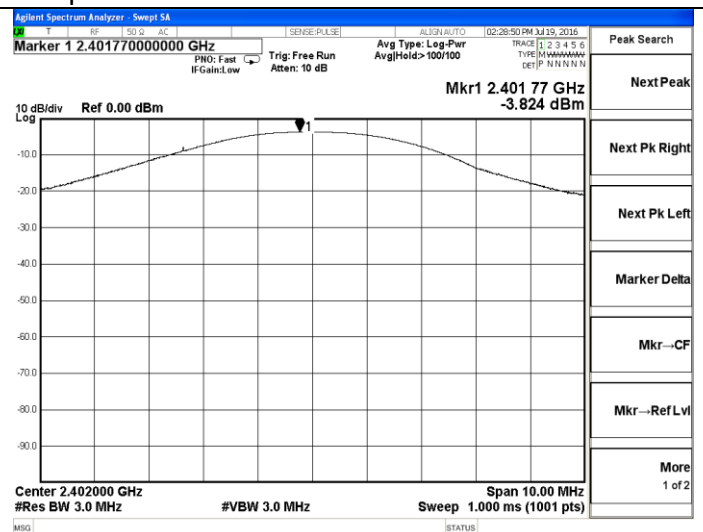

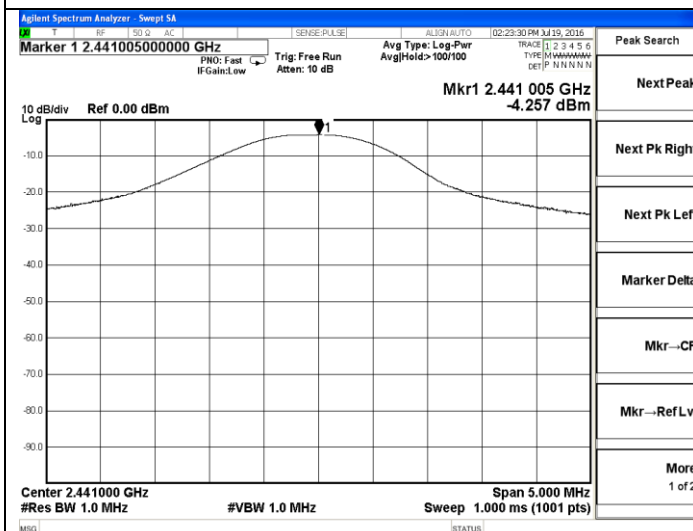
Test plot of Peak Output Power



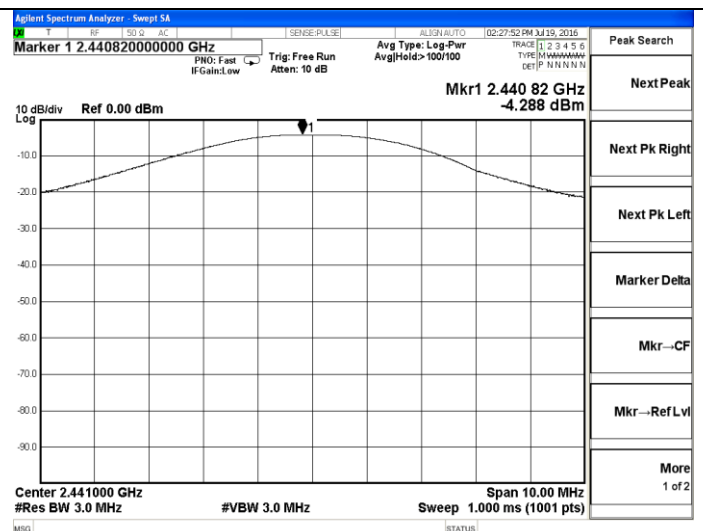
DH1-Low channel



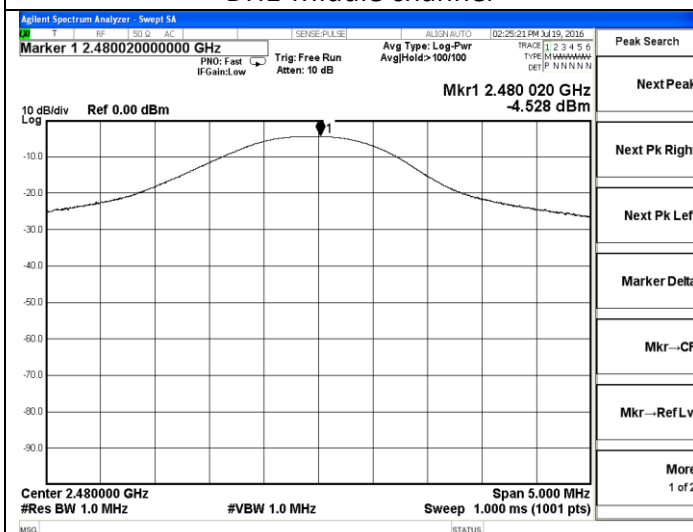
2DH1-Low channel



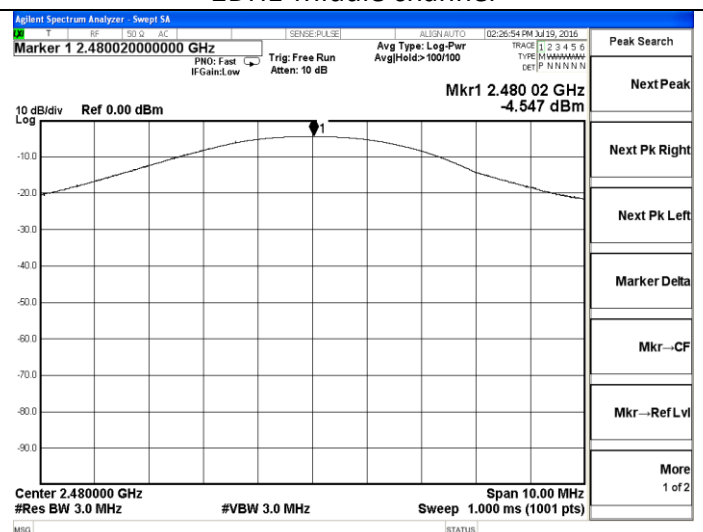

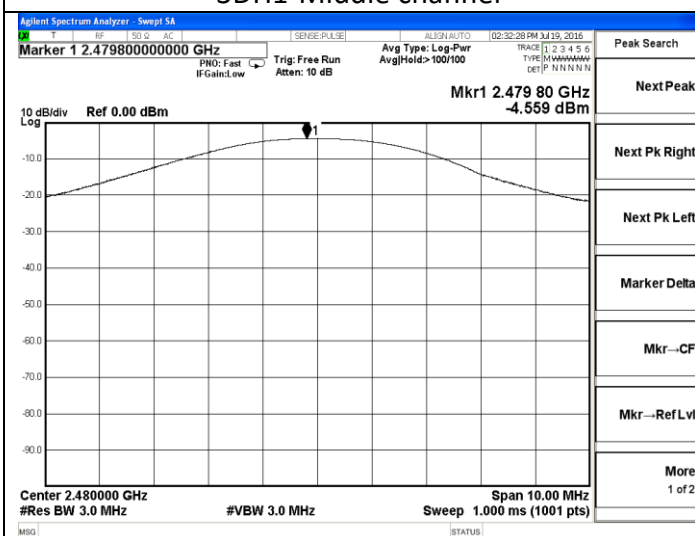
Test plot of Peak Output Power

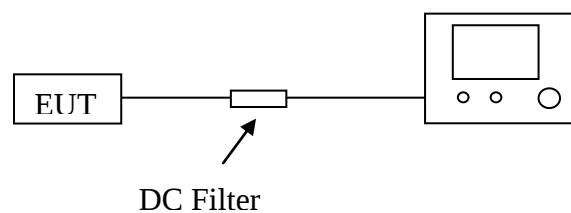

6.2 Frequency Separation And 20 dB Bandwidth

6.2.1 Limit

According to §15.247(c) or A8.1(a), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a).

6.2.2 Block Diagram of Test Setup



6.2.3 Test Procedure

Frequency separation test procedure:

- A. Place the EUT on the table and set it in transmitting mode.
- B. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- C. Set center frequency of Spectrum Analyzer = middle of hopping channel.
- D. Set the Spectrum Analyzer as RBW = 100kHz, VBW = 300kHz, Span = wide enough to capture the peaks of two adjacent channels, Sweep = auto.
- E. Max hold, mark 2 peaks of hopping channel and record the 2 peaks frequency.

20dB bandwidth test procedure:

- A. Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel.
- B. $RBW \geq 1\%$ of the 20 dB bandwidth, $VBW \geq RBW$.
- C. Detector function = peak.
- D. Trace = max hold.

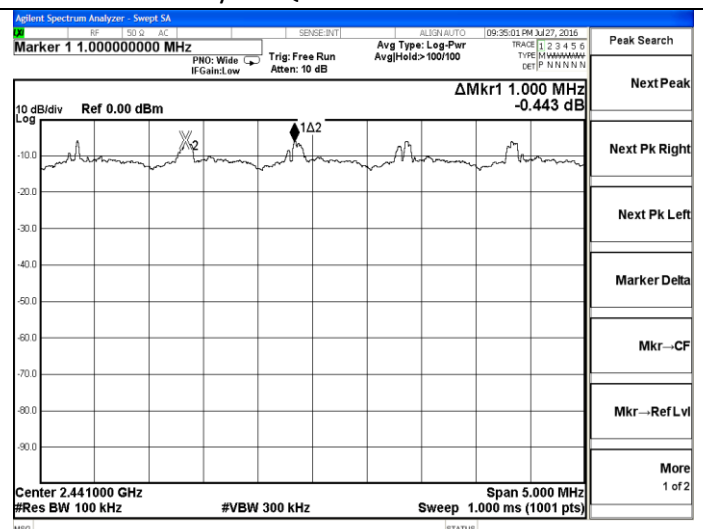
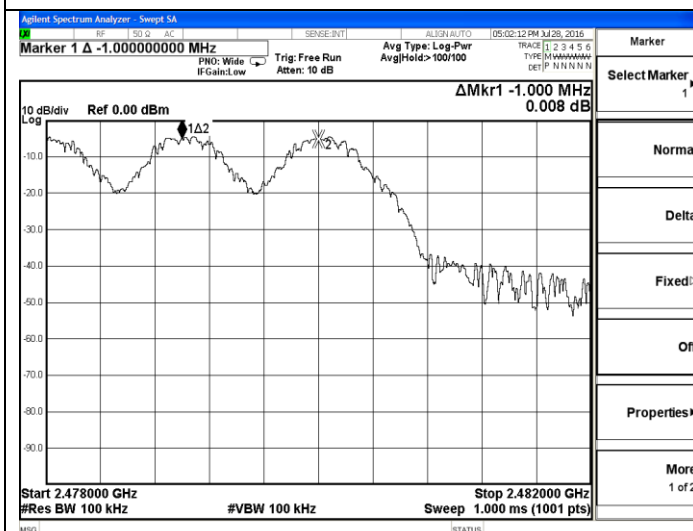
Test Plot of Frequency Separation



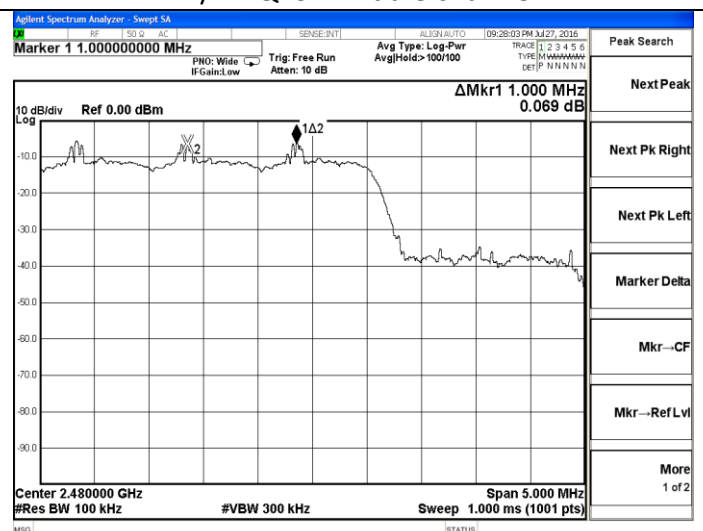

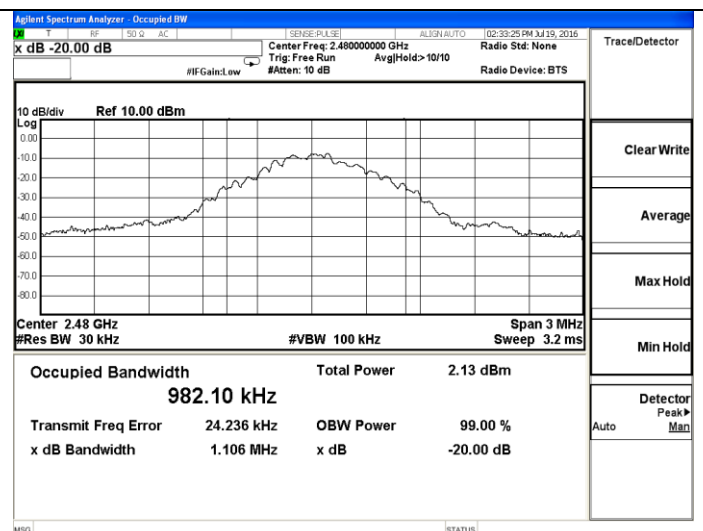
Test Plot of 20dB Bandwidth

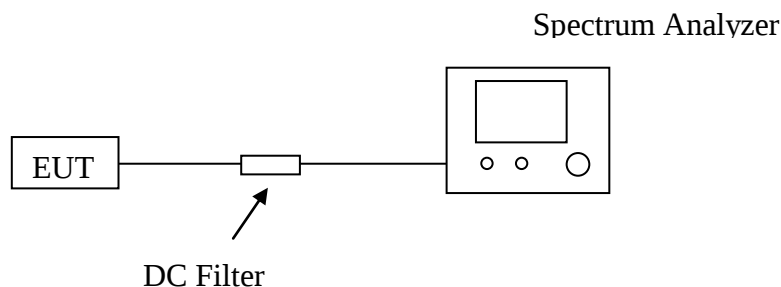

6.3.1 Limit

According to §15.247(a)(1)(ii) or A8.1 (d), Frequency hopping systems operating in the band 2400-2483.5 MHz shall use at least 15 hopping channels.

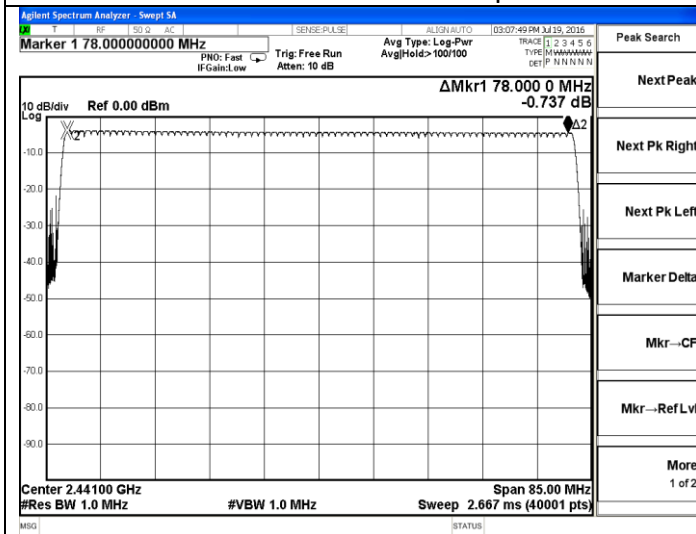

Test plot of Number Of Hopping Frequency

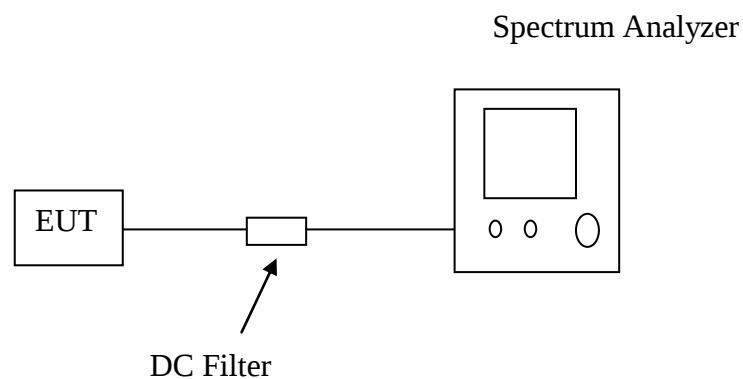


6.4 Time Of Occupancy (Dwell Time)

6.4.1 Limit

According to §15.247(a)(1)(iii) or A8.1 (d), Frequency hopping systems operating in the 2400MHz- 2483.5 MHz bands. The average time of occupancy on any channels shall not greater than 0.4 s within a period 0.4 s multiplied by the number of hopping channels employed.

6.4.2 Block Diagram of Test Setup



6.4.3 Test Procedure

- A. Place the EUT on the table and set it in transmitting mode.
- B. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- C. Set center frequency of Spectrum Analyzer = operating frequency.
- D. Set the Spectrum Analyzer as RBW, VBW=1MHz, Span = 0Hz, Sweep = auto.
- E. Repeat above procedures until all frequency measured were complete.

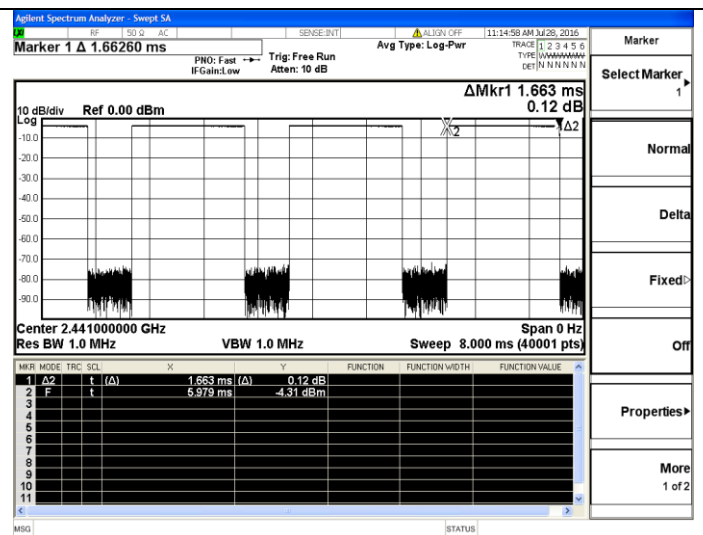
Test plot of Dwell time



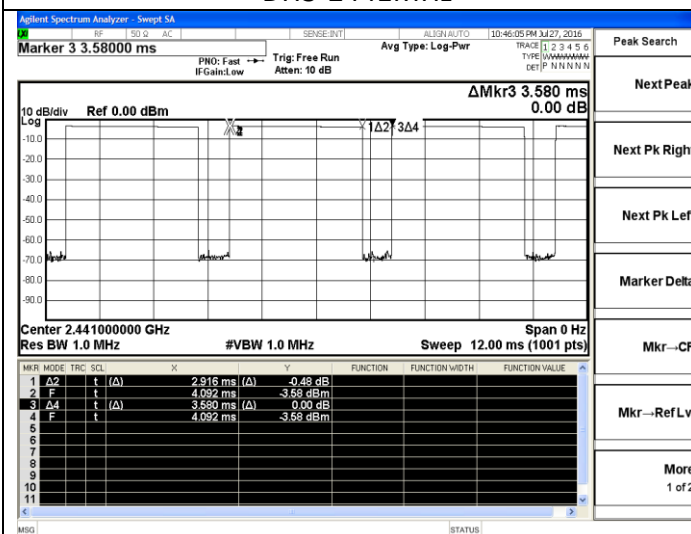

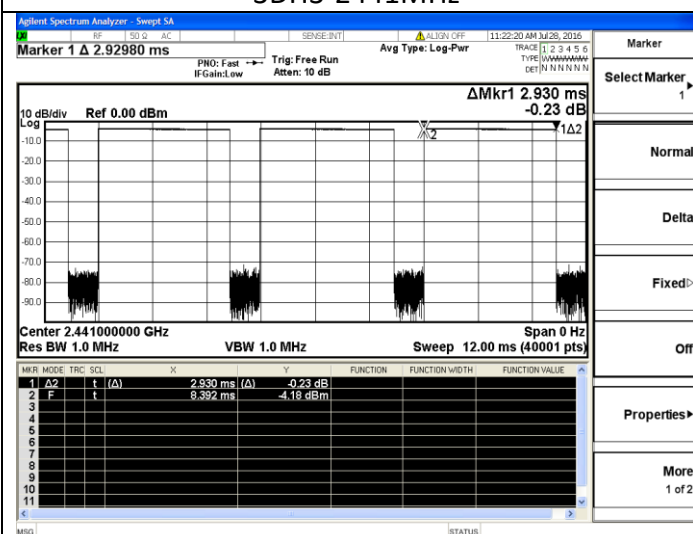
Test plot of Dwell time

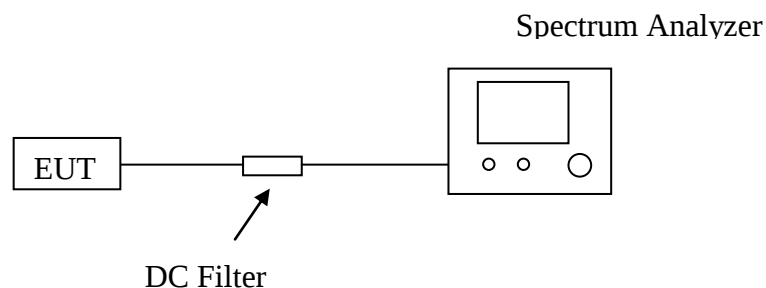

6.5 Conducted Spurious Emissions and Band Edges Test

6.5.1 Limit

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).

6.5.3 Test Procedure

Conducted RF measurements of the transmitter output were made to confirm that the EUT antenna port conducted emissions meet the specified limit and to identify any spurious signals that require further investigation or measurements on the radiated emissions site.

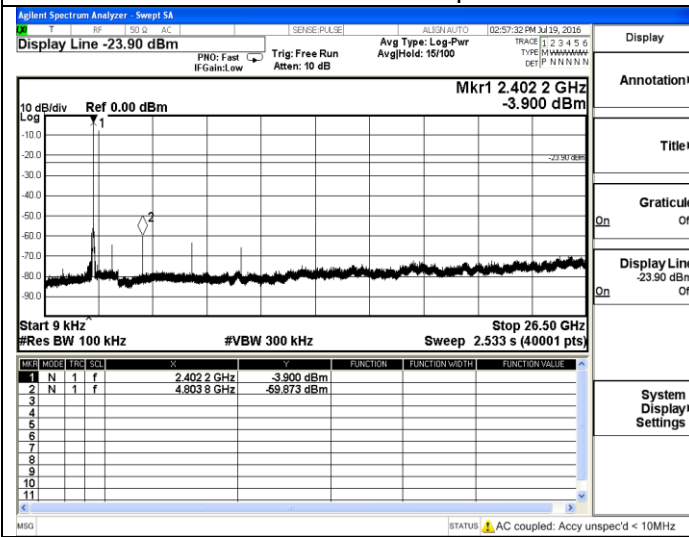

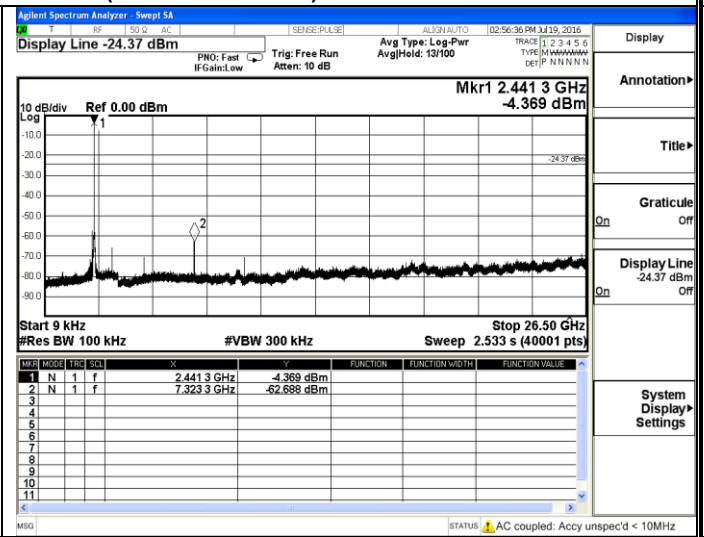

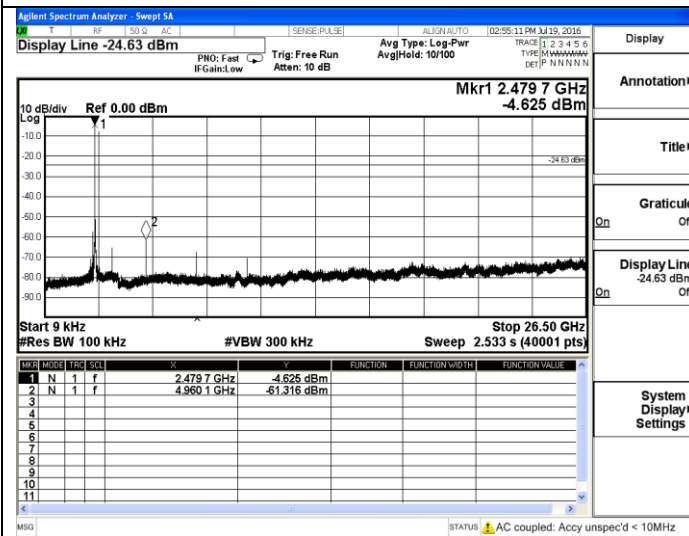
Test plot of Conducted Emission(9kHz~ 26.5GHz)

DH1-Middle channel

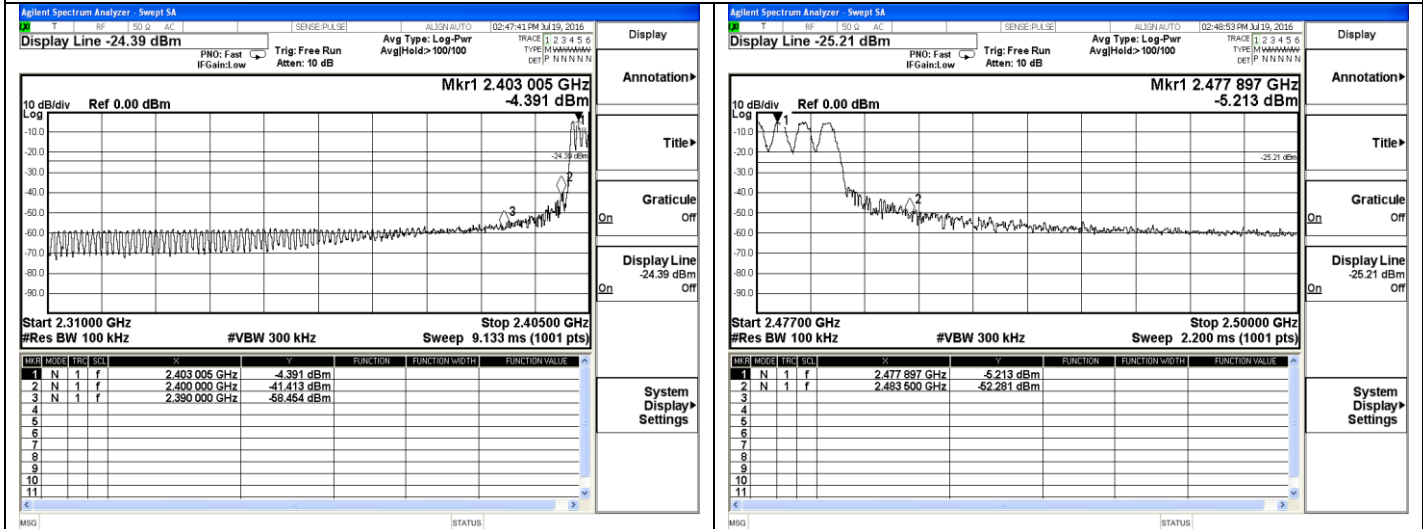


DH1-High channel

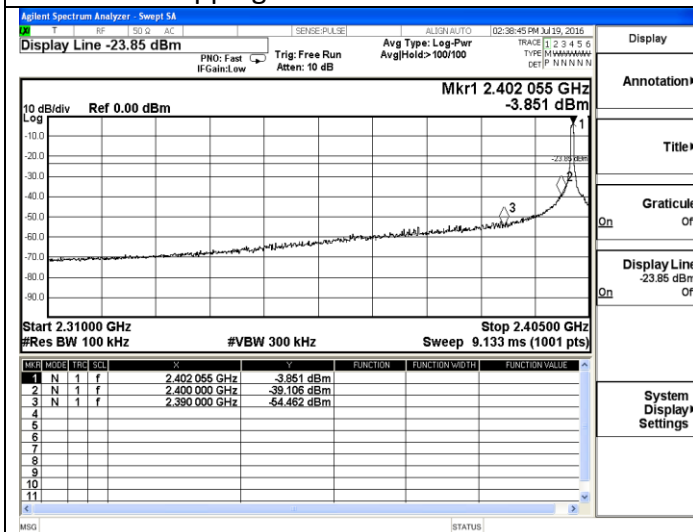

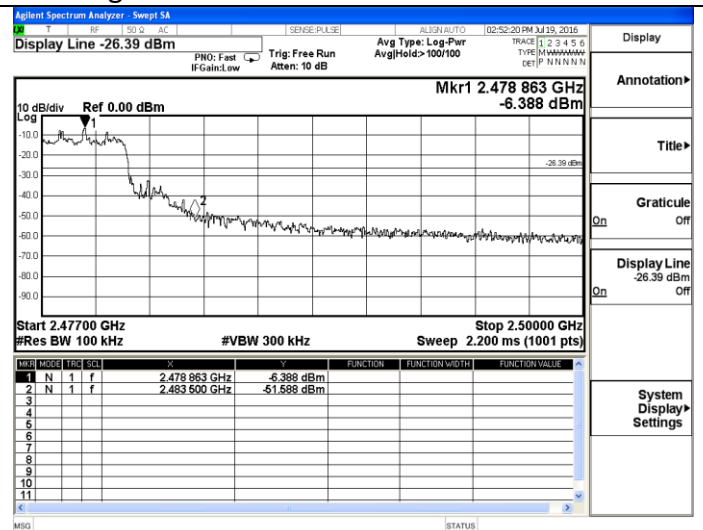
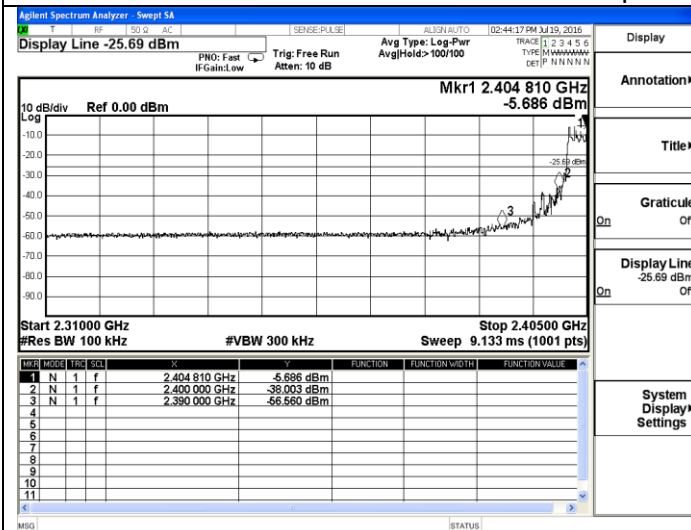


Hopping Off-GFSK-Low channel

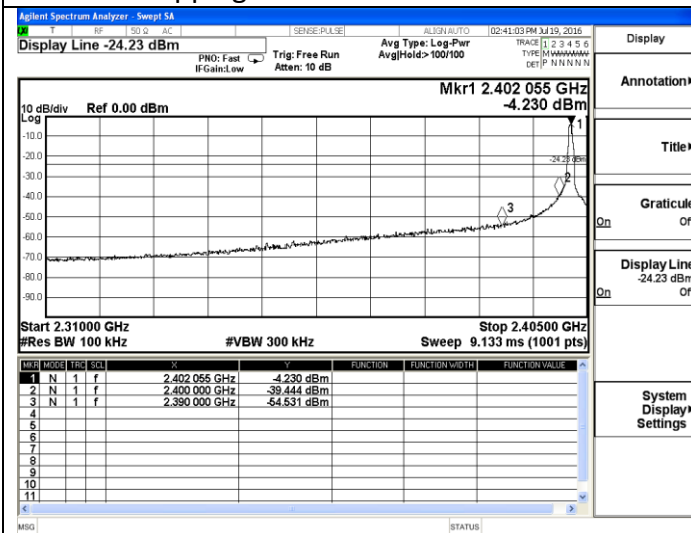


Hopping Off-GFSK-Middle channel

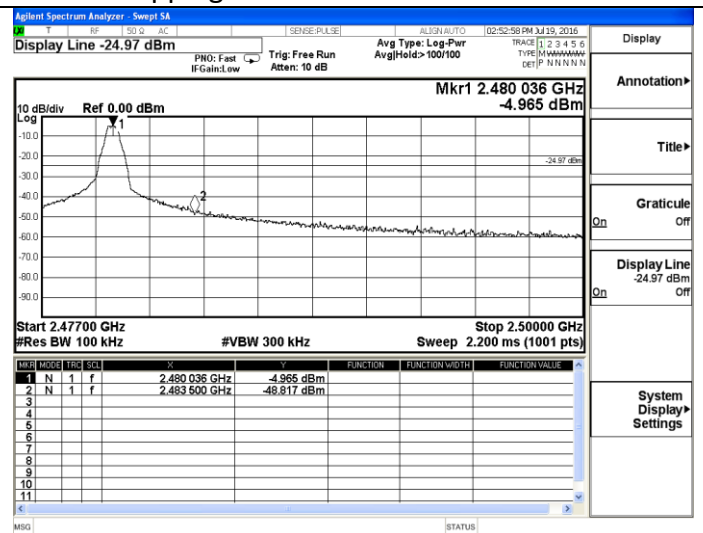

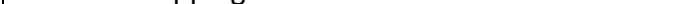
Hopping On-8-DPSK -Low channel



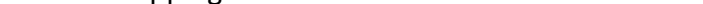
Hopping On-8-DPSK -Middle channel

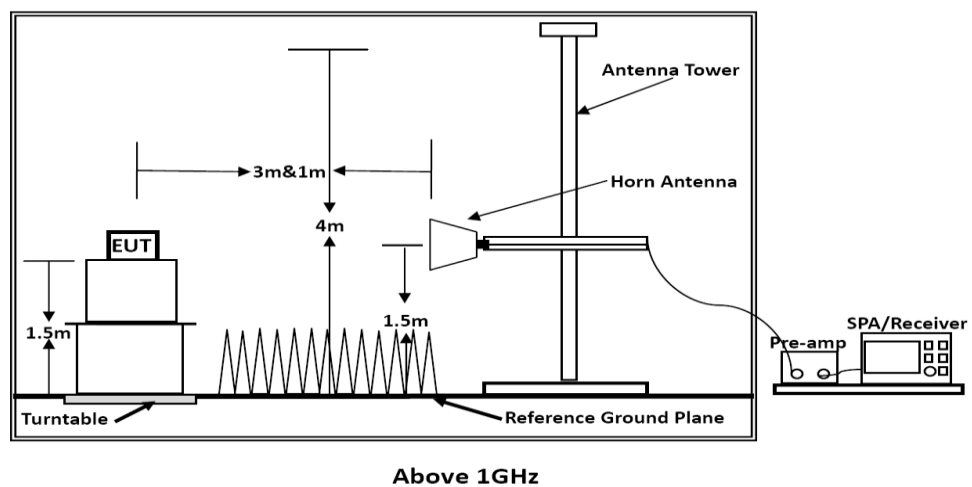
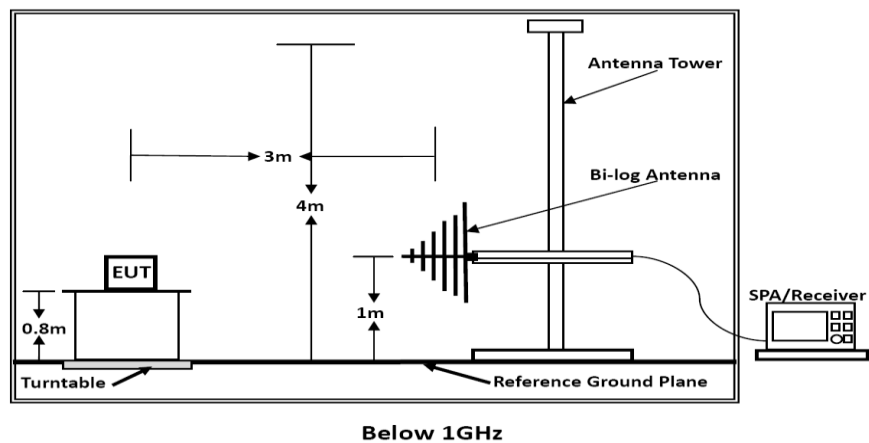
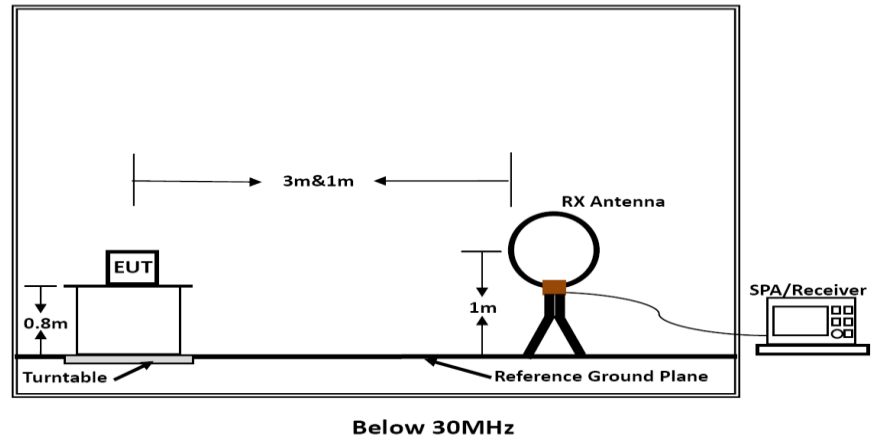


Hopping Off-8-DPSK -Middle channel

7.4 Test Procedures

1) Sequence of testing 9 kHz to 30 MHz

Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- If the EUT is a floor standing device, it is placed on the ground.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

Premeasurement:

- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- The antenna height is 0.8 meter.
- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

Final measurement:

- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0 ° to 360 °) and by rotating the elevation axes (0 ° to 360 °).
- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.
- The final levels, frequency, measuring time, bandwidth, turntable position, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.

2) Sequence of testing 30 MHz to 1 GHz

Setup:

- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

Premeasurement:

- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- The antenna is polarized vertical and horizontal.
- The antenna height changes from 1 to 3 meter.
- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

Final measurement:

- The final measurement will be performed with minimum the six highest peaks.
- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ($\pm 45^\circ$) and antenna movement between 1 and 4 meter.
- The final measurement will be done with QP detector with an EMI receiver.
- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

3) Sequence of testing 1 GHz to 18 GHz

Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.
- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

Premeasurement:

- The turntable rotates from 0 °to 315 °using 45 °steps.
- The antenna is polarized vertical and horizontal.
- The antenna height scan range is 1 meter to 2.5 meter.
- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

Final measurement:

- The final measurement will be performed with minimum the six highest peaks.
- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ($\pm 45^\circ$) and antenna movement between 1 and 4 meter. This procedure is repeated for both antenna polarizations.
- The final measurement will be done in the position (turntable, EUT-table and antenna polarization) causing the highest emissions with Peak and Average detector.
- The final levels, frequency, measuring time, bandwidth, turntable position, EUT-table position, antenna polarization, correction factor, margin to the limit and limit will be recorded. 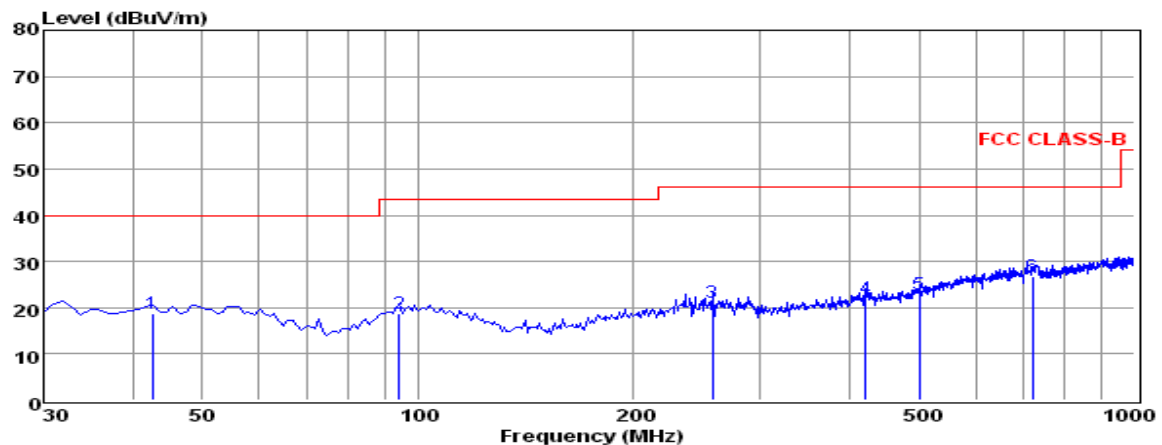

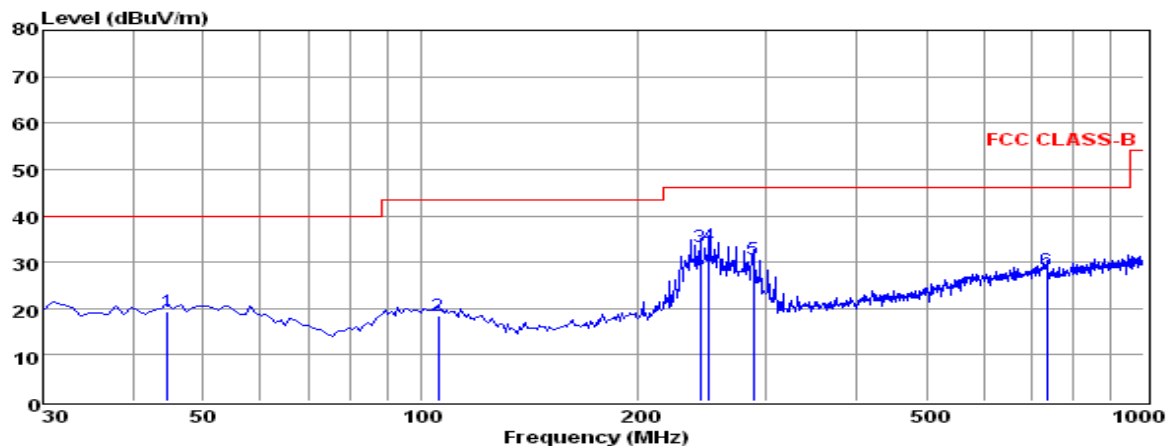

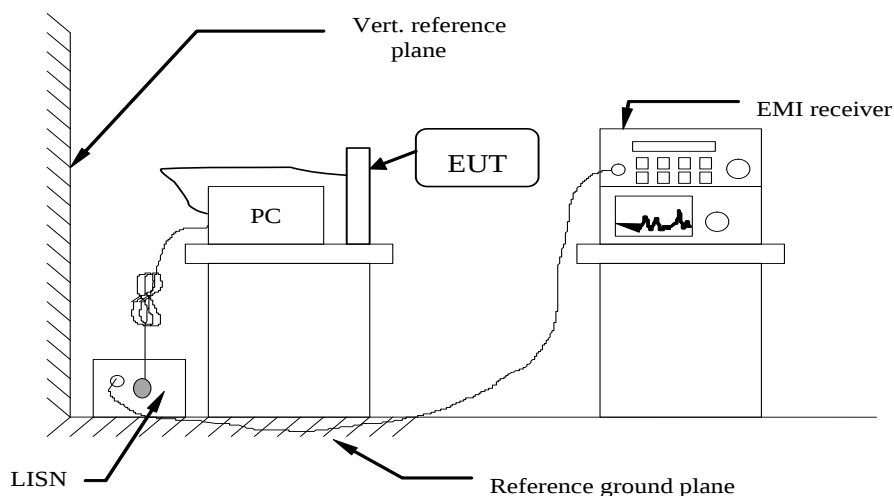
7.7. Power line conducted emissions

7.7.1 Standard Applicable

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 8. ANTENNA REQUIREMENT

8.1 Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

8.2 Antenna Connected Construction

8.2.1. Standard Applicable

According to § 15.203 & RSS-Gen, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

8.2.2. Antenna Connector Construction

The directional gains of antenna used for transmitting is 0dBi, and the antenna is an integral antenna connect to PCB board and no consideration of replacement. Please see EUT photo for details.
