
insert the Aux in cable into computer recording cable (interface 3.5MM end)



4. Connecting with Car Audio instructions

1.Connecting Diagram



1 : open the unit with long pushing POWER Knob.

Remark: the Power Indicator and EM Indicator will be worked on at same time. 2: working your phone in Blueooth mode, pairing "TUXUN-K9",

and connecting directly.

Remark: the unit and smartphone must keep into Bluetooth Free mode. if the unit is connected with other device, or the Smart phone is connected another player, must update into Bluetooth Free Mode. and then, connect as instructions

3 : Adjust your Car Audio player into FM Mode, and fixed Freq.into 107.6Hz. Open the player with short Pushing Power knob into Emitter-On Mode. Remark: please adjustvolume of Car Audio into suitable position to avoid Noise.

 $4. please \ \, running the \, relative \, Karaoke \, software \, APP (eg. Yo Kee) \, from \, your \, smart$ phone, and start to sing songs with Karaoke mode. Remark: the bluetooth pairing mode will be stop automatically when the phone is starting recording mode.





6.recharging operation

Computer recording song connection method

lack of the computer

1.Recharging method is same mobile phone recharging: the battery power indicator is red in recharging period. light automatically turns off after the unit is charged full.



usingDC5V adaptor to recharge

the first recharging period must be over 8 hours.

for the unit normal using, only need recharge 30 mins to 2 hour time.
