

安裝前確認事項

- 1. 確定PTU與其他的PTU最少間距305mm
- 2. 確定桌面為非金屬材質
- 3. 確定PTU安裝的位置,電源線的長度足夠

安装方式

★ 將PTU平放於桌面上方

安裝後確認事項

- 1. 接上電源線以打開PTU電源; 拔掉電源線以關閉PTU電源
- 2. 確認LED燈號

Before installation

- 1. Make sure PTU is away from another PTU at least 305mm
- 2. Make sure the table is non-metal material
- 3. Make sure PTU location and power cord length is enough

netall Procedure

★ Put PTU on the table.

After installation

- 1. Power on by coonecting adapter; power off by removing adapter
- 2. Confirm LED signal
- Flickering Connecting
- Gree light Charging mode
- Red light Protection mode / Error
- 3. Please keep metal thing 54mm hotizontally and 194mm vertically away from PTU
