## DISPOSAL AND RECYCLING INFORMATION

- Disposal of the packaging and your bracelet should be done in accordance with local regulations.


## **SAFETY INFORMATION:**

- Do not expose your ALTRUIS to liquid or moisture while charging. Exposure to moisture during charging could result in electric shock.
- Only charge your ALTRUIS with the supplied charging cable, connected to a USB compliant port.
- ALTRUIS and charger contain strong magnets, which can cause electronic equipment to malfunction. If you use an implanted medical device, please consult your physician and the manufacturer of your medical device before wearing or handling your bracelet and charger.
- ALTRUIS is rain, splash and sweat proof but submerging it in water should be avoided. Prolonged exposure to salt water or chemically treated water will reduce water resistance.
- ALTRUIS and its accessories contain small parts, which can be a choking hazard. If any part is swallowed, immediately seek medical help.
- Do not expose ALTRUIS to excessive heat or fire.
- Do not expose ALTRUIS to microwave.
- If you experience any skin irritations, remove band immediately and seek advice from your physician.

## SETUP INSTRUCTIONS

1.

Insert the charging cable into a powered USB port and align the pins on the charger with the back of your ALTRUIS. The first charge will also activate your ALTRUIS. A short vibration will confirm this.




