

### BATTERY NOTICE:

1. Insert 4 pieces of 1.5 volt "AA" batteries in the battery compartment of the vehicle, and insert 2 pieces of 1.5 volt "AA" batteries in the battery compartment of the controller. Batteries are to be inserted with correct polarity as shown in the diagrams. (Battery not included for both the vehicle and the controller)
2. Playing time: 60 minutes per charge.
3. Playing speed: 12 km/H.
4. Remove the batteries from the controller when it will not to be used for a long time to prevent leakage of harmful substances.

### OPERATION NOTICE:

1. Adjust the trimming when the vehicle is found to incline left or right while running, to keep it running straight.
2. Point the transmitter antenna up towards the vehicle. If the vehicle gets too far away, it won't work properly.
3. Radio interference will make the vehicle out of order. Interference can be caused by other R/C vehicles running on the same frequency, electrical wires, large buildings, or CB radio. We recommend that you avoid those objects.
4. Don't drive the vehicle in sand, water or snow.
5. Don't put the vehicle near heat or under the sunlight. Always turn switches OFF and remove all batteries for storage.
6. Only be sure that battery compartment is fixed can children play.
7. The car is imitated by the real product, so please keep young children away from reaching out to it. It should be played under the adult's upervision.
8. As it is the high speed car, please do not hit people and animal, in case of any hurt or danger.
9. Keep the package for its important information.

### CAUTIONS:

1. Only rechargeable batteries can be recharged.
2. Batteries are only to be charge under adult's supervision.
3. Different types of batteries or new and used batteries are not to be mixed.
4. Batteries should be inserted with the correct polarity.
5. Used batteries should be take out from products.
6. The supply terminals are not to be short-circuited.
7. Examine the transformer or battery charger and any damage to their cord, plug, enclosure and other spare parts regularly. Please stop using, and replace other suitable charger when anything broken down.
8. To ensure safety and proper operation, battery replacement must always be done by adults.

### PLAYING OPERATION:

1. Make sure the electricity of both the vehicle and the controller is sufficient.
2. Turn the power switch on the controller to ON, then the power light of the controller will flash, which indicates that the signal is connecting. Turn the power switch on the vehicle to ON, then the power light on the controller black out, which indicates that signal connection is done and the vehicle is ready to play.
3. When the electricity is insufficient, all functions of vehicle would slow down. Please replace batteries or charge in time.

**Controller of 6-FUNCTION with sound**  
Press "Engine Start" button to start the vehicle, push the "forward/backward" lever to pull the car running forward and backward, push the "left/right" lever to make the car turned left and right. Press the "Sound Switching" button to switch 4 kinds of sound and mute mode. Press "Horn Sound" button for the horn sound under the sound mode, and it is invalid under the mute mode.

**Controller of 4-FUNCTION**  
Make the vehicle moved forward and backward by pulling the "forward/backward" lever on the controller and make the vehicle turned left and right by pulling the "left/right" lever.
