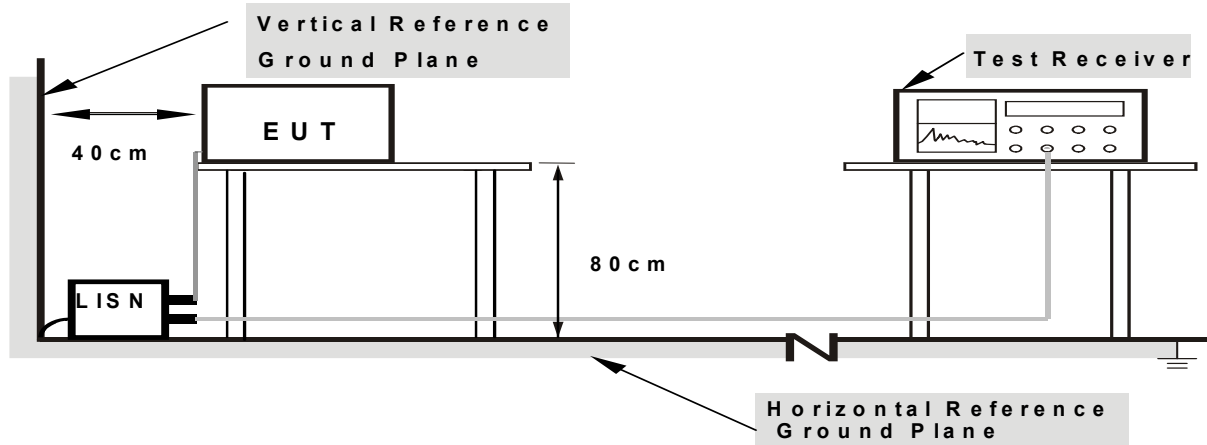
##### 3.1.2 TEST PROCEDURE

- a. The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN at least 80 cm from nearest part of EUT chassis.
- e. For the actual test configuration, please refer to the related Item –EUT Test Photos.

**3.2.2 TEST PROCEDURE**

Below 1GHz test procedure as below:

- The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.
- The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters (for the test frequency of below 30MHz, the antenna was tuned to heights 1 meter) and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

Above 1GHz test procedure as below:

g. Different between above is the test site, change from Semi- Anechoic Chamber to fully Anechoic Chamber and change form table 0.8 metre to 1.5 metre( Above 18GHz the distance is 1 meter and table is 1.5 metre).

h. Test the EUT in the lowest channel ,the middle channel ,the Highest channel

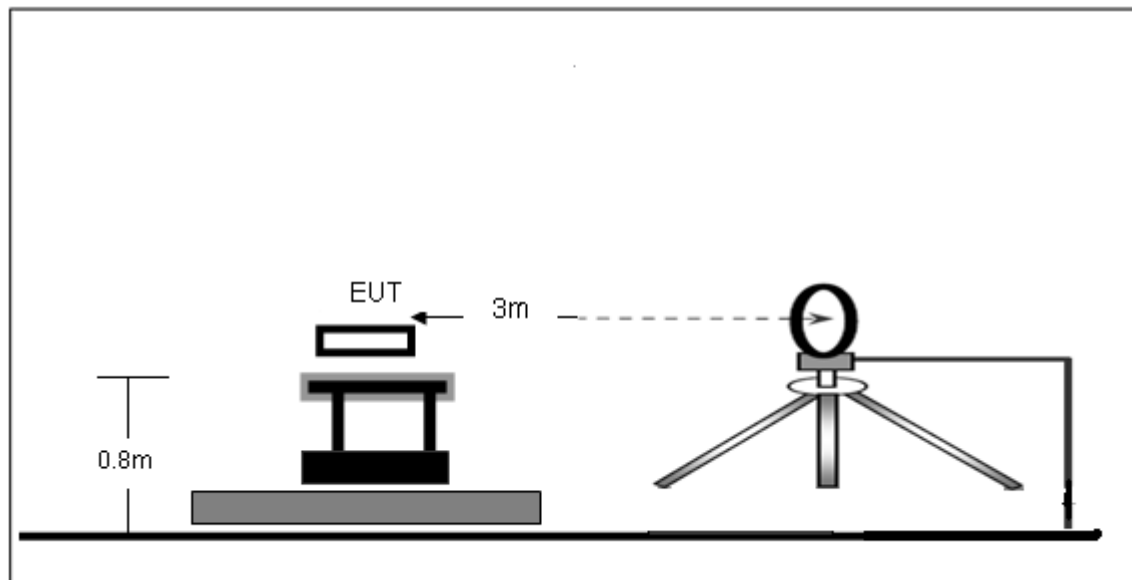

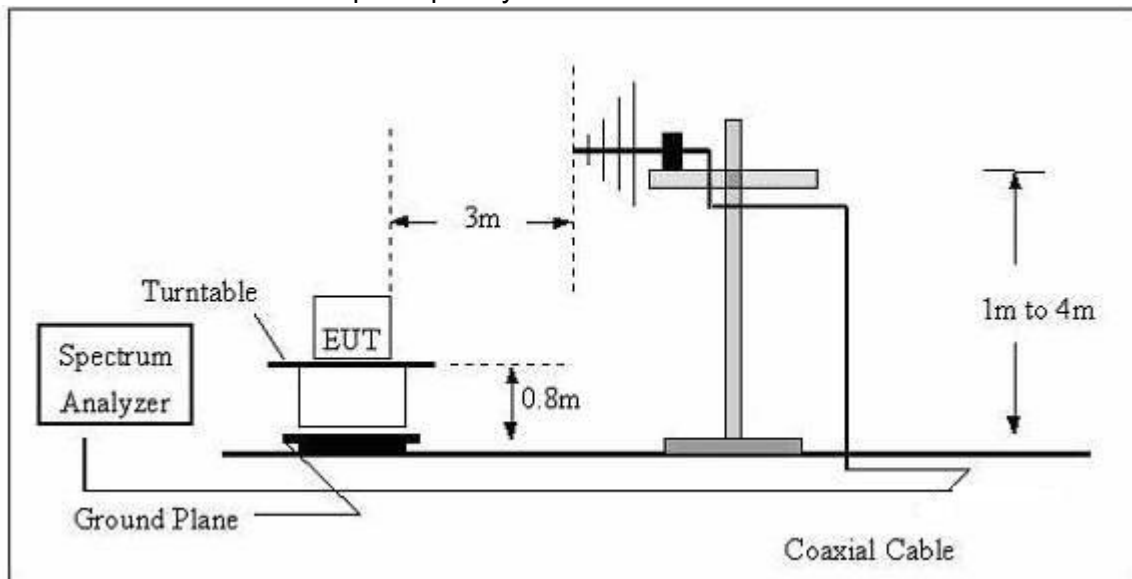

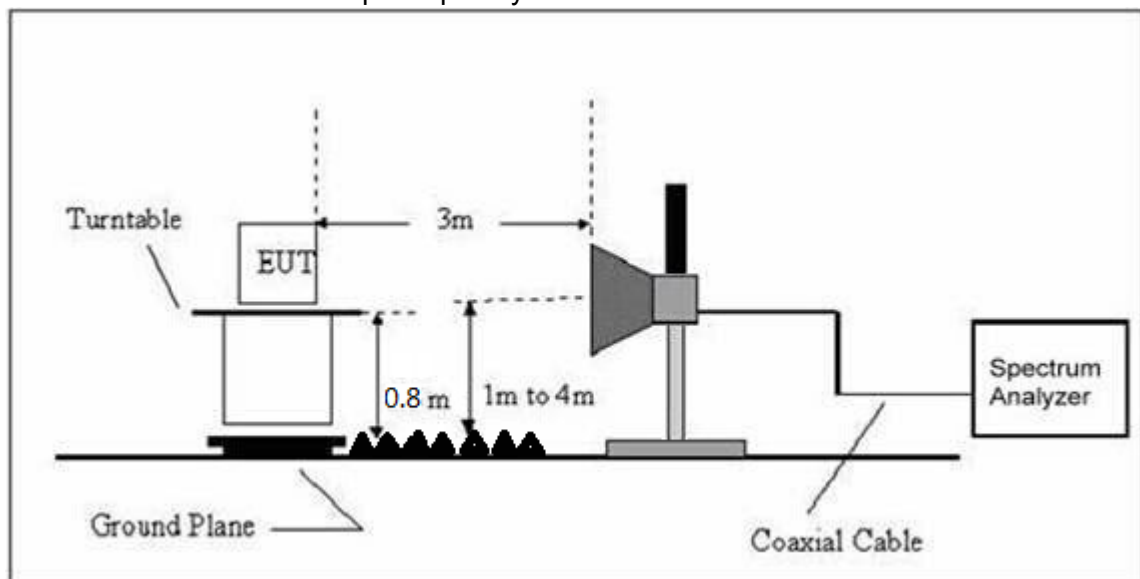
(A) Radiated Emission Test-Up Frequency Below 30MHz

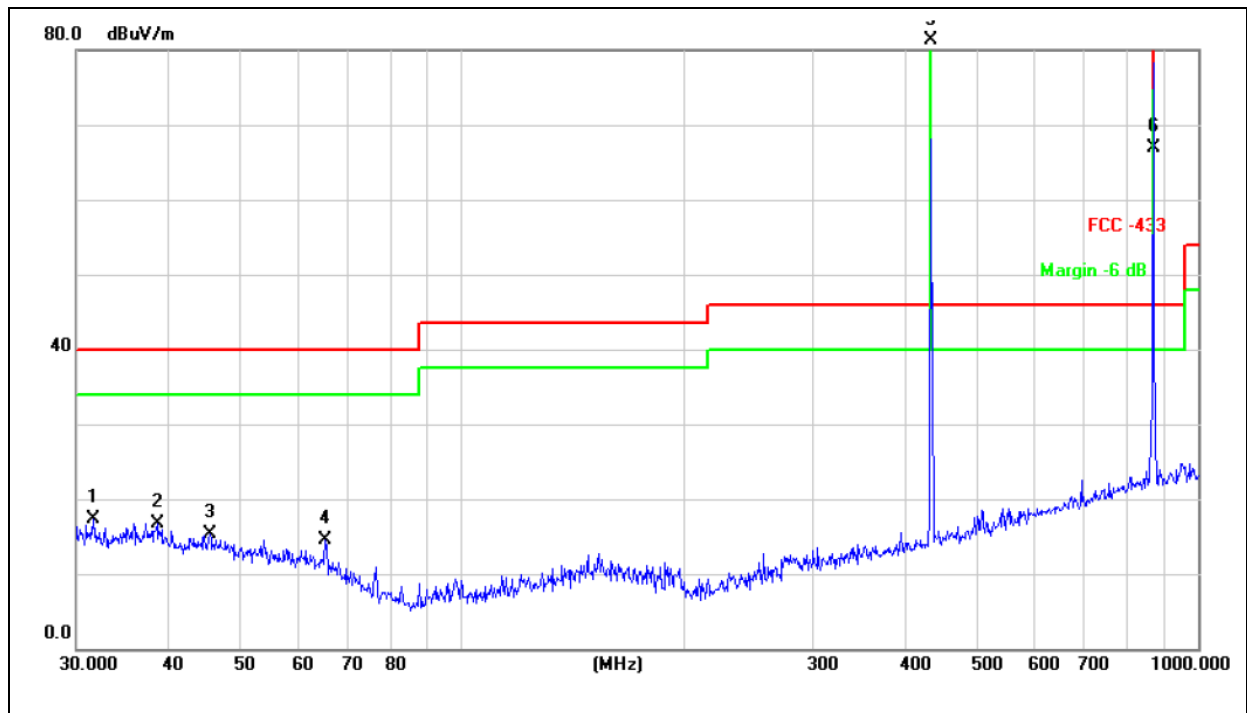

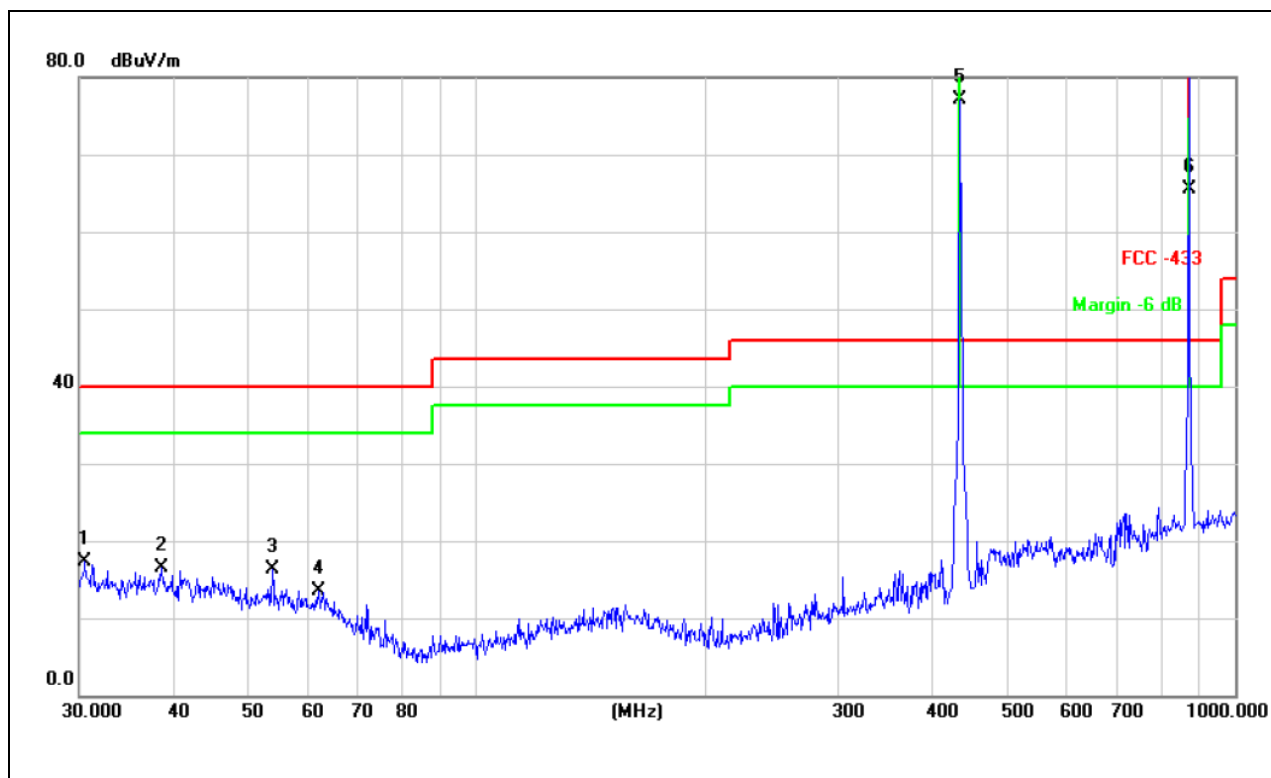

## 4. BANDWIDTH TEST

### 4.1 APPLIED PROCEDURES / LIMIT

According to FCC 15.231(c) requirement:

The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating between 70 MHz to 900 MHz. Those devices operating above 900 MHz, the emission spurious shall be no wider than 0.5% of the center frequency. Bandwidth is determined at the points 20 dB down from the modulated carrier.

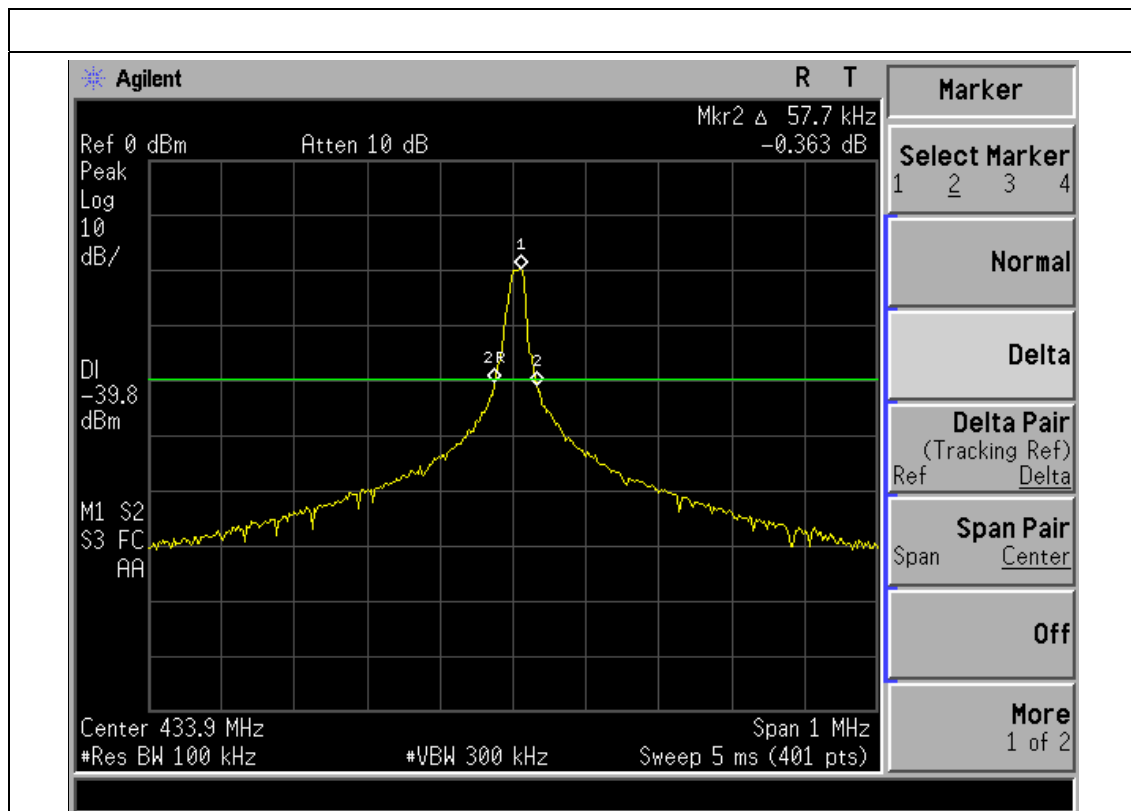

## 5. CALCULATION OF AVERAGE FACTOR

The output field strengths of specification in accordance with the FCC rules specify measurements with an average detector. During the test, a spectrum analyzer incorporating a peak detector was used. Therefore, a reduction factor can be applied to the resultant peak signal level and compared to the limit for measurement instrumentation incorporating an average detector.

The duty cycle is measured in 100 ms or the repetition cycle period, whichever is a shorter time frame. The duty cycle is measured by placing the spectrum analyzer to set zero span at 100kHz resolution bandwidth.

Averaging factor in dB =  $20\log(\text{duty cycle})$

The duration of one cycle = 100.00ms

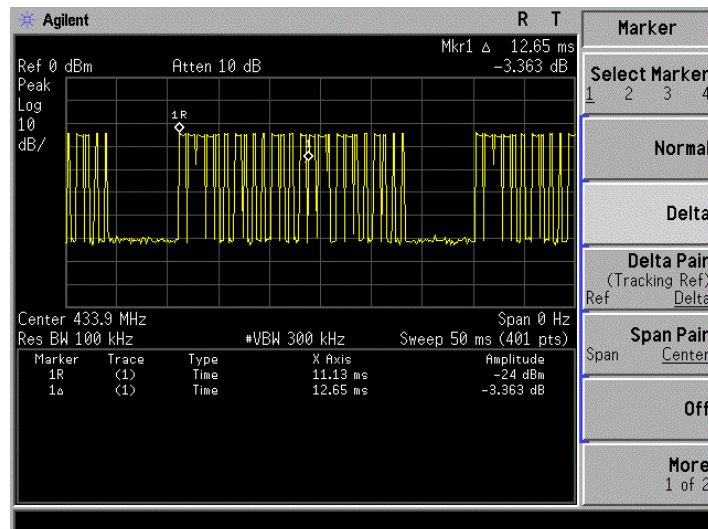
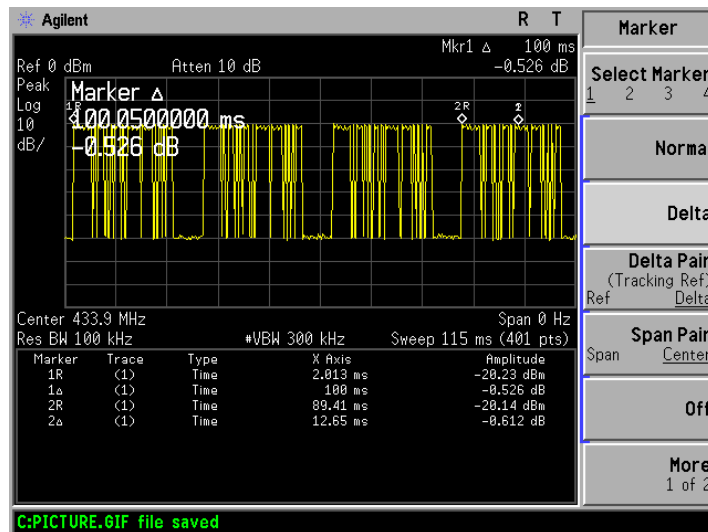
The duty cycle is simply the on-time divided the duration of one cycle

Duty Cycle =  $(0.727\text{ms} \times 43 + 0.273\text{ms} \times 46) / 100 = 43.819\text{ms} / 100\text{ms} = 0.438$

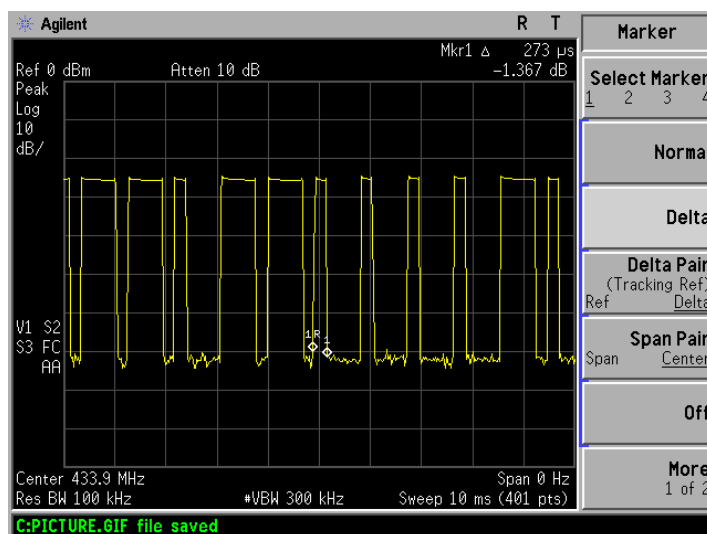
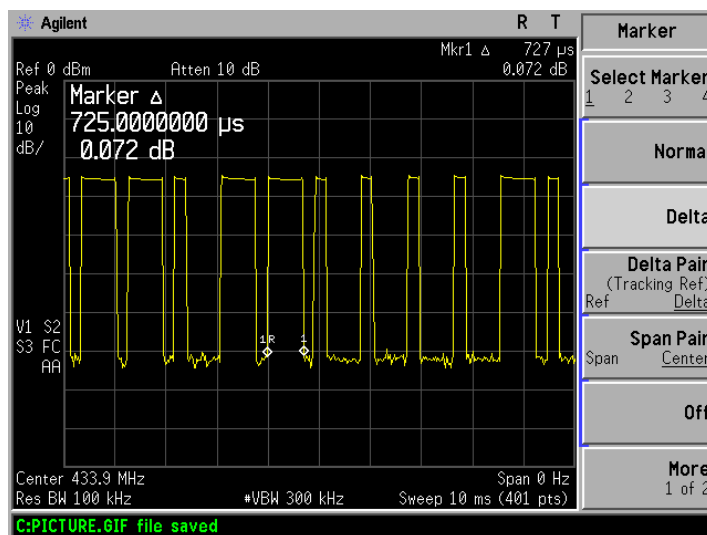
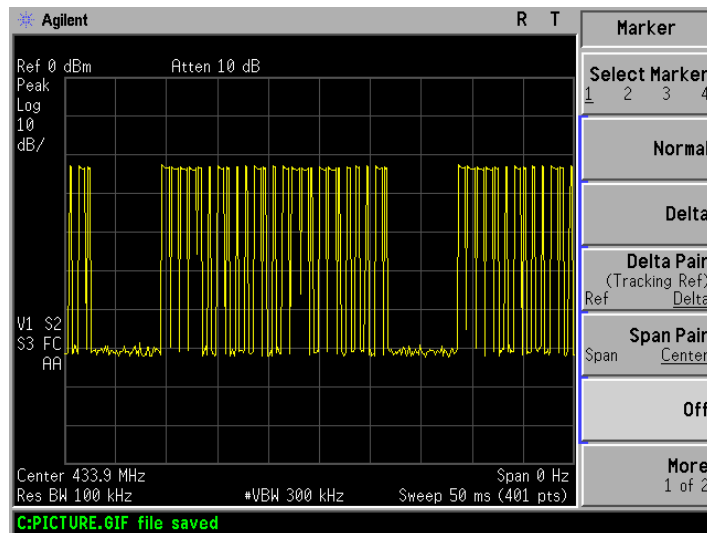
Therefore, the averaging factor is found by  $20\log 0.438 = -7.17\text{dB}$

## 6. DWELL TIME

### APPLICABLE STANDARD

According to FCC 15.231(a) requirement:

A manually operated transmitter shall employ a switch that will automatically deactivate the transmitter within not more than 5 seconds of being released.

Result: The EUT does not have a automatically activated transmitter. Periodic transmissions at regular predetermined intervals are not permitted. However, polling or supervision transmissions, including data, to determine system integrity of transmitters used in security or safety applications are allowed if the total duration of transmissions does not exceed more than two seconds per hour for each transmitter. There is no limit on the number of individual transmissions, provided the total transmission time does not exceed two seconds per hour.
