Dear user,

Thank you for choosing the series product of Aihua Electronics Factory and we are confident that the product will provide you with lots of fun in your life. To further know the product, please read the instruction carefully before using it and keep it for reference.

I. Features

1. Playing the music files with MP3 format in TF card directly
2. Multiple Treble/Bass tone control that can release the perfect sound.
3. Versions 4.1 Intelligent Bluetooth chip set with low power consumption, quick and stable connection
4. Built-in rechargeable dual 18650 lithium batteries with high capacity and current, as well as lasting life.
5. Memorizing the item played last time automatically, breakpoint continuous.

6. Supporting functions like wireless connection with mobile phones' general Bluetooth, telephone answering and calling back.

II. Illustration of button and jack (Real object be taken as final)

- ① [Telephone Answering] In Bluetooth mode, press the button into the function of answer phone call when incoming call. When playing MP3 music, press the button to select different tone performance (7 kinds of performance available)
- ② [Play/Pause]: Press the button to pause or to play.
- ③ [PREV/-]: Press to play previous music. Long press for turning down the volume.
- ④ [Next/+]: Press to play next music, Long press for turning up the volume.
- ⑤ [DC 5V]: Charging when connecting with USB interface of PC or using mobile phone charger adapter.
- ⑥ [BT/OFF/MP3:] BT - Bluetooth Mode

OFF - Power off

MP3 - Play the MP3 music from TF card

- ⑦ [TF Slot]: Insert TF card for MP3 music playing
- ⑧ [AUX]: Input external sound source



III. Operation of Music Playing

In MP3 mode, insert TF card and the system will prompt “card playing” while the item playing automatically; for more details of operation, please refer to the “Illustration of Button and Jack”.

IV. Operation of Bluetooth:

1. In Bluetooth mode, the system will prompt “Bluetooth Mode”.
2. Make sure that whether or not the Bluetooth (telephone and so on) that requires to be connected is turned on, search the device whose Bluetooth name is AH-018, and connect with the device. (The device will prompt “Connect Successfully” if it has been connected);

- please restart the product or telephone if it cannot be connected.
3. After connected with the Bluetooth of the product, the telephone can play the music; you can open the Music Player in your telephone and choose the music you like.
4. During music playing, you can press the button

[◀] [▶] [◀] in your Music Player or [PREV/-], [Next/+], [Play/Pause] of the product to choose the item you like.

5. Please try to keep the Bluetooth Speaker and the telephone in the same direction as much as possible to ensure the continuous and steady music signal.

6. The distance of barrier-free range of the Blue tooth is about 10 meters.

7. Hands free phone call. The telephone number will be prompted when incoming call, press the [Telephone Answering] to make hands free phone call, and press it again to hang up the call.

8. If you want to call back, press the [Telephone Answering] and it will call the first telephone number that in your call logs automatically.

V.AUX LINE IN

Insert sound source such as computer, telephone, MP3/MP4 player, iPhone, PSP, CD player into "AUX" jack through 3.5MM audio cable, the voice system prompt [Input Sound Source]; besides, you can adjust the volume

by [PREV/-] or [Next/+] , and press [Play/Pause] for muting after inserting 3.5MM audio cable , the system will turn off the music.

VI. Charging Method

1. Charge when connecting with USB interface of PC or using telephone chargers. The red indicating light will twinkle when charging and it requires 6 - 8 hours to be fully charged; the battery playtime is different every time according to the different volume.
2. When low power occurs and the sound is distorted, please charge in time; not use this product for a long period, please charge at least once a month so as to lengthen battery's life.

Kindly Reminder

1. For the service life of speaker and your physical and mental health, please do not listen to music at a high volume for a long time, in case that it will damage your hearing.
2. In public places, wear a pair of earphone to avoid interrupting others.
3. Faced with malfunctions, please immediately shut off the power switch and pull out the USB plug so that the loudspeaker and other components will not be broken.
4. What to do if there is no response when TF card is inserted in? Please make sure there is no quality problem of TF card and check whether audio files in it are on MP3/WMA format.
5. No Blue tooth match between cell phone and the Blue tooth speaker?
 - ① Check the battery voltage of the speaker to see if there is sufficient electricity, please charge it for a while when the electricity is insufficient and try Blue tooth match again.

- ② Delete all Bluetooth matching history records in cell phone .
- ③ Restart the cell phone and turn on its Bluetooth, then scan and search Bluetooth of this speaker.
- ④ Rematch the speaker with cell phone .

After-Sales Service

(1) Our company provides following after-sales services :

1. Consulting service: Before using the product, please read carefully the instruction of this product. You are welcome to call our national service hotline-4008. And you can also contact the local distributor, or log on the official website to consult solutions if there is any problem while using the product.
2. Replacement service: Within the replacement period (7 days from the day purchasing the product), customers who use the product correctly can contact local distributor to exchange or repair their products when any no-man-made damages is confirmed by inspection. Please keep the product, its accessories and packaging

complete (product with broken packaging can only be freely repaired).
