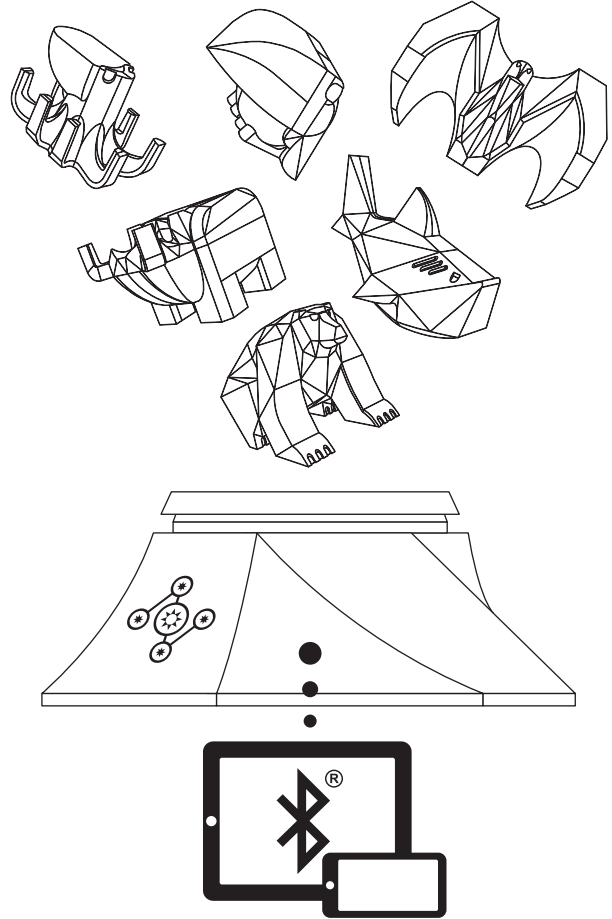

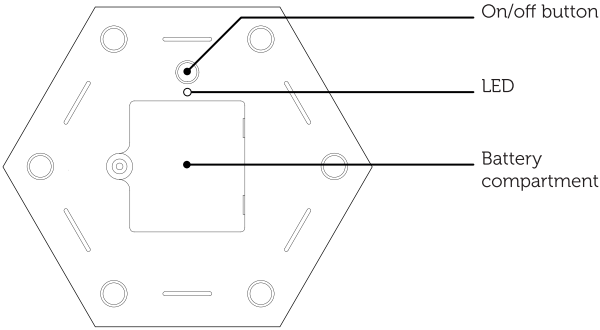

CARE

- In an environment with electrostatic discharge, the game may malfunction. In this case, please remove the batteries, wait for 5 minutes and then replace the batteries.
- Keep the Plinth and Artefacts dry and away from open flames or other heat sources.
- Do not modify or disassemble the Plinth or Artefacts unless explicitly instructed to do so in an official Beasts of Balance communication
- Never stand on the Plinth or Artefacts.
- The game is designed to be played either on a tabletop or on the floor. Dropping the Artefacts onto a hard surface from a height greater than 3 ft/ 1 m could result in damage and may void the warranty.

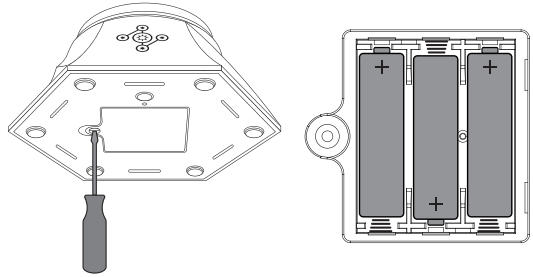

2. Insert batteries



The battery compartment is on the bottom of the Plinth. Remove the battery door and insert 3 x 1.5V AA/LR6 batteries (not included). Replace the battery door. A small screwdriver (not included) is required for battery installation.

3. Press button

Press the button on the base of the Plinth to switch it on. When the red LED light is illuminated through the base, the Plinth is on.

4. Connect the Plinth to the BoB app

- The Plinth uses Bluetooth to connect to the BoB app on your smartphone or tablet. To connect the Plinth to your device:
- a. Make sure your smart device has Bluetooth turned on and isn't already connected to another device
 - b. Launch the BoB app
 - c. The Plinth will connect automatically
 - d. In the unlikely event that the app cannot find the Plinth it will automatically take you through a series of steps to get your device connected

5. Start tutorial

Once connected to the Plinth the tutorial will automatically run the first time you launch the app, and is available from the main menu at any time.

6. Auto shut off

If not connected to the app the Plinth will turn off automatically after 3 minutes.

TROUBLESHOOTING

- Large metal items may interfere with the NFC reader when scanning an Artefact. The Plinth should be placed on a flat surface and kept a minimum of 6 in/ 15 cm away from metal objects or surfaces.
- The recommended play range is 3 feet/ 1 m or closer. Move the Plinth closer to your smart device if it is not being recognized.
- Check that the batteries in the Plinth still have some charge.
- Make sure Bluetooth is enabled on your smart device and that the Plinth is paired.
- Powerful radio emitters placed near the Plinth (other than the smart device connected to it) may adversely affect gameplay.

BATTERY INFO

- Install only new batteries of the same type in the Plinth
- Failure to insert batteries in the correct polarity, as indicated in the battery compartment, may shorten the life of the batteries, cause batteries to leak or damage the Plinth.
- Do not mix old and new batteries.
- Do not mix alkaline, standard (carbon-zinc), or rechargeable (nickel-cadmium or nickel metal hydride) batteries.
- Non-rechargeable batteries must not be recharged.
- Rechargeable batteries should only be charged under adult supervision.
- Rechargeable batteries should be removed from the Plinth before being charged.
- Exhausted batteries should be removed from the Plinth.
- Do not short circuit the supply terminals.
- Do not dispose of batteries in fire.
- Batteries should be recycled or disposed of as per state and/or local guidelines.

FIRMWARE UPDATES

- On occasion the app may prompt you to update the Plinth firmware. During this process it is vital that the user follows the instructions on the app in order to avoid damaging the Plinth.
- Please do not remove the batteries from the Plinth during the firmware upgrade process.
