Single Modular Approval Requirements			
1	The radio elements of the modular transmitter must have their own shielding. The physical crystal and tuning capacitors may be located external to the shielded radio elements.	Device is equipped with metal shielding to cover the RF section. Refer to external photos	Y
2	The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation. 3	The modular transmitter must have its own power supply regulation.	Power is provided by a LDO built into the TI CC2520 chip. See block diagram.	Y
4	The modular transmitter must comply with the antenna and transmission system requirements of Sections 15.203, 15.204(b) and 15.204(c). The antenna must either be permanently attached or employ a replaceable antenna coupler (at all connections between the module and the antenna, including the cable).
