




Know your phone

SIM/SD card installation


1. Power off your phone.

Charging the phone

You can charge your phone with a charger or by connecting it to a computer using a USB cable (comes with the phone).

Use only Infinix chargers and cables. Other chargers or cables may damage the phone and invalidate its warranty.
