

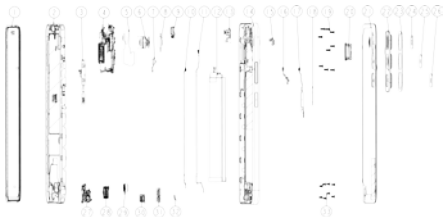

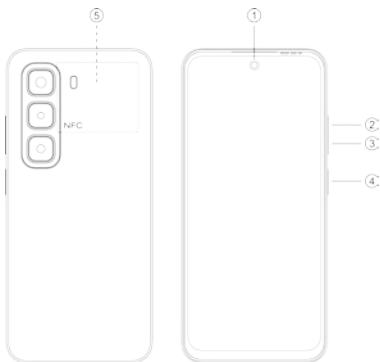

## SIM/SD card installation

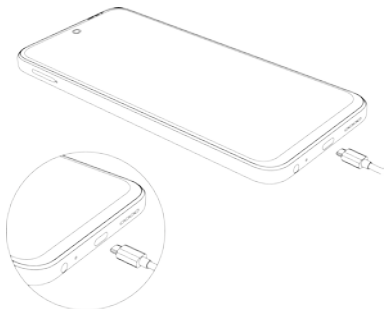
1. Power off your phone.
