Good Practice Guide:

Introduction

In the past decade, the uptake of smart-phones, tablets & gaming machines such as Xbox or PlayStation has been phenomenal! Children as young as 6 years old now commonly use technology at home which gives them full access to the internet. Parents worry about the amount of time their kids spend online, age inappropriate content, cyberbullying, internet trolling, online gambling and self-harm sites.

Internet addiction is now common place and as a result, children are developing poor social skills and have less time for other important things like school work and family.

Many parents are struggling to manage the time that their children spend on the internet and resort to confiscating phones and tablets or turning off the internet at the router. This in turn can lead to additional conflict and less healthy Parent-Child relationships.

What can iKydz do for your family?

iKydz has been developed to give control back to parents so that they can manage internet usage in their own homes. It regulates the amount of time any digital device within the home is used for and filters out content that you are not happy with. Protecting your children"

While iKydz is configuring you can connect back to your existing wireless network and download the iKydz app from either the Apple Store (IOS phones) or the Google Play store (Android)

You can also connect to your private portal @ <https://customerportal.ikydz.com/>

Login using the email address and PIN you used during registration

Once the iKydz unit has completed its down loads and installation, it is recommended that you check that all functions are operational by simply connecting to the iKydz wireless network and ensure that you can surf the internet. It may take longer to complete this process that anticipated base on your bandwidth speed.

Next, you can then begin to connect your children's devices to the iKydz network. It is recommended you remove/forget the existing home network details and access from the children's devices. It is also recommended that you change the Wi-Fi password on your existing network.

Quick registration.

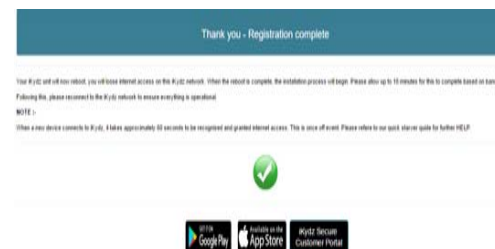
On your PC or tablet (we recommend browser for ease of use) connect wirelessly to the new safe SSID called "IKYDZ". Password:" ikydzwifi". It will take 60 to fully connect first time.

Next open your browser and type into the URL Bar: **10.10.10.1**

You will then be taken to the ikydz Registration Page. Fill in the mandatory information fields denoted with * and press “Begin Registration”.

An onscreen prompt will appear while iKydz downloads and configures your safe network. **This process will take up to 10 minutes to install and configure**

During this time any device connected to the iKydz SSID will have no internet access. **(Note – do not switch off the device during this process.)**
