Applied procedures / limit

According to FCC §15.247(i) and §1.1307(b)(1), systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy level in excess of the Commission's guidelines.

MPE PREDICTION

Predication of MPE limit at a given distance, Equation from OET Bulletin 65, Edition 97-01

$$S = PG/4\pi R^2$$

Where: S = power density

P = power input to antenna

G = power gain of the antenna in the direction of interest relative to an isotropic radiator

R = distance to the center of radiation of the antenna, R=20cm

13.56MHz Note:dbm=dbuv/m-95.2=101.07-95.2=5.87dBm(ERP), so the conduct peak power=5.91- 1=5.87dBm

125kHz+13.56MHz supported simultaneous transmission:

125kHz+13.56MHz MIMO : $\sum \text{MPE Ratio} = 0.0067 + 0.0008 = 0.0075 \leq 1$, So passed.
