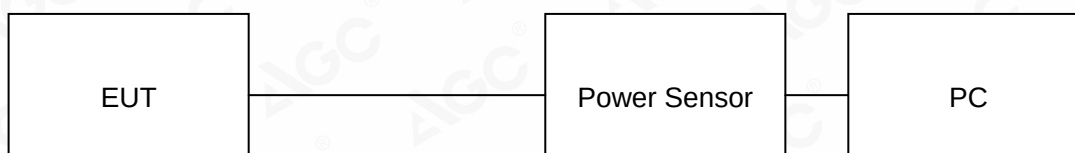

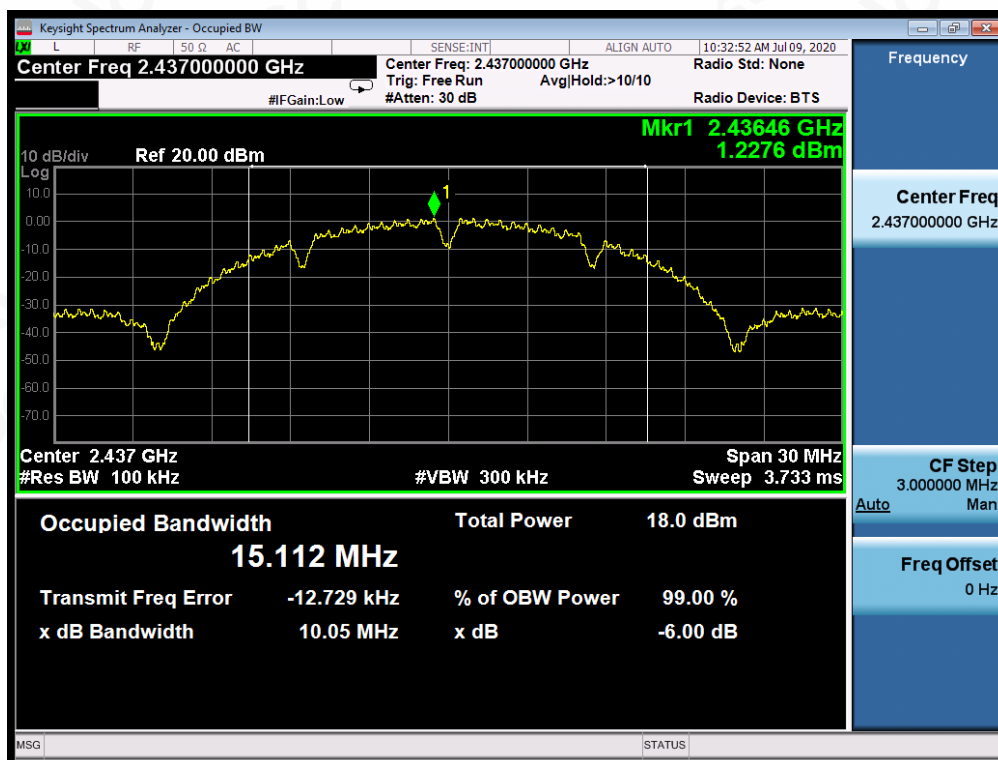

TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL

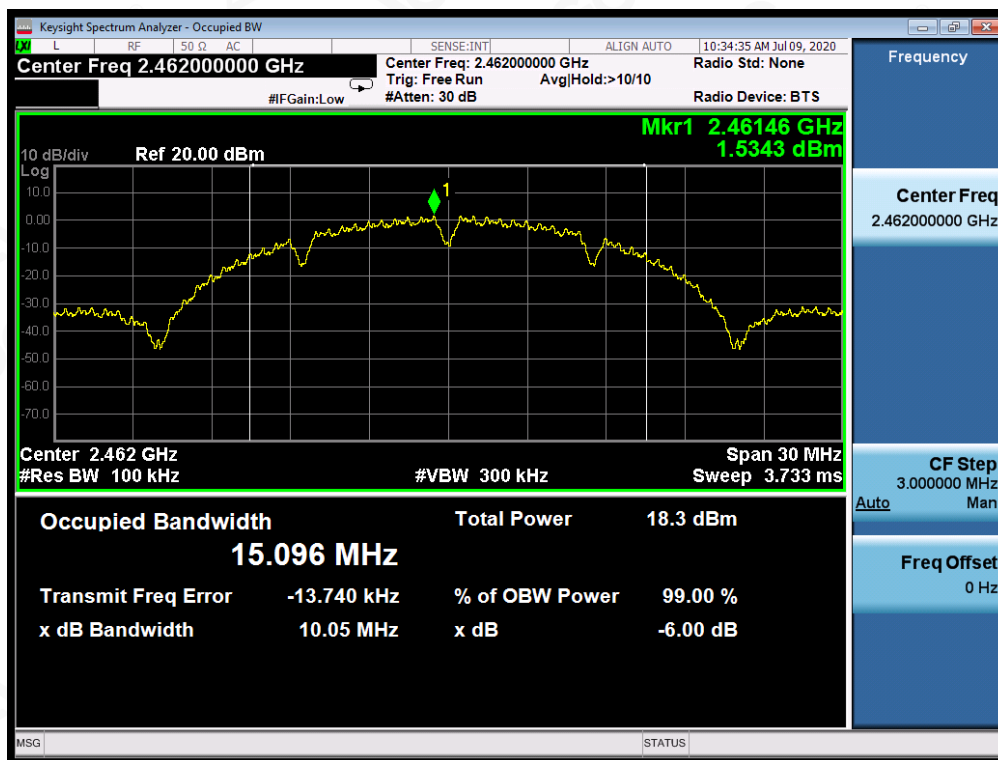

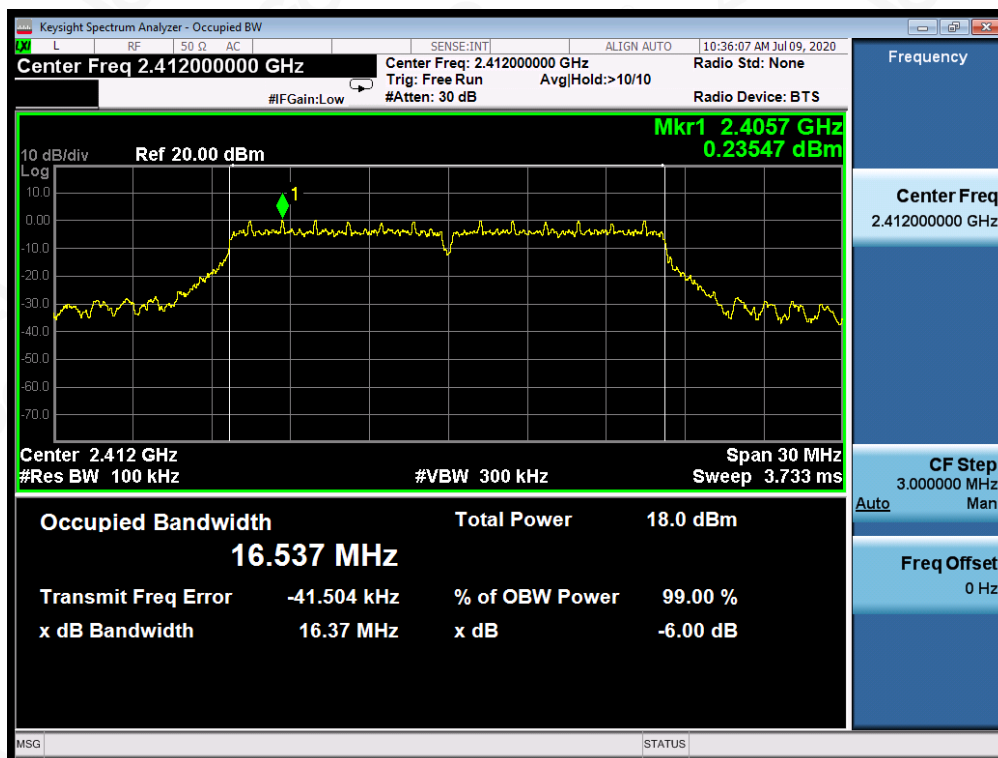


TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL

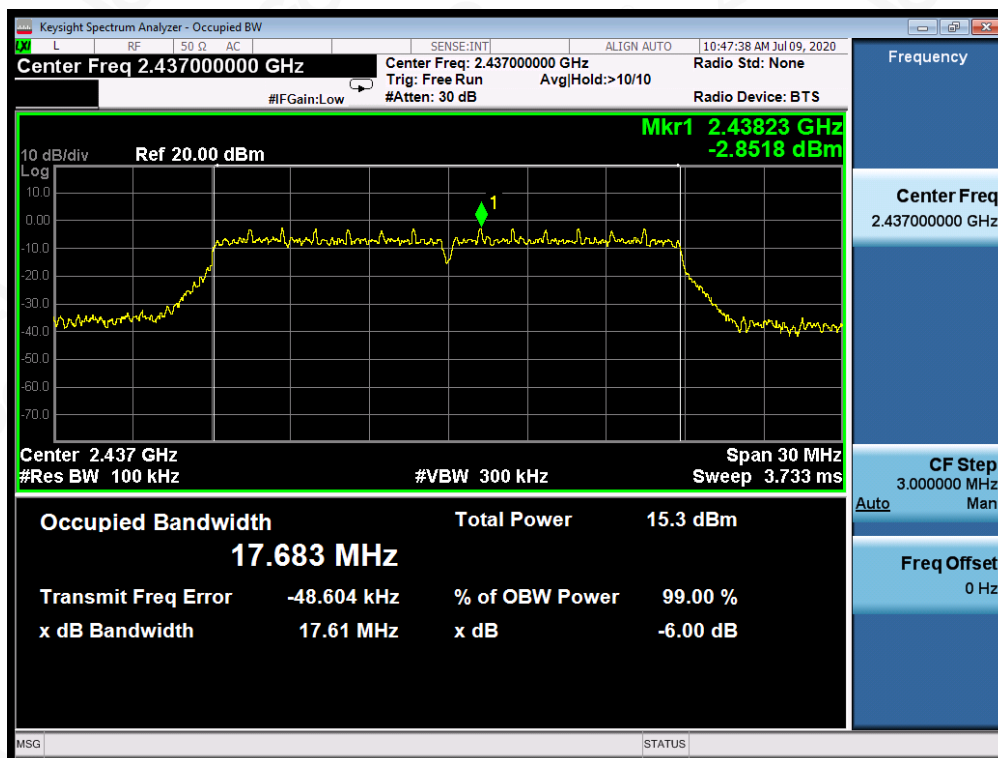


802.11n (20) TEST RESULT

TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL

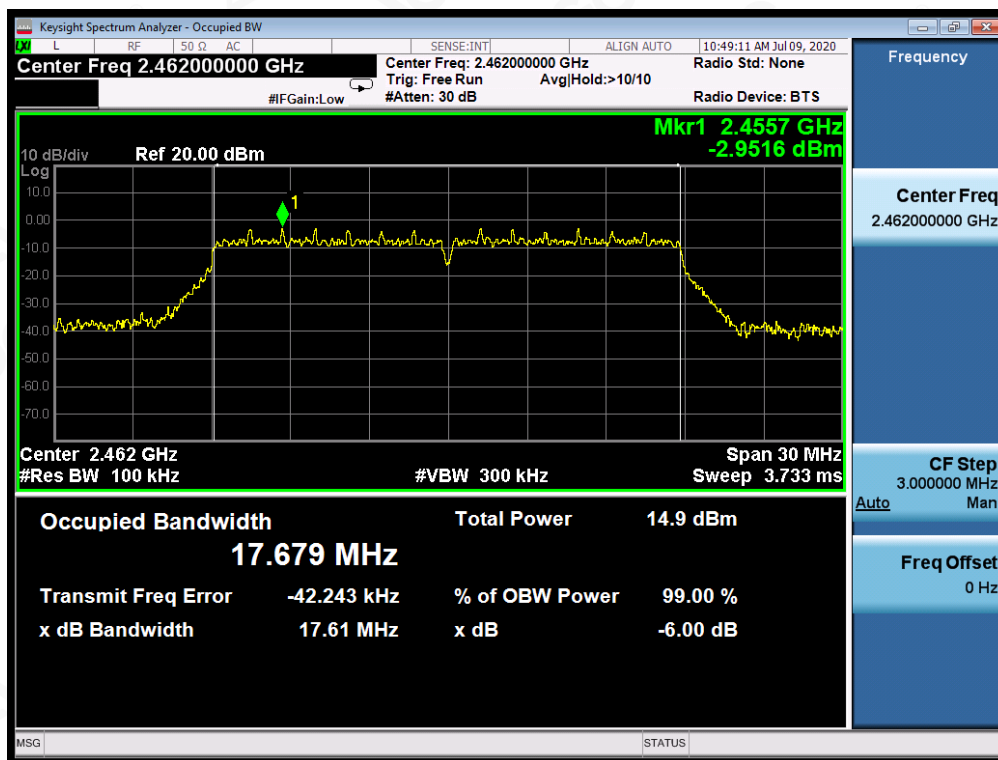

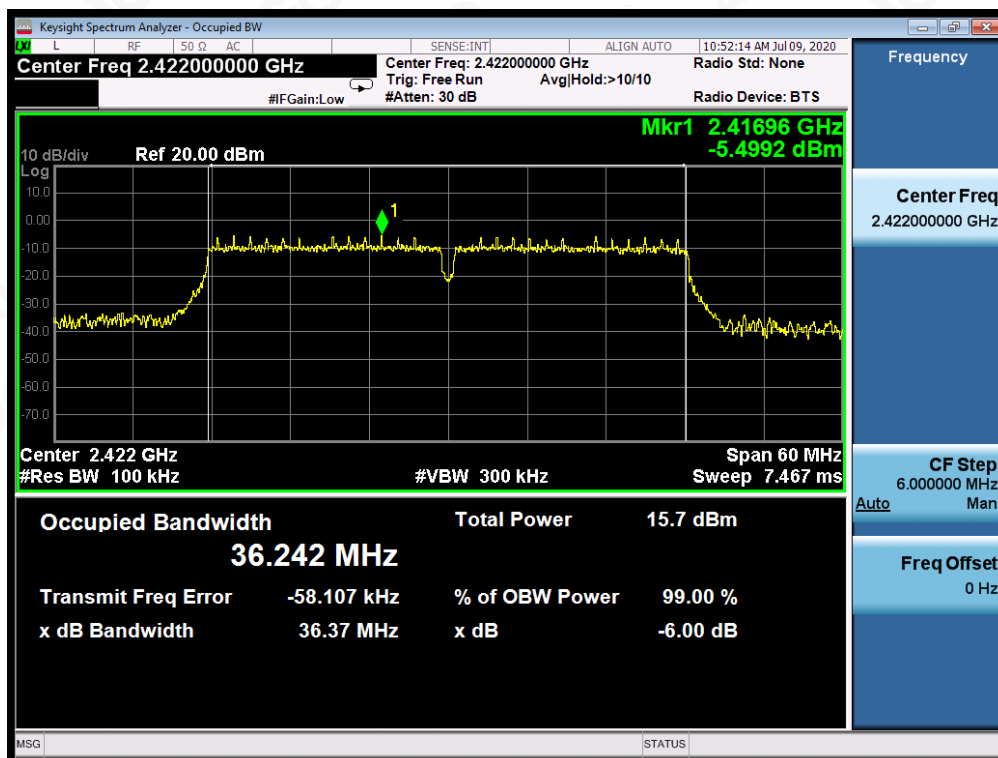


TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL

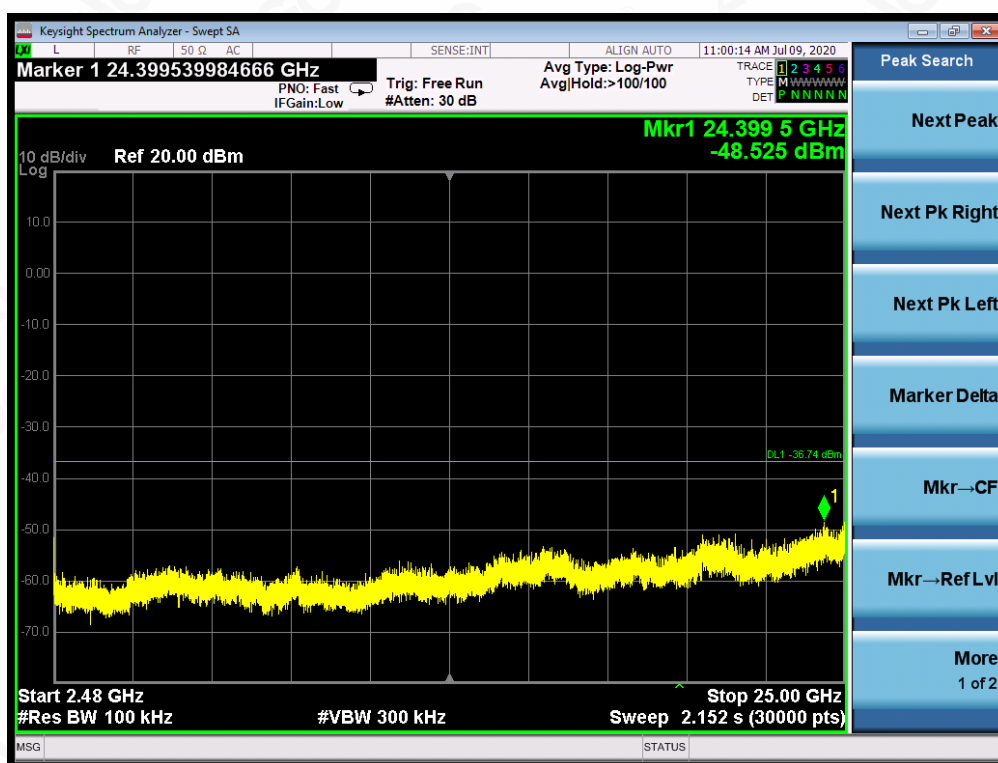
TEST PLOT OF OUT OF BAND EMISSIONS THE WORST CASE
OF 802.11n40 FOR MODULATION IN MIDDLE CHANNEL



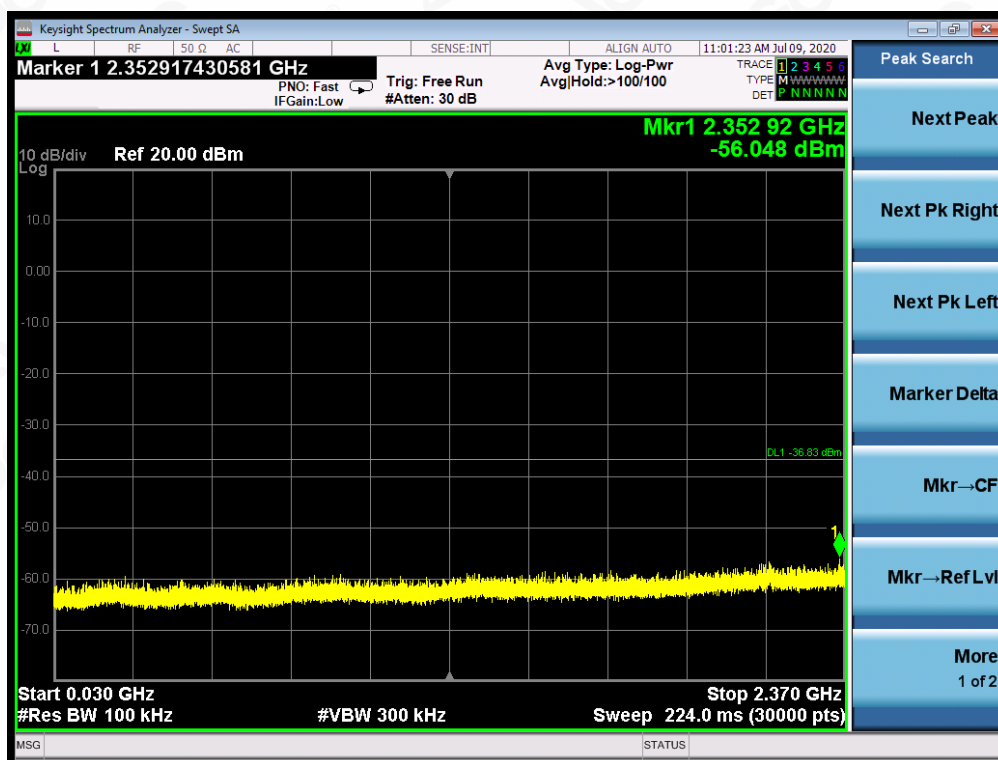

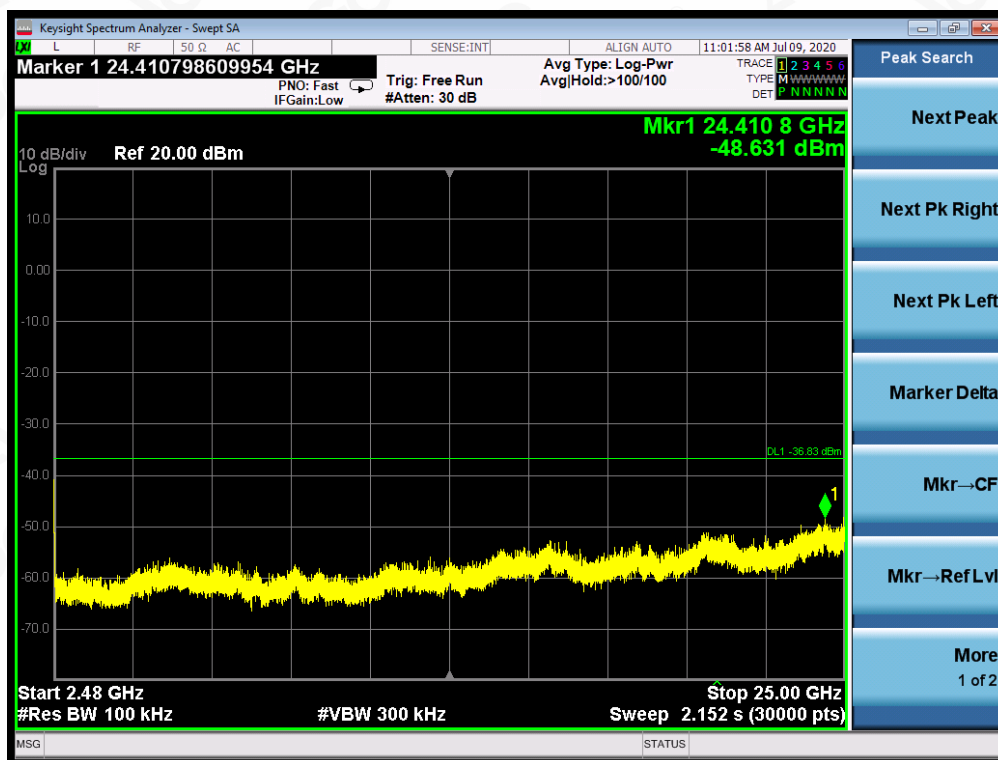
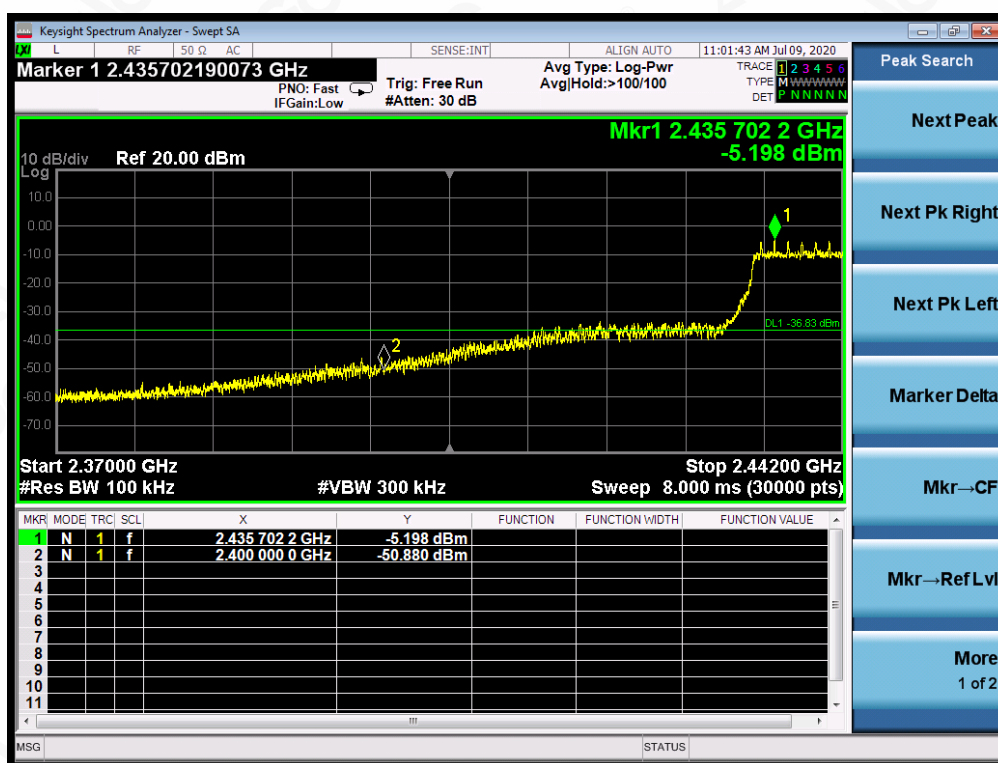
TEST PLOT OF OUT OF BAND EMISSIONS THE WORST CASE

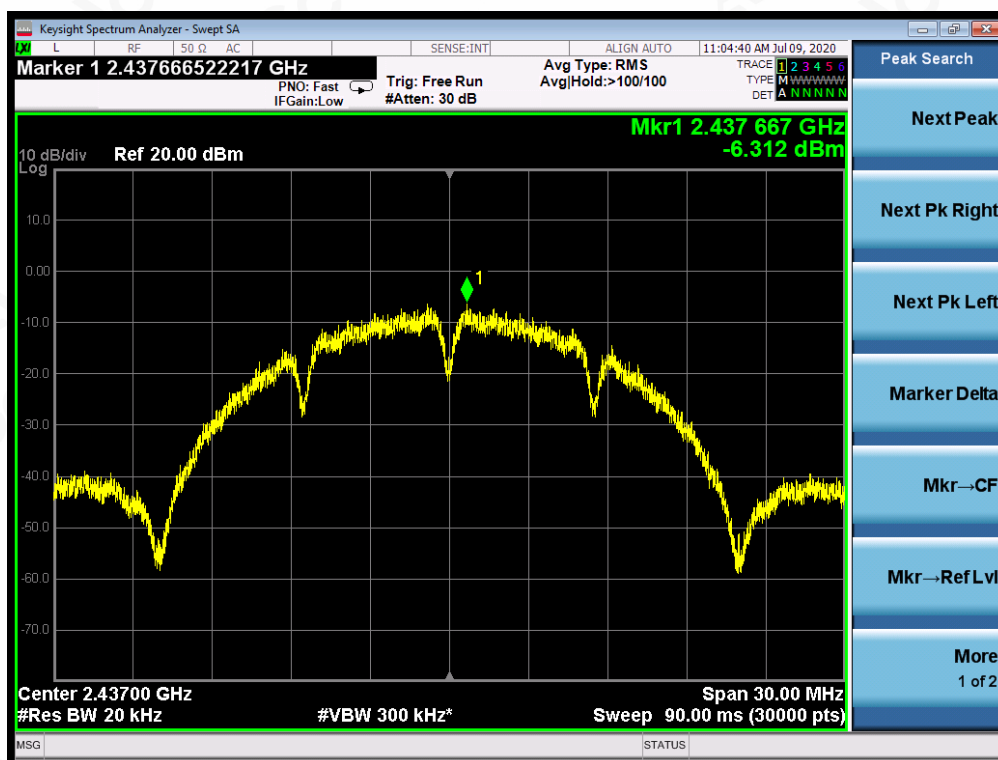
