
⚠ Please be slow down or walk when you are in bad road.

12 Safety

-Please avoid to ride the device under if light is not enough.

-Please keep relax pose to ride this device.

-Riding backward is very dangerous,do not try to do it,because the device does not support it.

13 Maintenance

F0 body has stains, you can use soft cloth with little water wiping; if it is difficult to clean the stain, you can use toothpaste and toothbrush clean, then use wet cloth clean.

Tips: Don't use alcohol, petrol, kerosene or other corrosive and volatile chemical solvent, otherwise appearance and inner structures will be badly damaged. Don't use pressure gun spray.

When not in use, the storage of F0 is dry and cool place, don't put it in the outdoor for a long time. The sun/ hot/ cold outdoor environment will accelerate aging of F0 appearance, tire and battery.

F0 battery Maintenance

Don't put battery in the more than 50°C or less than -20°C environment(such as, please do not lay F0 or battery on the car under the summer sun). Don't put the battery into fire, it caused battery failure, overheating, even fire. Other battery maintenance please refer to battery brand under the body.

As far as possible to avoid power fully draining, please charge in time, extend the life of battery. In addition, battery will achieve extended range and high performance in the normal temperature; if you use F0 under 0°C, extended range and performance of battery will decline.

14 Warranty

The warranty does not cover certain situations, including, but not limited to, the following:

Malfunction due to misuse

Expired warranty

Discrepancy between warranty card, proof of purchase, and product.

Product that has been disassembled, or repaired by anyone who is not authorized by FastWheel.

Damage caused by accident, abuse, or misuse, such as mechanical failure, damage due to dropping, or extreme rust.

Damage caused by exceeding weight limits, riding over barriers(such as riding down a flight of stairs or falling over) or engaging in extreme sports.

Other malfunction or damage not caused by design, technology, manufacturing or quality issues.

Please keep the warranty card and invoice as evidence.
