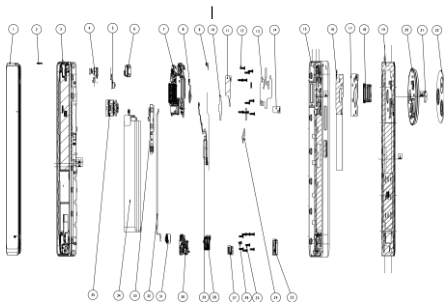

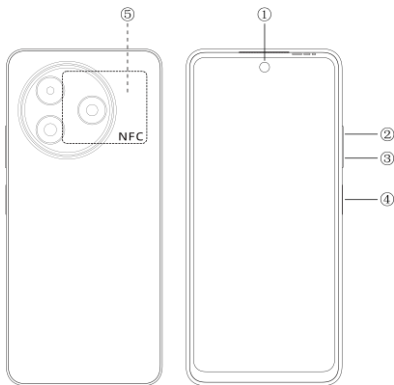

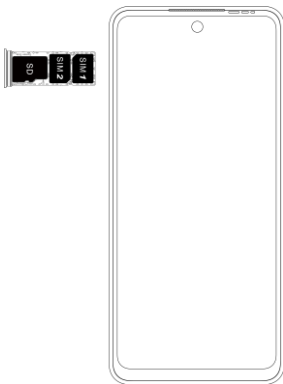
Know your phone

SIM/SD card installation

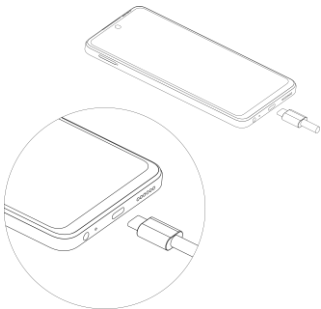
1. Power off your phone.

Charging the phone

You can charge your phone with a charger or by connecting it to a computer using a USB cable (comes with the phone).

Use only itel chargers and cables. Other chargers or cables may damage the phone and invalidate its warranty.

Information to the user.

Note: This device has been tested and found to comply with the limits for a Class B digital device, pursuant to part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference in a residential installation. This device generates, uses and may radiate radio frequency energy and, if not installed and used in accordance with the instructions, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this device does cause harmful interference to radio or television reception (able to be determined by turning the device off and on), the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the device and receiver.

Specific Absorption Rate (SAR) information:

This mobile phone meets the government's requirements for exposure to radio waves. Body-worn Operation

This device was tested for typical body-worn operations. To comply with RF exposure requirements, a minimum separation distance of **1.0 cm** must be maintained between the user's body and the handset, including the antenna. Third-party belt-clips, holsters, and similar accessories used by this device should not contain any metallic components. Body-worn accessories that do not meet these requirements may not comply with RF exposure requirements and should be avoided. Use only the supplied or an approved antenna.
