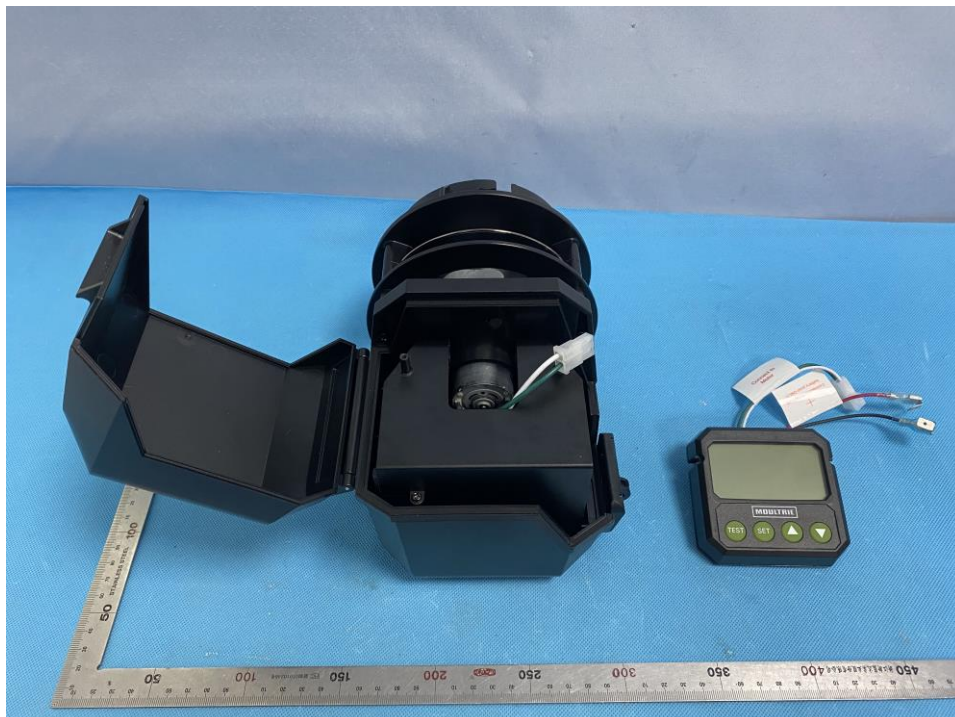

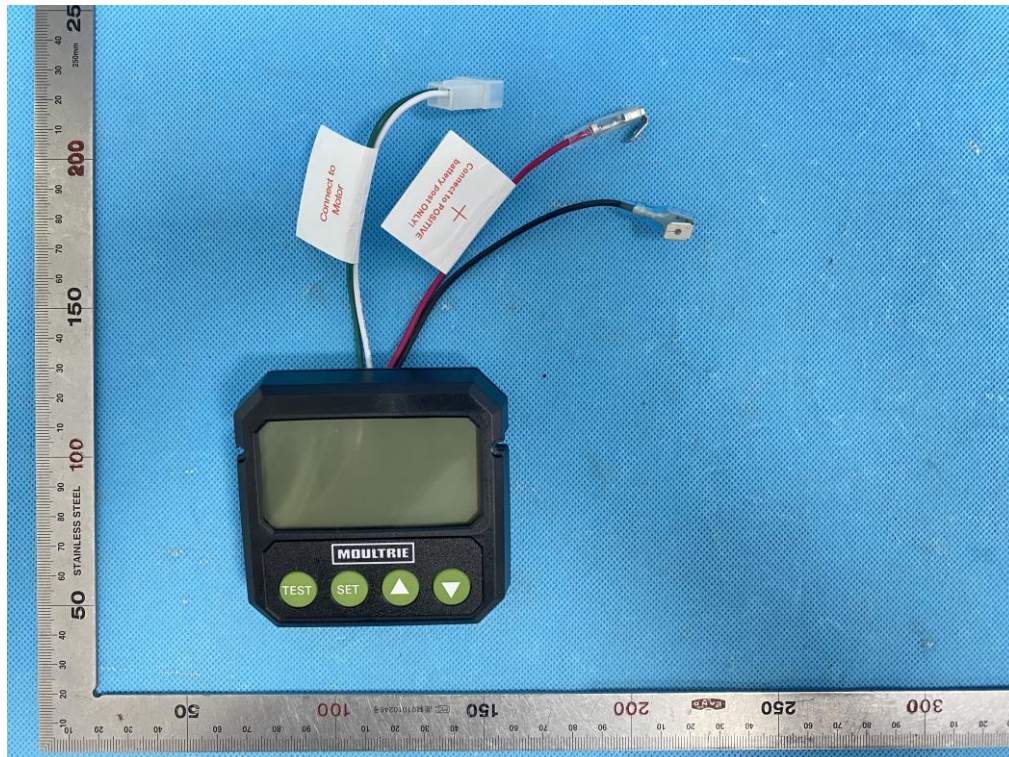

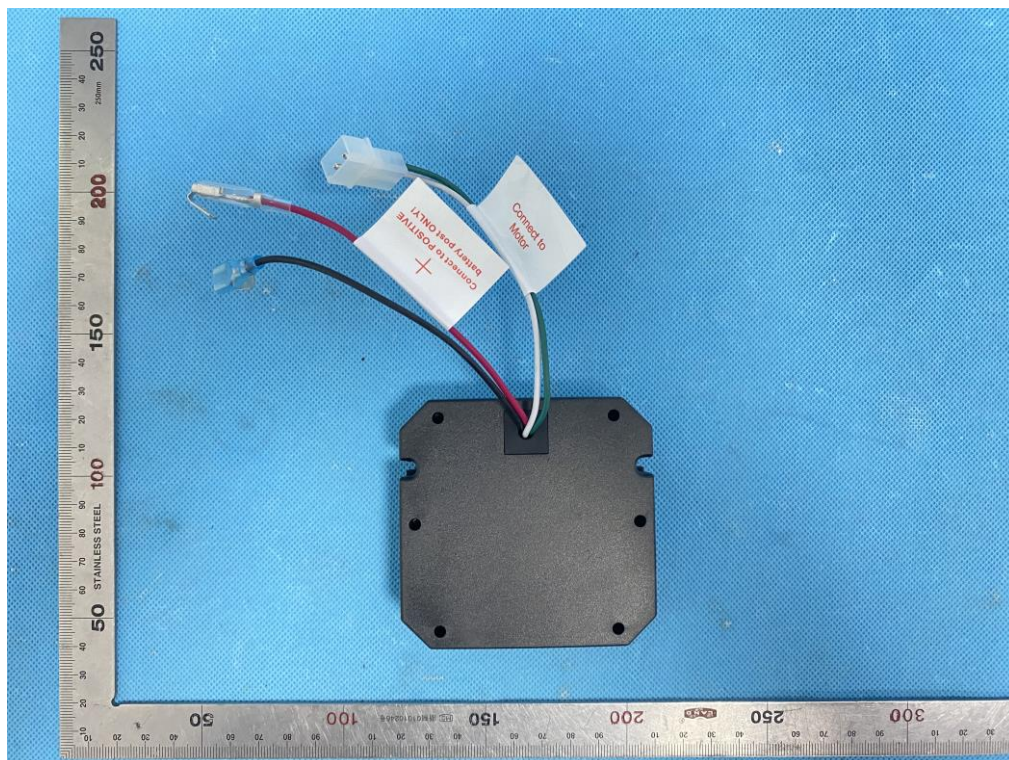

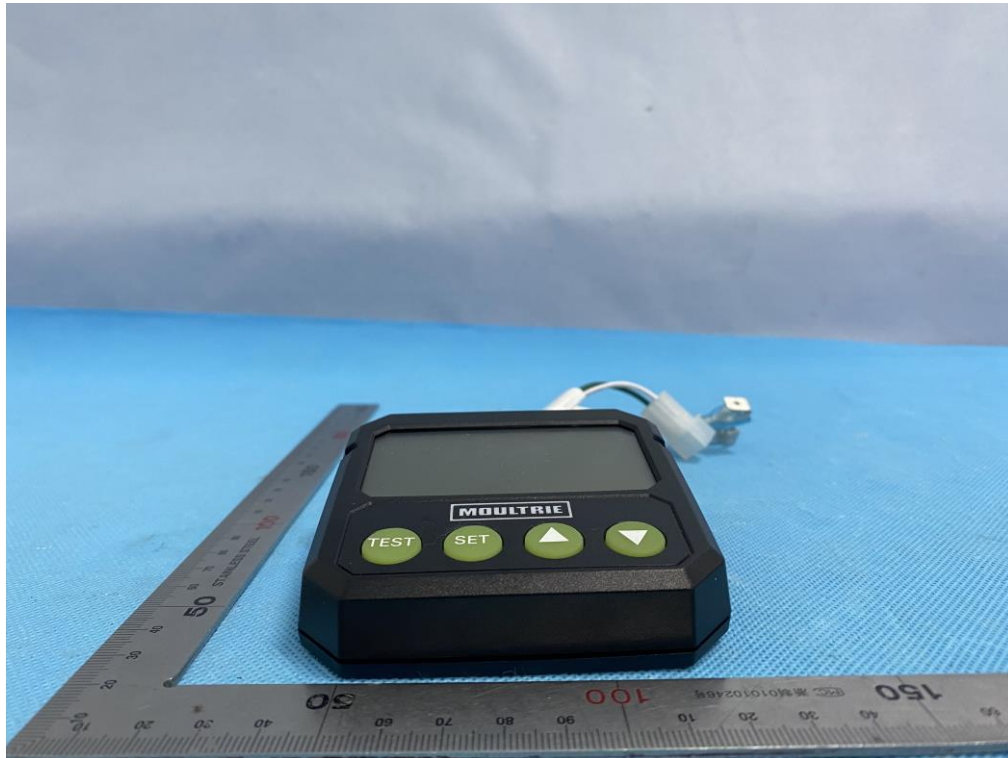


INTERNAL VIEW OF EUT (FIGURE 4)

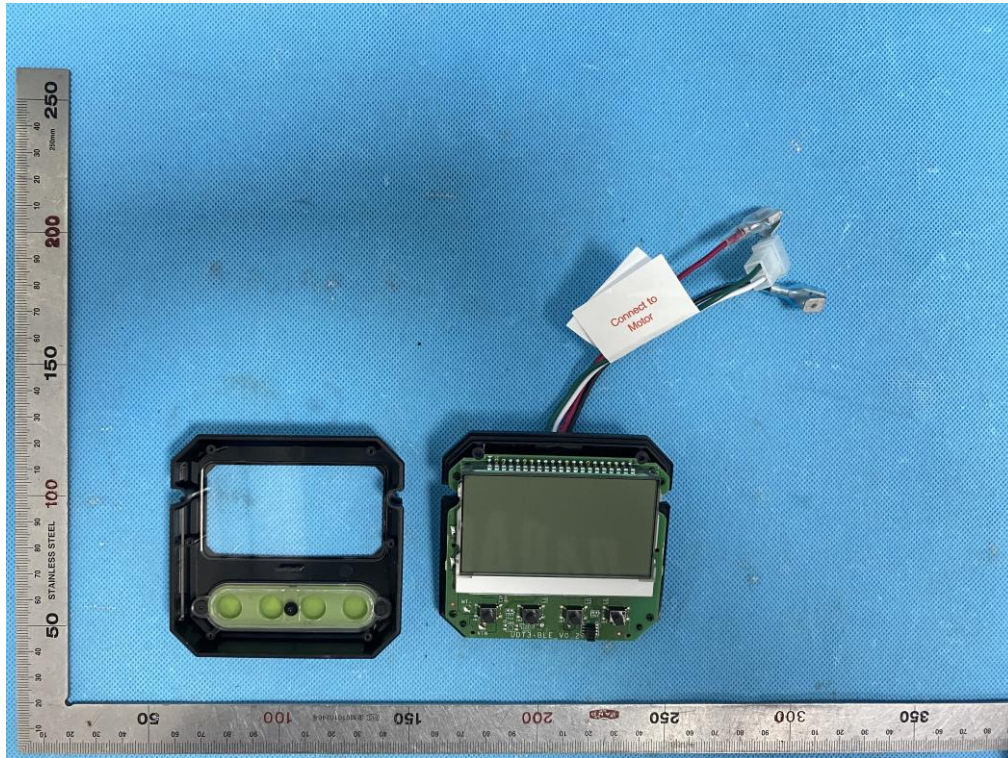

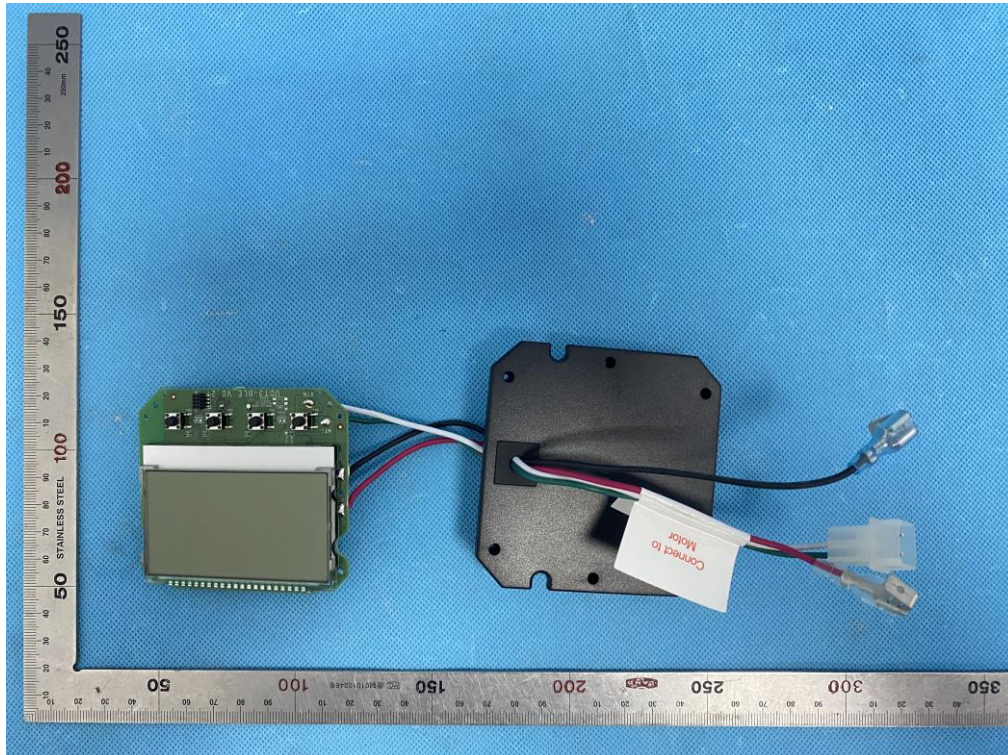

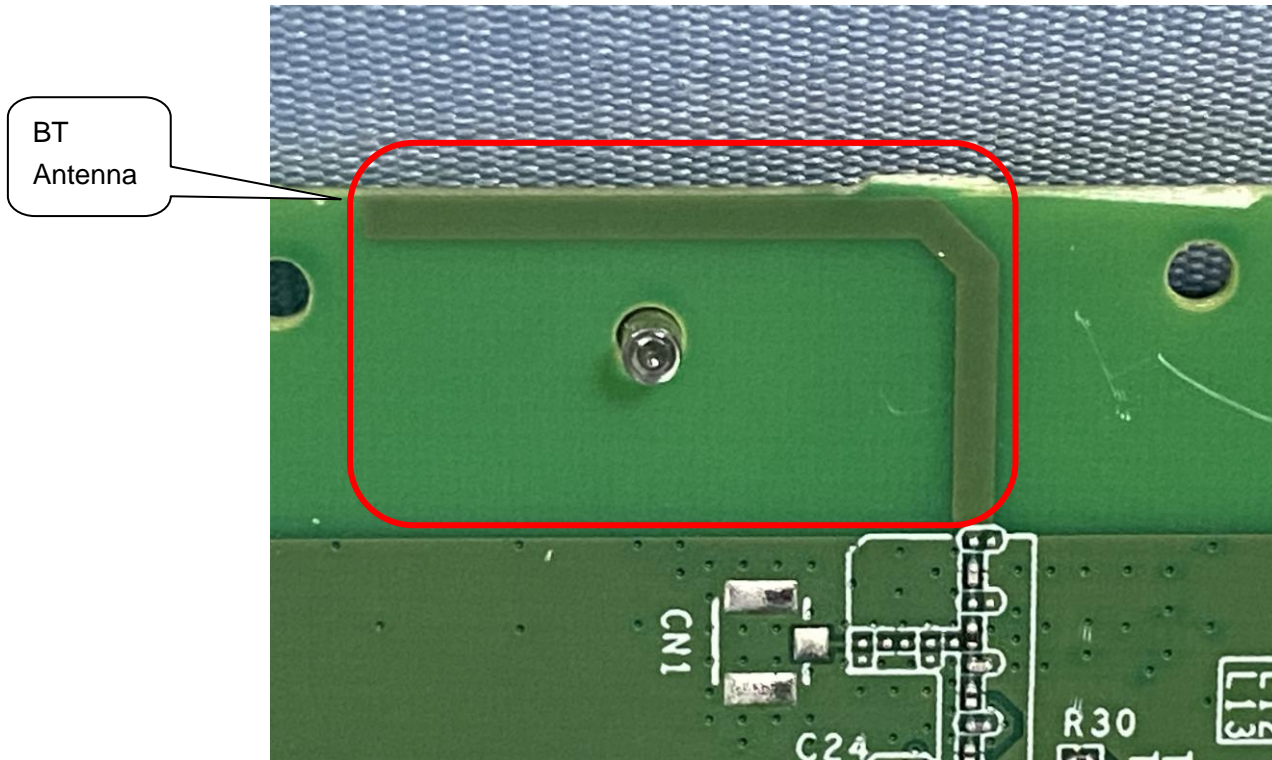

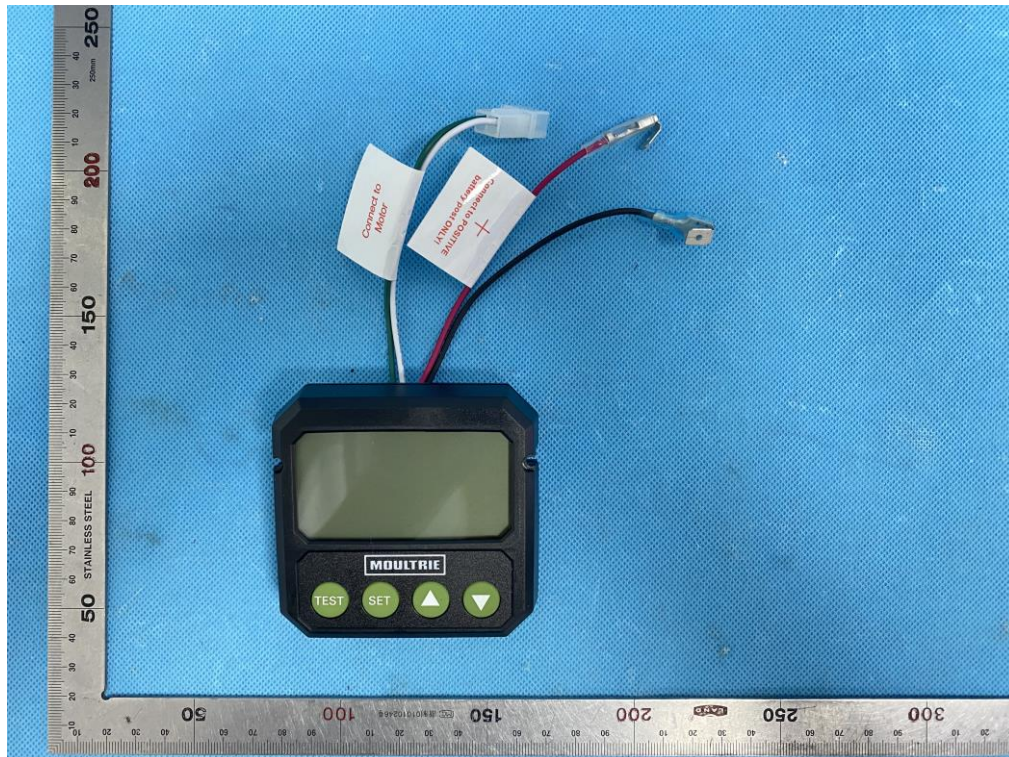

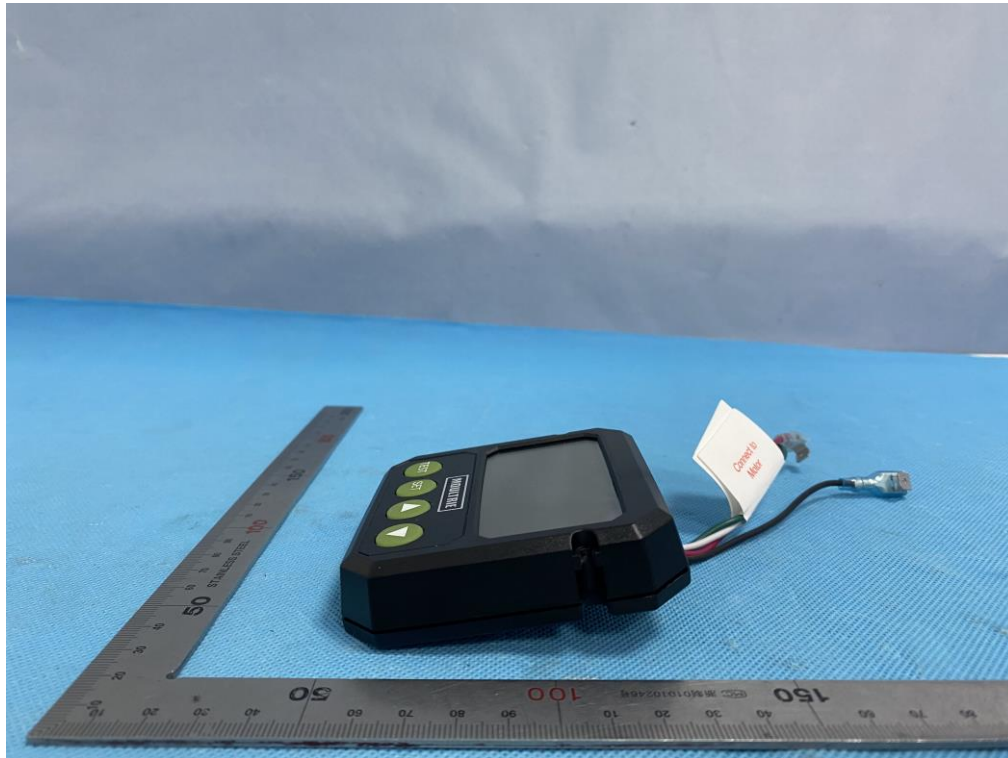

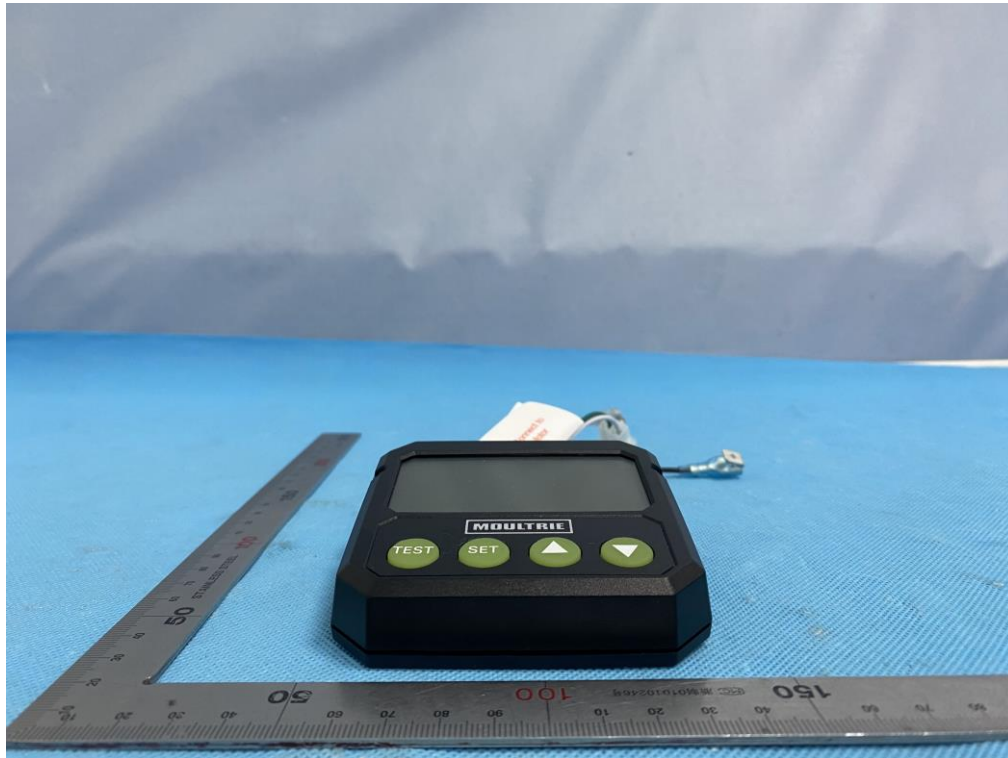

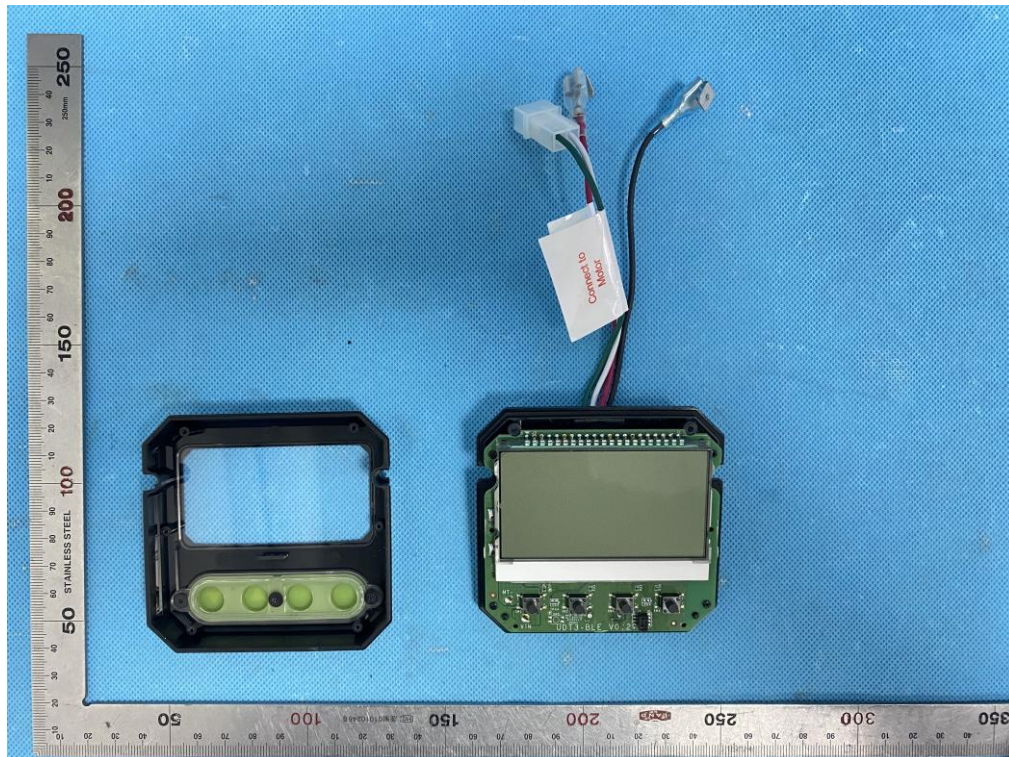


INTERNAL VIEW OF EUT (FIGURE 7)

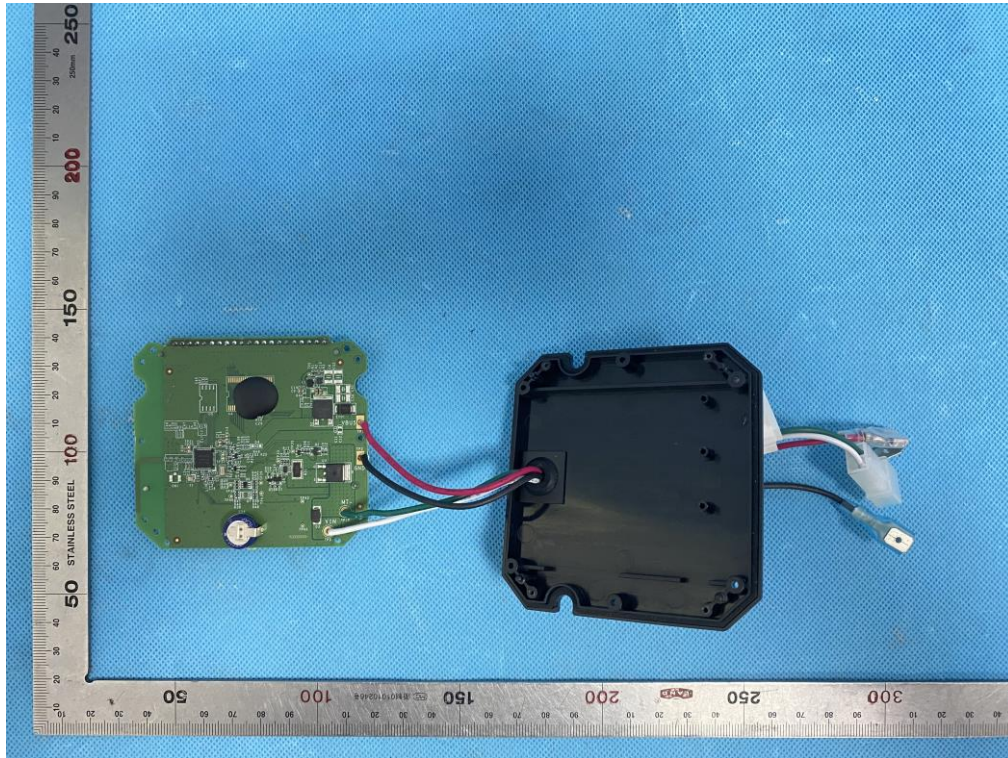

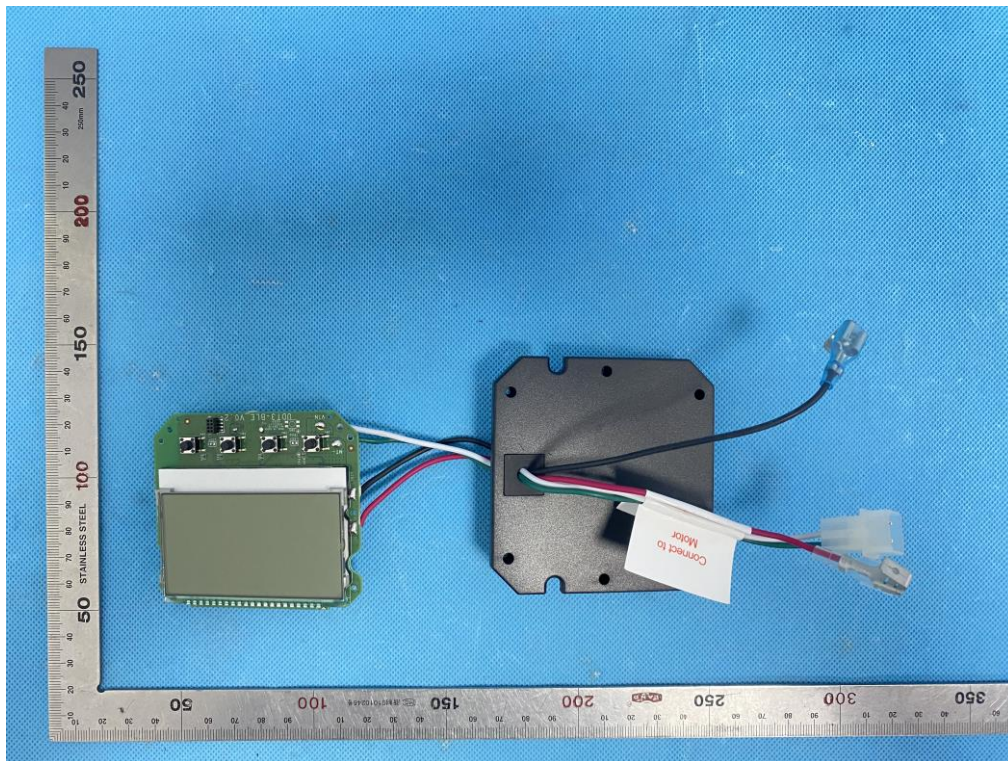

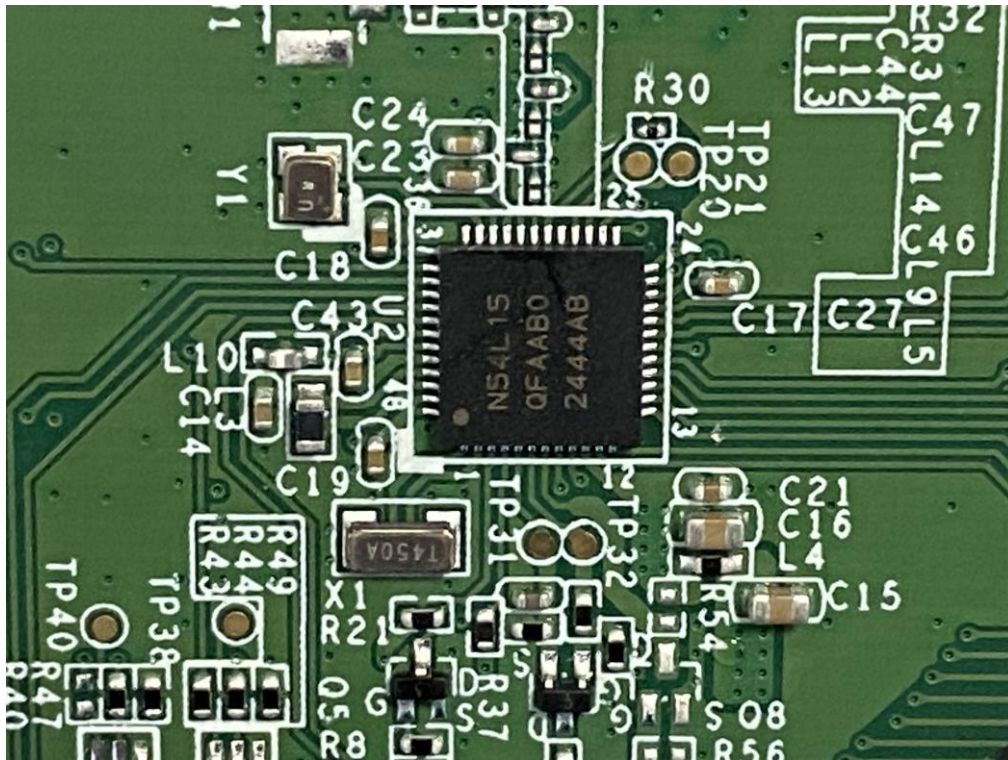
