3DH1_Ant1_Hop



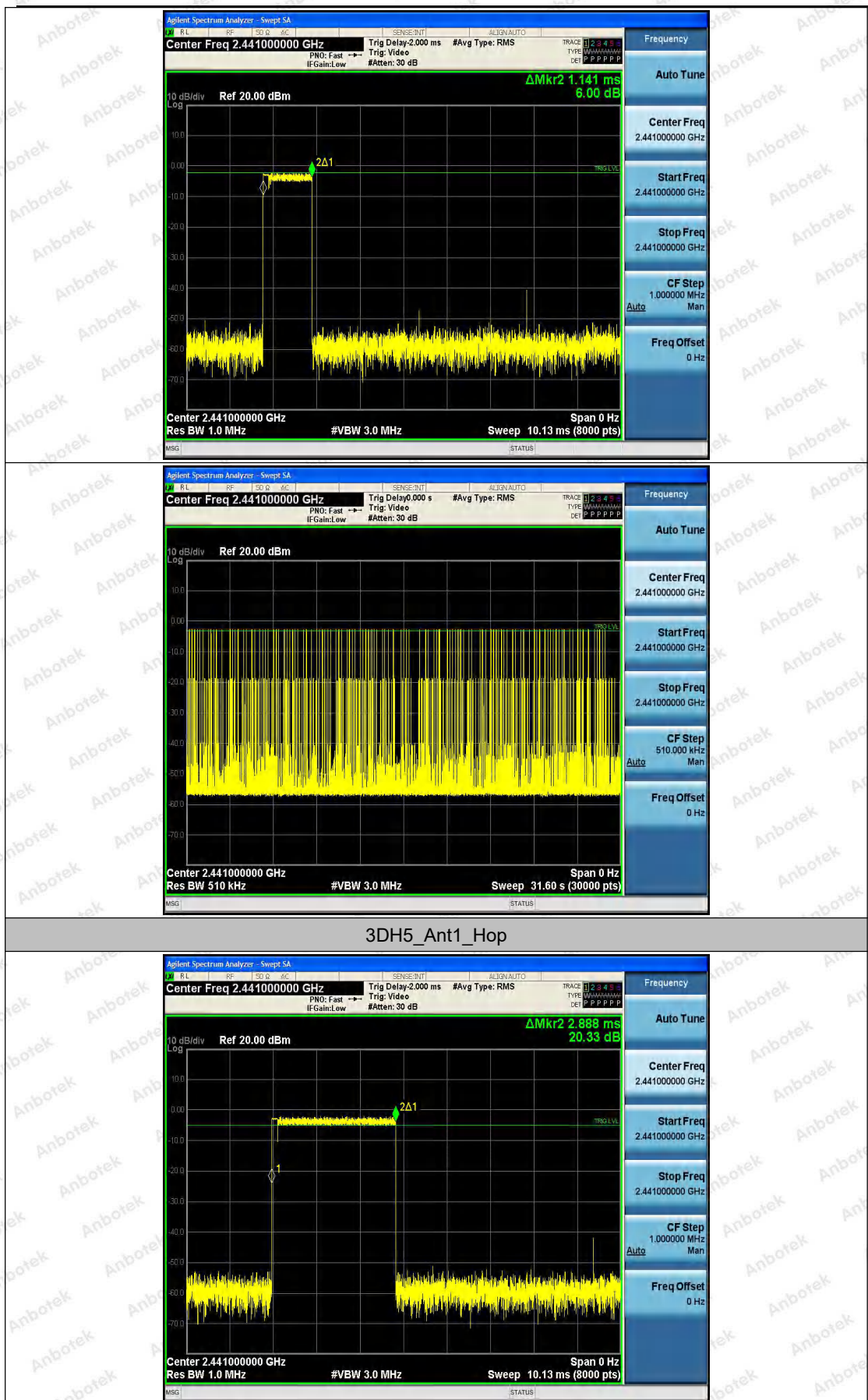
