User guide:

1.Charge the speaker for 3 hours before first use.
2.The power indicator will be red while charging (full charging time is about 2 hours).
3.The speaker will automatically turn off after 10 minutes.
4.To use, simply connect the speaker to your smartphone, tablet, laptop, or MP3 player using the audio cable provided.
5.The speaker will automatically switch on when the audio cable is plugged into the speaker.
6.You can now play music from your smartphone, tablet, laptop, or MP3 player.
7.The volume can be adjusted from the connected device.
8.Disconnect the audio cable when not in use.

Safety precautions:

1.Please read the instructions carefully before use.
2.Avoid contact with liquids and humid conditions.
3.Keep the speaker and cord away from sources of heat such as radiators, heaters, air ducts, and direct sunlight.
4.Keep naked flames away from the Warpt Speaker.
5.Charge the battery with correct voltage output (5V/500mA).
6.Do not drop the product, or insert any conductive objects into the speaker or charging jack.
7.Do not block the speaker grill when the speaker is running.
8.Stop using at once if the product is overheated or producing smoke, a burning smell, abnormal noise, sparks or flames.
9.Do not attempt to repair the product yourself. Seek the help of a professional.
10.To avoid electric shocks, do not touch the product with wet hands.
11.Keep out of the reach of children.

Troubleshooting:

1.The LED indicator is not illuminated.
2.Audio cable is not fully plugged into the 3.5 mm audio port on speaker or device.
3.Audio cable is damaged.
4.Source of audio is not working.
5.LED indicator does not illuminate when audio cable is plugged in.
6.Warpt Speaker is out of power.
7.Not charging.
8.Input power source is incorrect (should be 5V/500mA).
9.Micro USB adaptor plug on charging cable is not fully plugged into the Warpt Speaker charging port.
10.Charging cable is damaged.
11.Battery failure.
12.LED indicator does not illuminate.
13.LED indicator failure.
14.Battery empty.
15.Audio cable not fully plugged into the socket.
