### 1.Charging instructions

- ◎Insert DC connection to the charging hole.
- ◎You can charge the toys with USB wire on computer or mobile plug.
- ◎Please take out the DC connection after charging.

#### 1. Please comply with the followings before using the product:

- ◎Clean the product completely.Scrub it with an antibacterial soap and then wash with clean hot water.At last,wipe it gently with towel or soft cloth.

- ◎Don't use massage oil or hand cream as lubricant.
- ◎Don't use the silicon-based lubricant as it will damage the product surface.

- ◎None of components can be replaced or repaired by the users. If any part of the product requires replacement,please contact your dealer.

### Maintenance of the built-in battery:

- ◎This product uses rechargeable batteries. A new battery can play its full effectiveness after 2-3 times charging and discharging processes.
- ◎A battery can be charged or discharged for over 100 times and will go bad finally.After being charged fully,the battery shall be disconnected from the charger because overcharge may reduce the battery life.
- ◎When the product is not used,the battery capacity will release gradually.
- ◎If the product is placed at too hot or cold environment,it will reduce the battery capacity.And if the battery is too hot or cold,the battery life will get shorter even though it is fully charged.

### Battery warning!

- ◎When the battery is wrongly operated,it will cause fire or chemical burn.
- ◎Suggest to use LEVETT charger to charge the battery.
- ◎The battery shall be disposed in accordance with the local laws and regulations.

#### Charger Maintenance:
