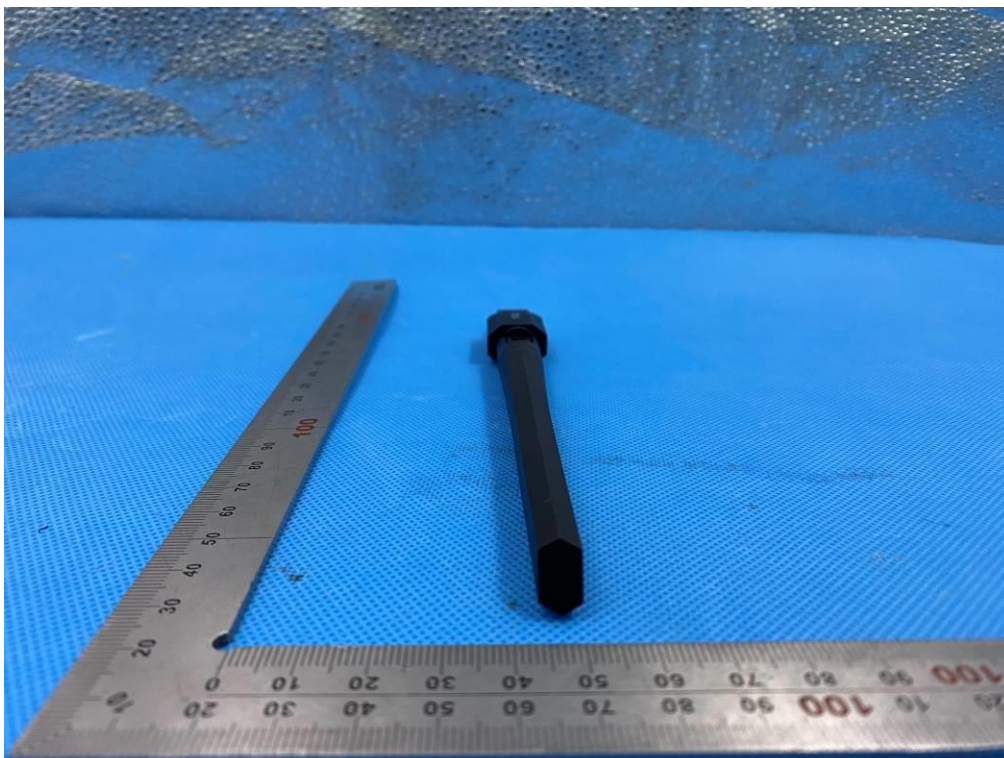

BACK VIEW OF EUT



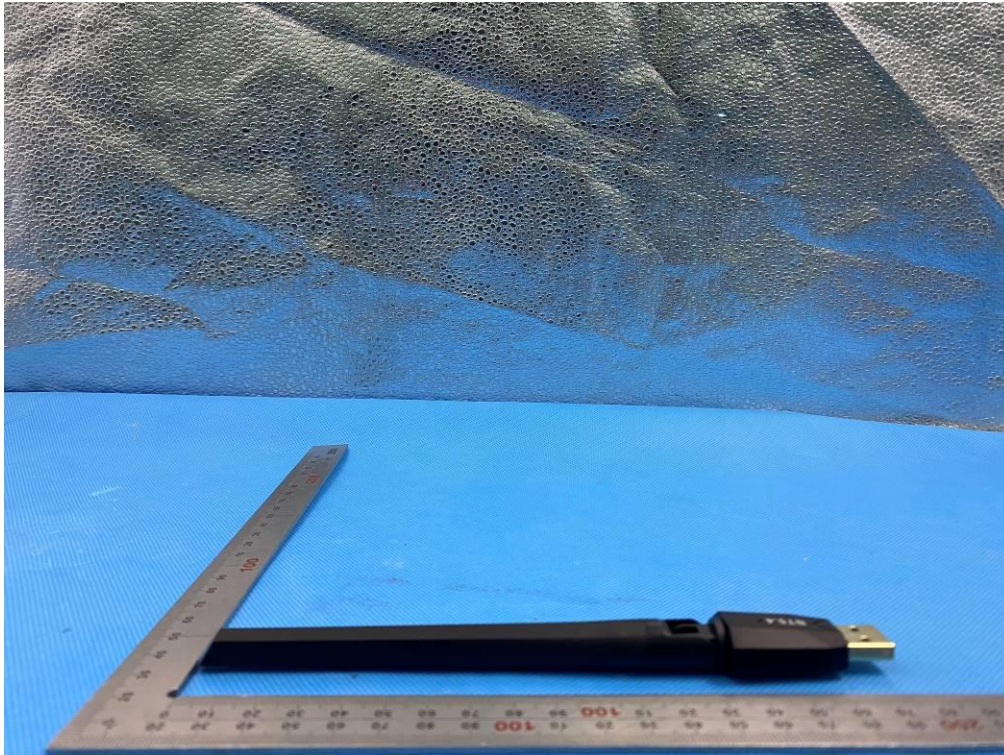

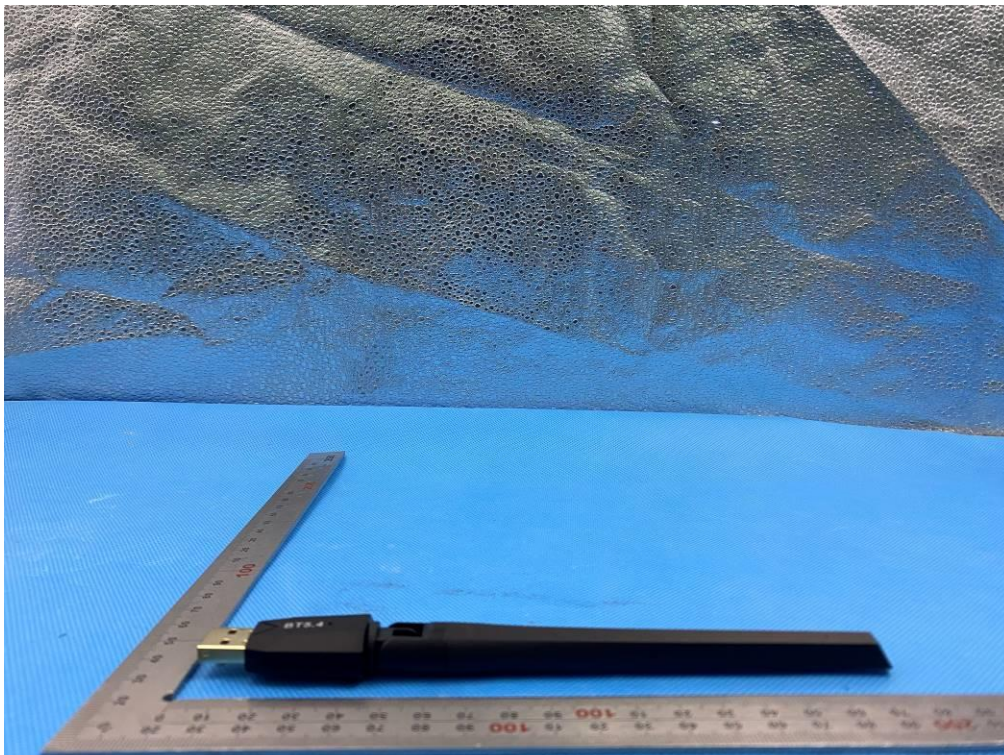

RIGHT VIEW OF EUT



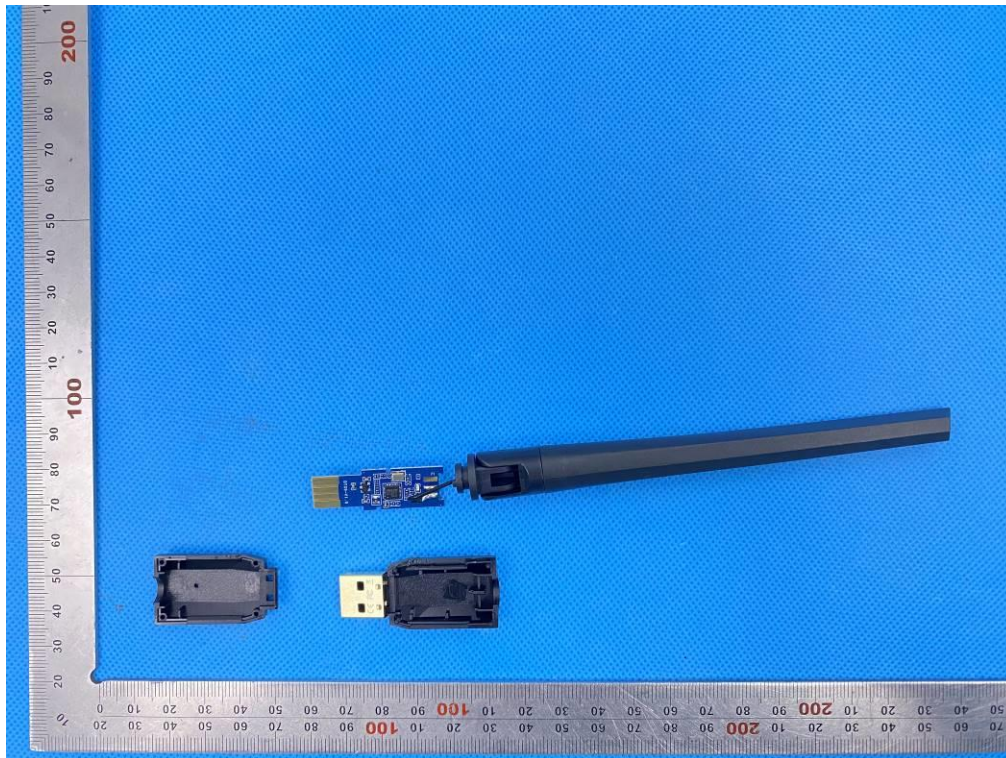

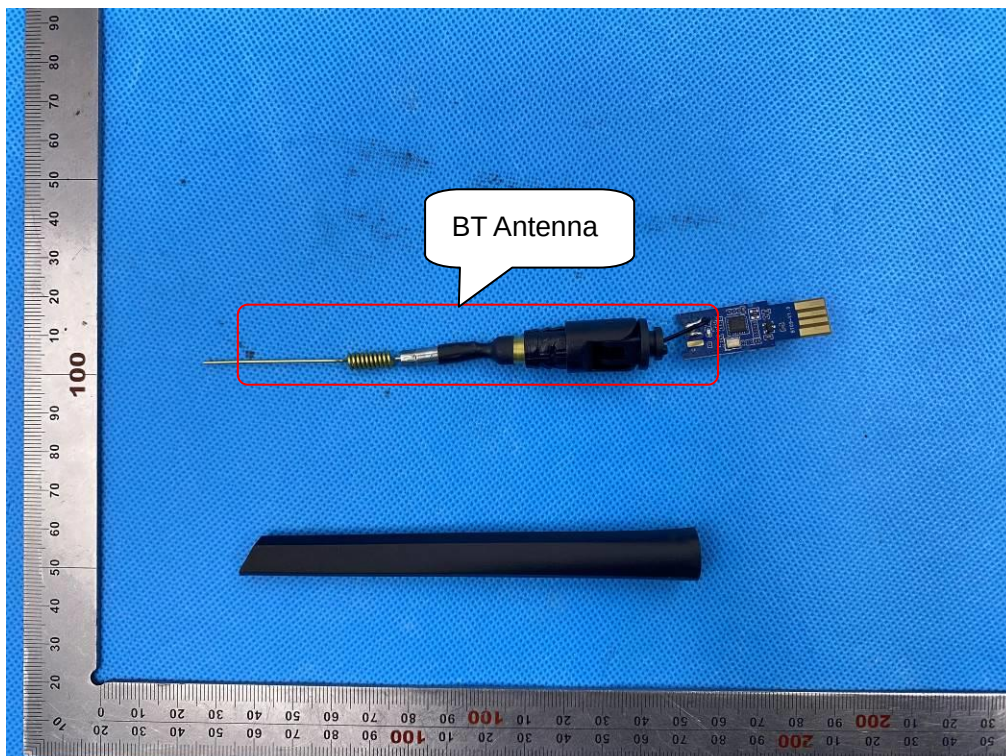

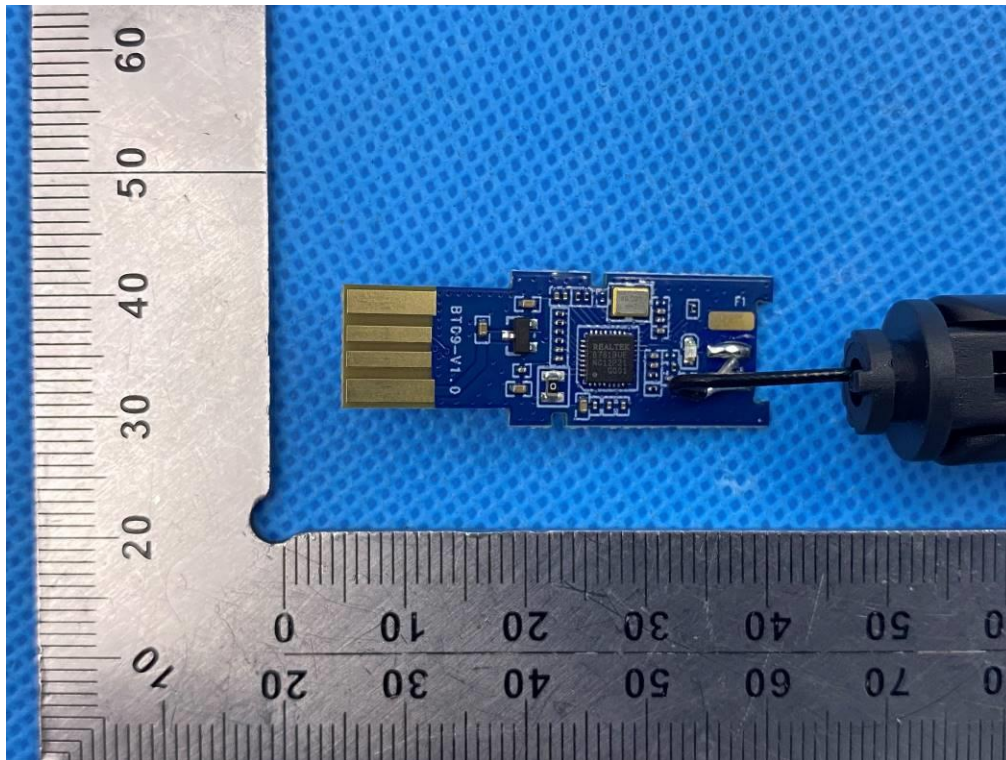

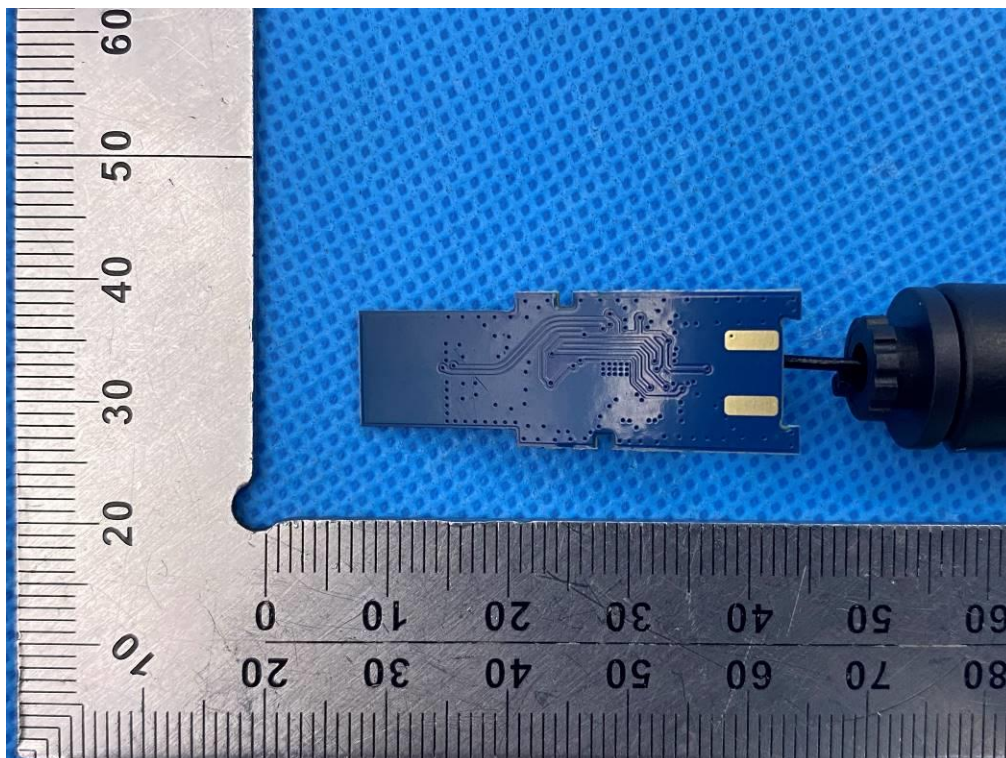

INTERNAL VIEW OF EUT (FIGURE 2)



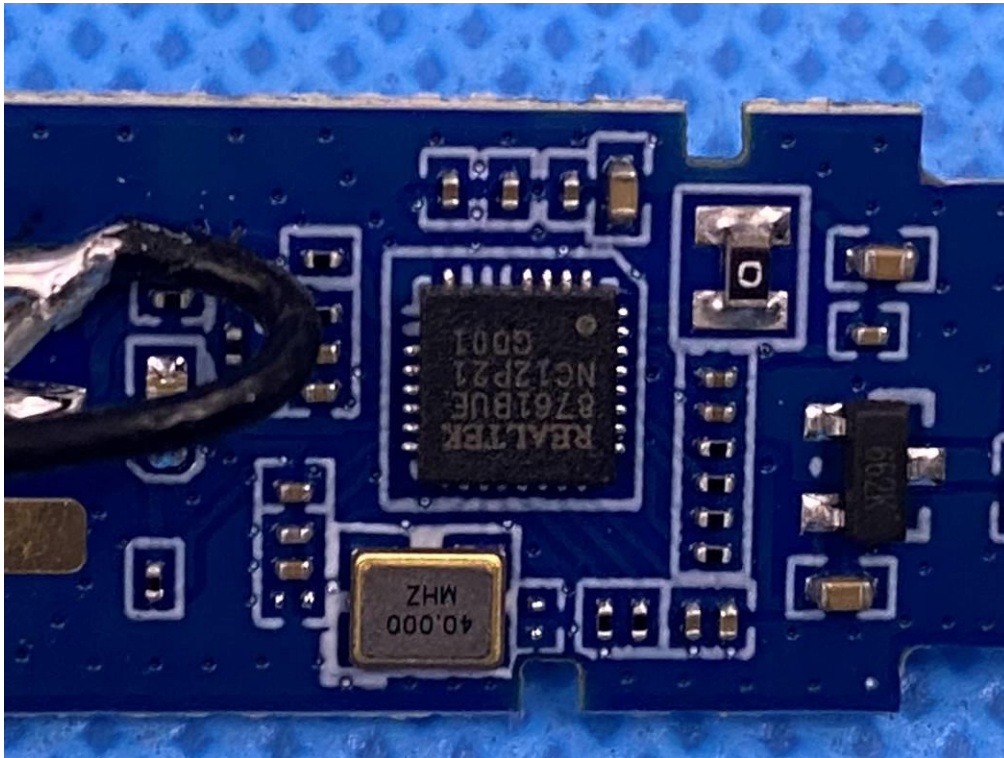

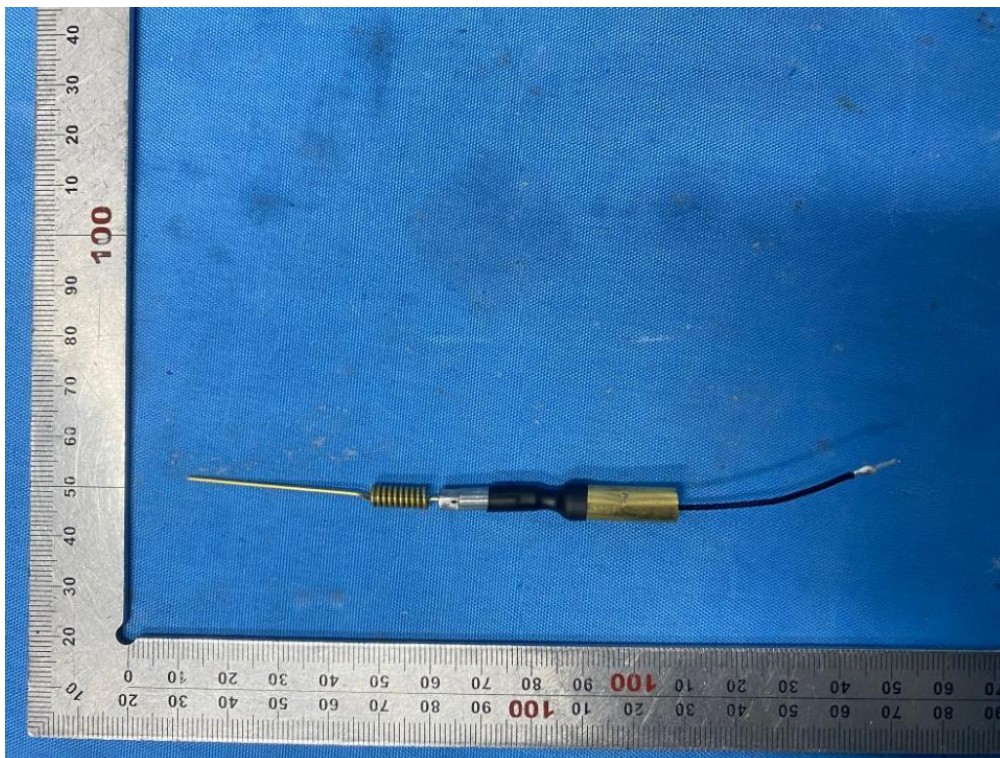
