

## 6 Radio Spectrum Technical Requirement

### 6.1 Antenna Requirement

#### 6.1.1 Test Requirement:

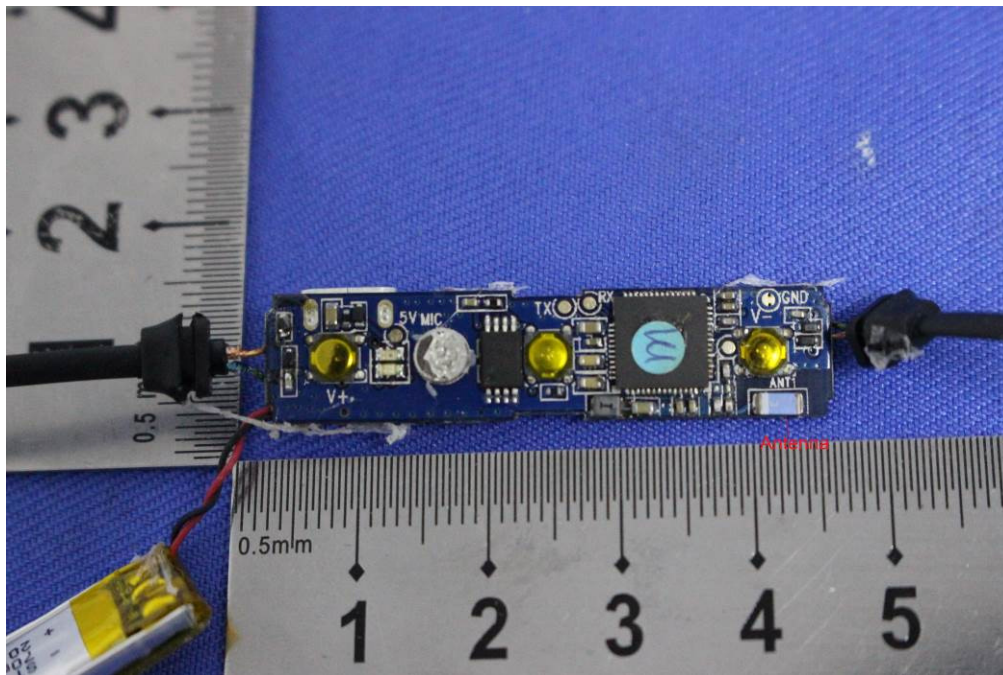
47 CFR Part 15, Subpart C 15.203 & 15.247(c)

#### 6.1.2 Conclusion

Standard Requirement:

Testing shall be performed using the highest gain antenna of each combination of licence-exempt transmitter and antenna type, with the transmitter output power set at the maximum level. When a measurement at the antenna connector is used to determine RF output power, the effective gain of the device's antenna shall be stated, based on a measurement or on data from the antenna manufacturer.

EUT Antenna:



The antenna is integrated on the main PCB and no consideration of replacement. The best case gain of the antenna is 0dBi.



## **6.2 Other requirements Frequency Hopping Spread Spectrum System Hopping Sequence**

### **6.2.1 Test Requirement:**

47 CFR Part 15, Subpart C 15.247(a)(1),(g),(h)

### **6.2.2 Conclusion**

Standard Requirement:

The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONES; i.e. the shift register is initialized with nine ones.

Number of shift register stages: 9

Length of pseudo-random sequence:  $2^9 - 1 = 511$  bits

Longest sequence of zeros: 8 (non-inverted signal)

Linear Feedback Shift Register for Generation of the PRBS sequence

An example of Pseudorandom Frequency Hopping Sequence as follow:

Each frequency used equally on the average by each transmitter.

According to Technical Specification, the receivers are designed to have input and IF bandwidths that match the hopping channel bandwidths of any transmitters and shift frequencies in synchronization with the transmitted signals.

According to Technical specification, the system incorporates with an adaptive system to detect other user within the spectrum band so that it individually and independently to avoid hopping on the occupied channels.

The system is designed not have the ability to coordinated with other FHSS System in an effort to avoid the simultaneous occupancy of individual hopping frequencies by multiple transmitter.

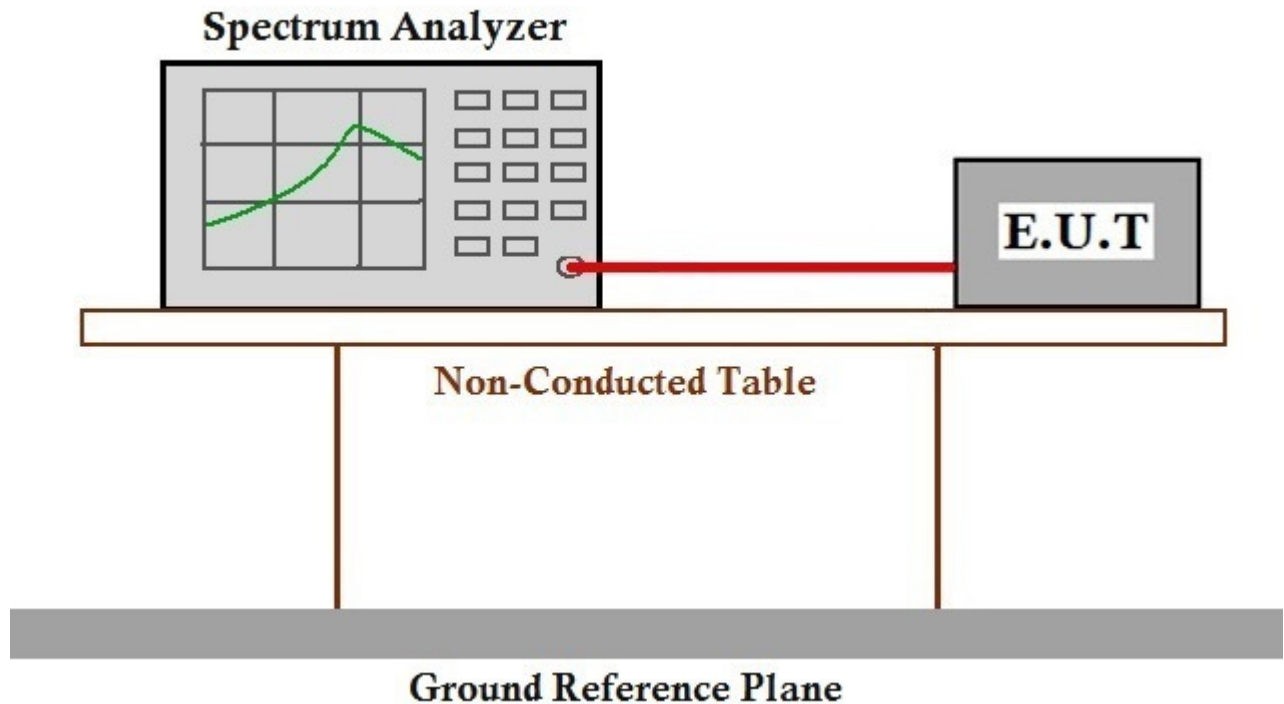

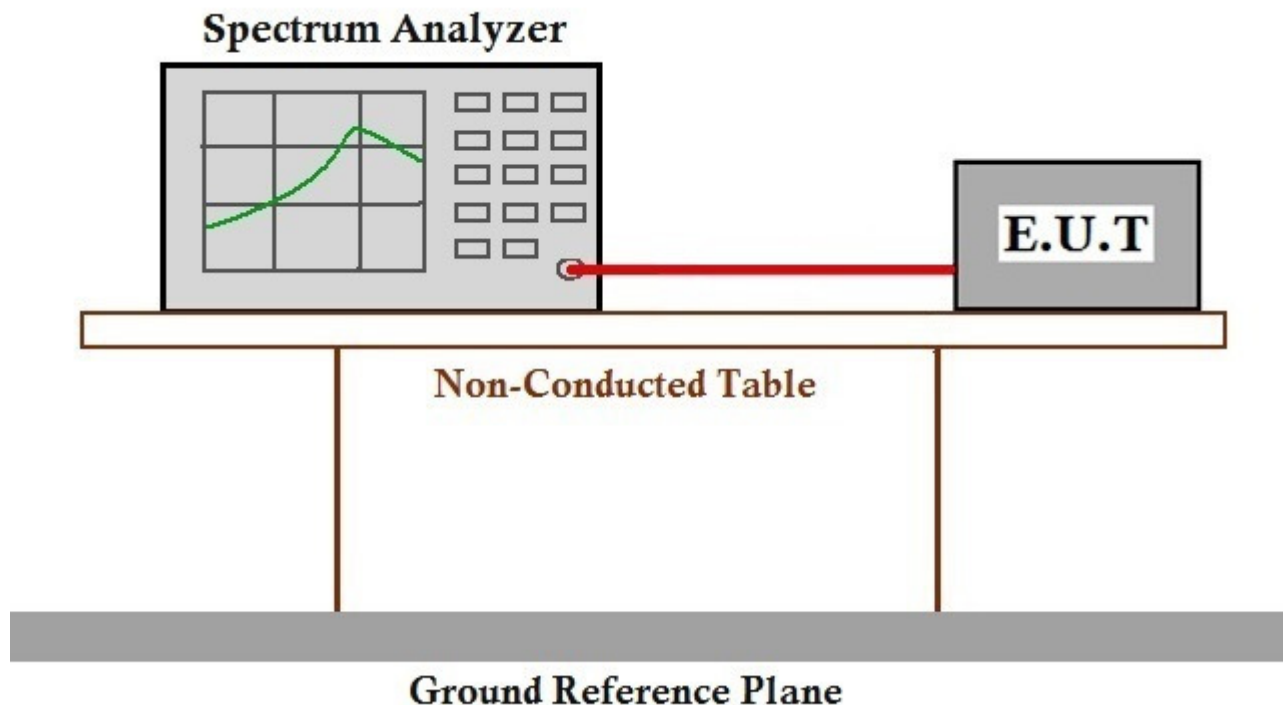

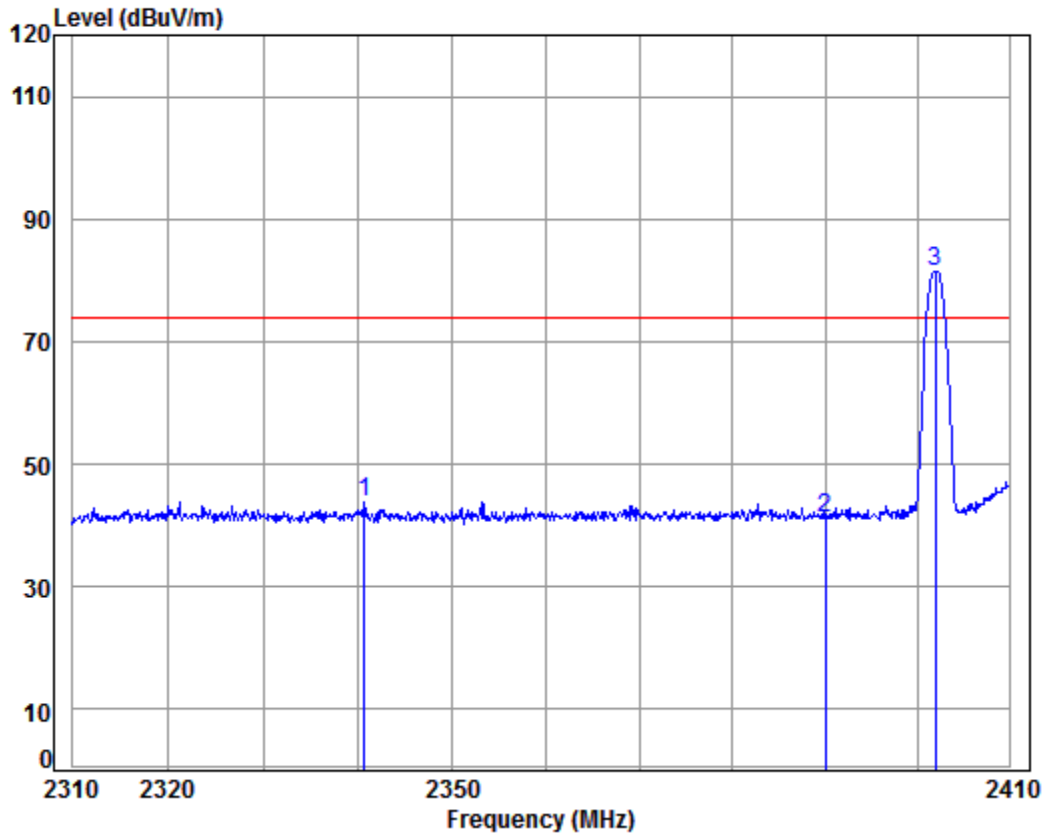

### 8.1 Radiated Spurious Emissions Test Setup



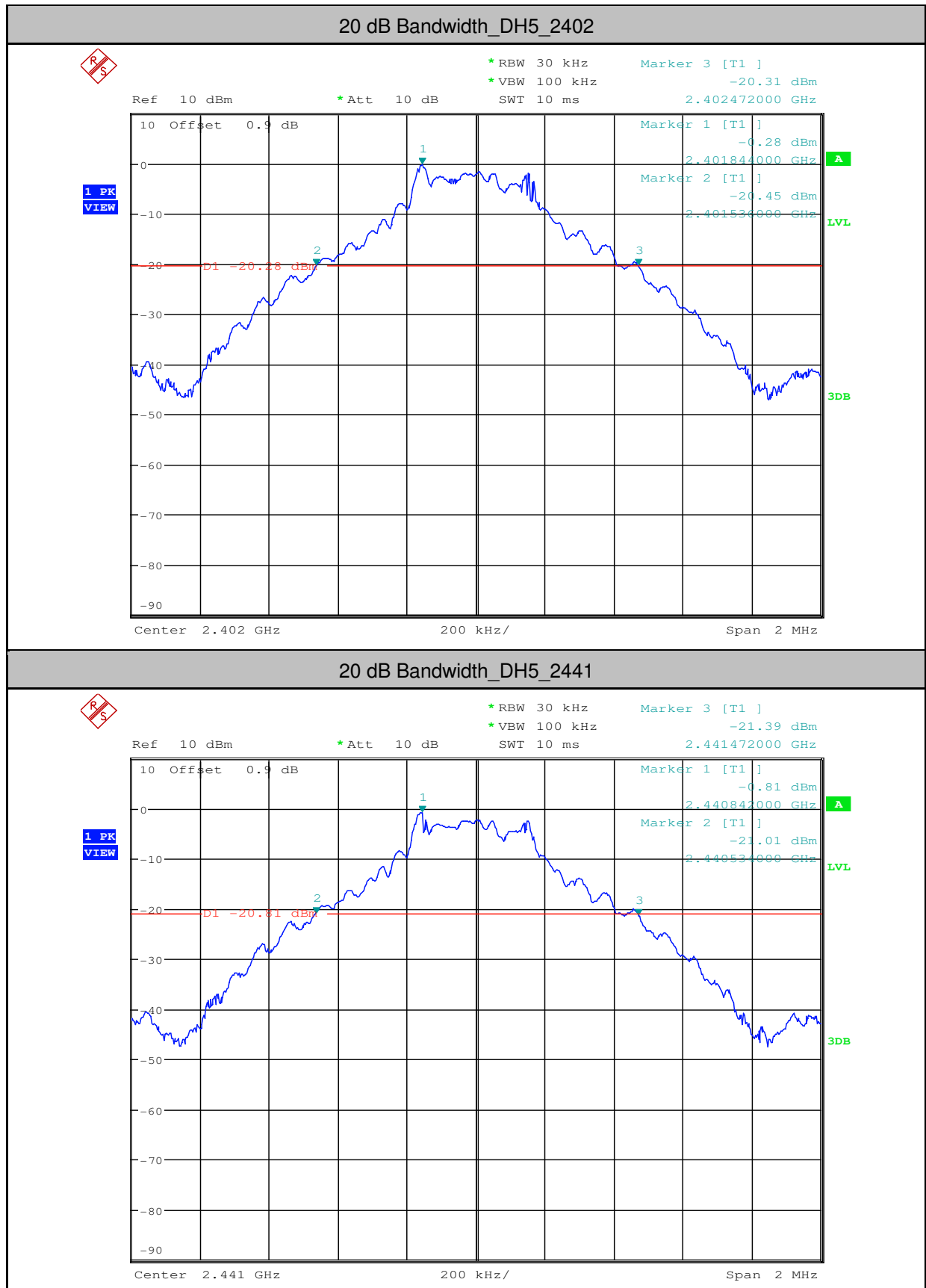


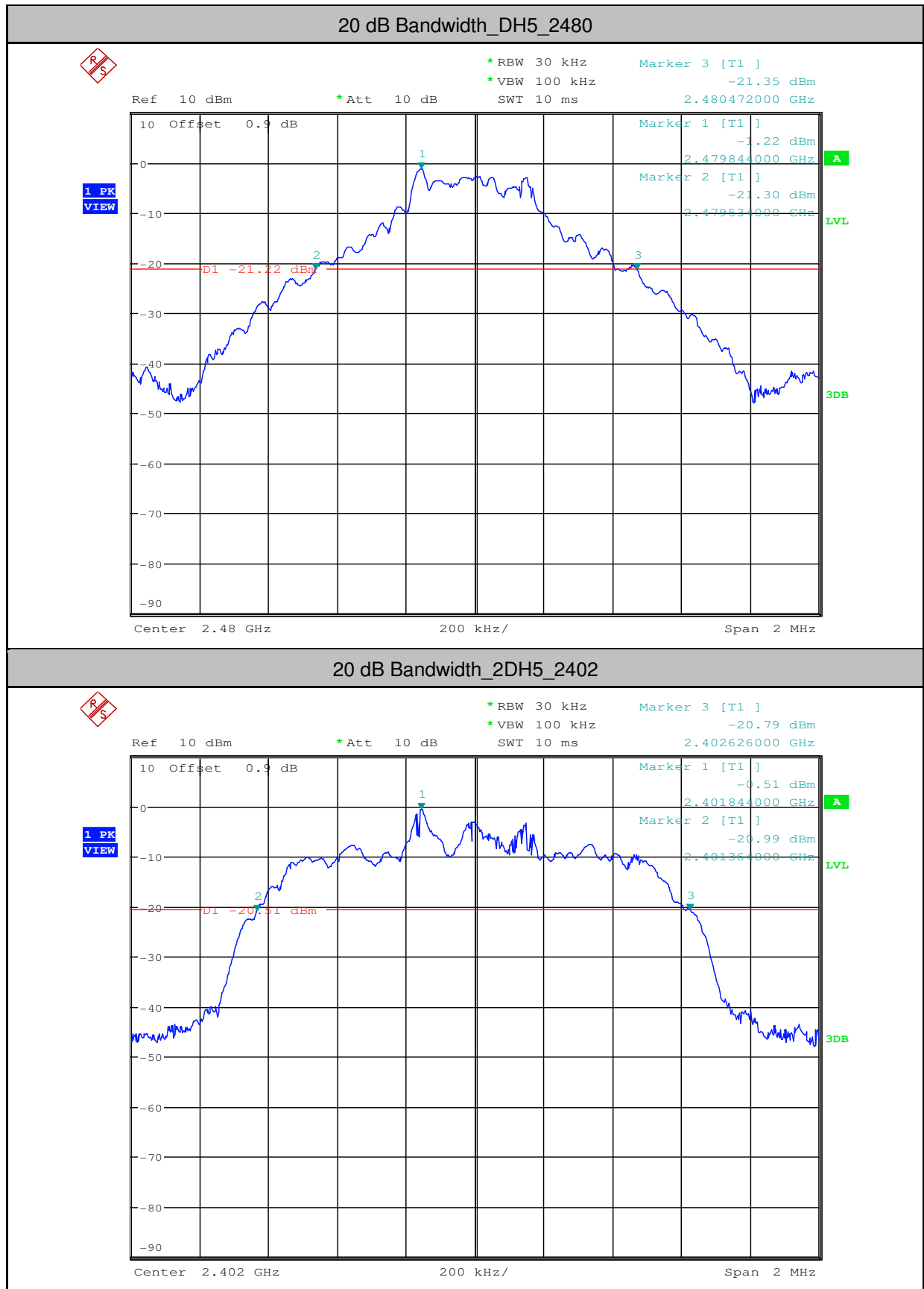

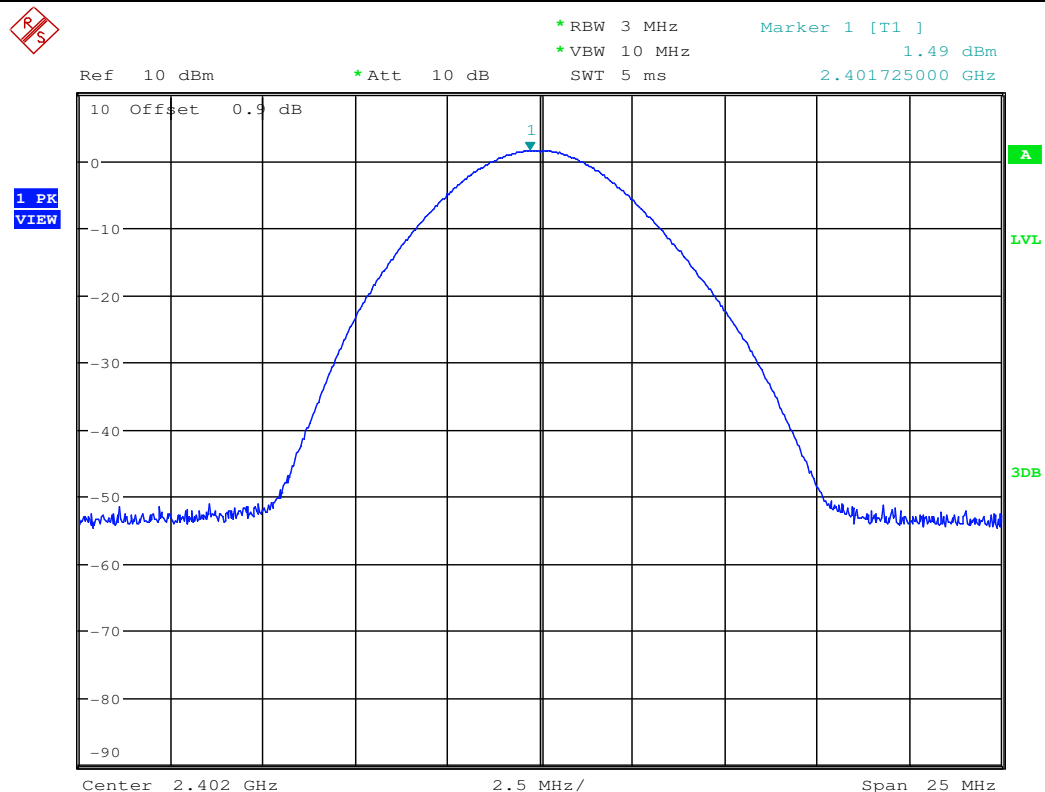




Conducted Peak Output Power\_DH5\_2480

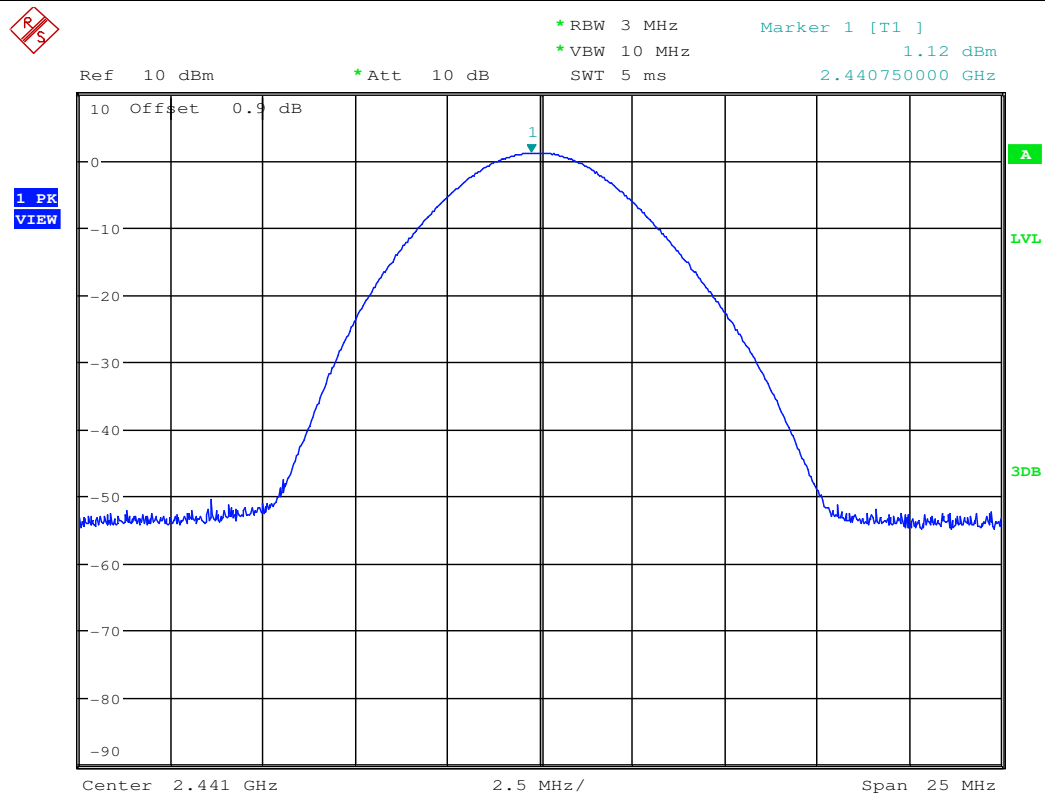
