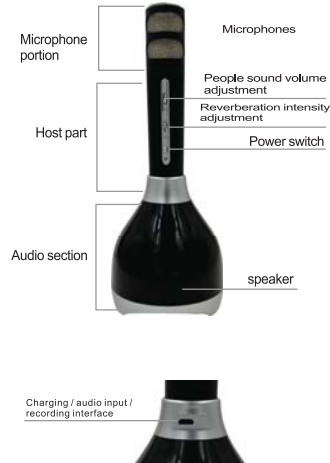

02. Instructions for use

How Wireless sing

1. Turn on the power: the power switch, **blue light** (normal);
 2. **Bluetooth** connectivity: **Bluetooth** and **turn** on your phone to scan, search for "D9" after. The mating connector, the connection can hear the speaker issued a "beep" is heard (Note: If the pairing process Required to enter a password, enter "0000")
 3. **play music**: Open mobile music **player**, such as "cool dog music" download list, favorite songs or accompaniment, start playing, and then click the second icon to adjust the volume via the phone;
 4. **adjust the vocal**: adjust the microphone volume and reverse **vocal** strength to the right place; 5. K song began.
- Note:
- After connecting a mobile phone with **Bluetooth** with memory function boot automatically connect back;
- To disconnect, it can set off **Bluetooth** phone,
- If you only listen to music, you can microphone volume to minimum.

How phone recorded songs

1. the connection line recording: recording accessories line out, insert the USB plug into the recording Mouth, when the Bluetooth function is automatically disconnected.
2. connect the phone: the other end of the audio cable connector into the phone's 3.5mm headphone jack.

3. open mobile phone software: "Sing," a song or other recording APP, select Their favorite songs, singing by the above method, start recording songs.
4. debugging, and save the song: Press the relevant phone software instructions.
- NOTE: Insert the recording cable, Bluetooth will turn off automatically

03. General conditions and treatment

Symptom	Cause of issue	Method of exclusion
Power light does not shine	Low battery or charging cable is not plugged	Check charging cable or charging connector
Microphone does not sound	Power is not turned on or turned on at aliterality	Power is turned on or adjust the vocal volume
No microphone reverb	Reverb switch is not positioned	Adjusting Reverb switch to the appropriate position
Singing or recording noisy	Ambient noise interference from mobile phones	Quiet place to widen the distance with the use of mobile phones
Poor sound effects in some models of mobile phones	The phone does not match the phone sound chip performance is weak outside the grounds	Restart the phone try to replace the use of mobile phones
Bluetooth audio playback staccato	Bluetooth phone and microphone too far away obstructions	Near the phone to avoid obstacles
Bluetooth accompanying sound on or sound small	Phone down the volume of music files or source volume is small	Open the phone media volume louder music download
Bluetooth can not connect	Bluetooth too far away from obstructions has been connected to another phone	Avoid obstacles near the phone has been disconnected and even old phones
Bluetooth music distortion	Sound excessive low battery	Turn down the volume of mobile media to charge the battery
Bluetooth is unable to connect Apple phone singing software	Apple IOS system does not support Bluetooth output	With a cool dog phone or QQ music software

04. How to Charge

1. when the battery voltage is too low, the product will automatically shut down;
2. accessories USB charging cable to connect standard mobile phone charger USB interface to charge, when the red light below the power button lights up, indicating that the battery is being charged;
3. the normal charge for 2 hours and fully charged, the red light goes off automatically;
4. the normal time for 3-5 hours of continuous use.
