### 整机按键说明



如遇到类似死机问题时,可长按开关机键10秒就可以实现复位操作,以此操作相当于拔电池。

### 使用中常见问题处理

- 1 手表无信号或者不识别手机卡: 请关闭手表,然后确认手机卡装卡方向,确认无误后把手机卡装入,然后再重新开机,必要时可以进行恢复出厂设置
- 2 机器出现卡顿情况: 出现这种情况时,请长按开机按键,机器会强制进行重启。
- 3 忘记手表锁屏密码或出现不可描述的系统异常: 开机状态下,连续按30下方的按键,机器会强行进行重置为出厂状态
- 4 手表测试中的相关功能包括心率、气压、血氧和血压测试数值和实际有轻微差别? 产品中的心率、温度、气压、血氧和血压测试数值是传感器通过实际测量并结合智能人工算法计算得出的数据,仅供参考。当出现异常时请第一时间寻找专业设备或医疗机构进行测量。

### 保修说明



### Common problem handling in use

- 1) watch no signal or recognition phone card; please close the watch, and then confirm the phone card direction, confirmed after the phone card, and then restart, if necessary to restore factory Settings
- 2) machine card machine: in this case, please long press the boot button, the machine will be forced to reset
- 3) Forget the password of the watch lock screen or appear indescribable system abnormality: under the boot state, press the lower button continuously for 30 times, and the machine will forcibly reset to the factory state
- 4) The related functions in the watch test include heart rate, air pressure, blood oxygen and blood pressure test values are slightly different from the actual value? The heart rate, temperature, air pressure, blood oxygen and blood pressure test values in the product are the data calculated by actual measurement and combined with intelligent artificial algorithm for reference only. ### Complete machine key instructions



If you encounter a similar crash problem, you can long press the power key for 10 seconds to achieve the reset Operation, in which the operation is equivalent to pulling out the battery.
