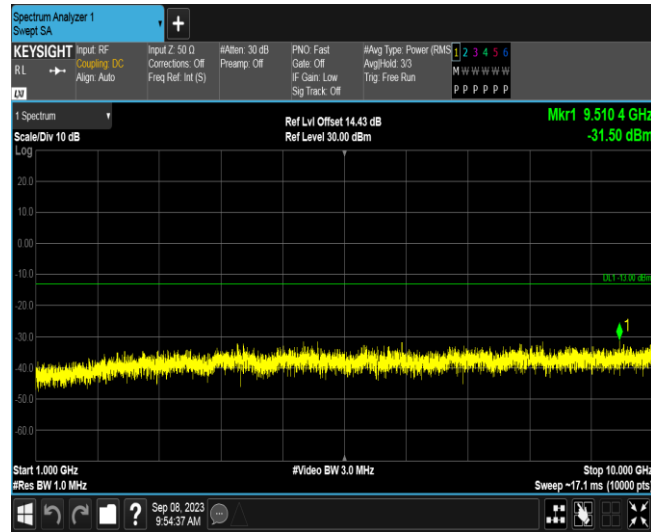


Band12-3MHz-16QAM-23025-1RB#0-Range1:30~1000MHz

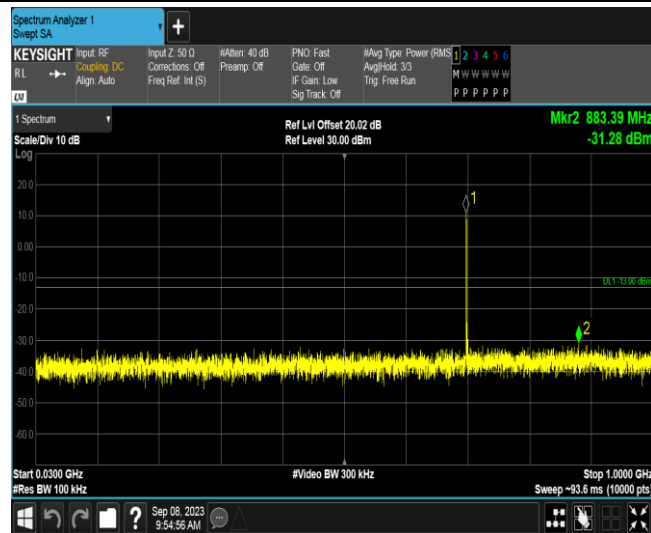

Band12-3MHz-16QAM-23165-1RB#0-Range1:30~1000MHz

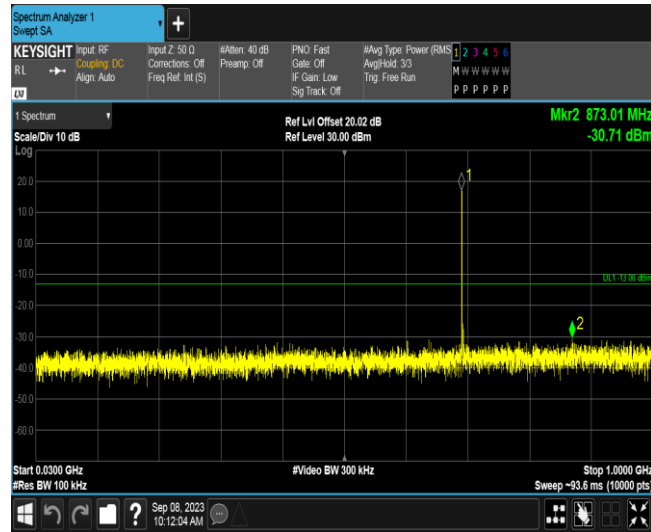

Band12-5MHz-QPSK-23095-1RB#0-Range2:1000~10000MHz

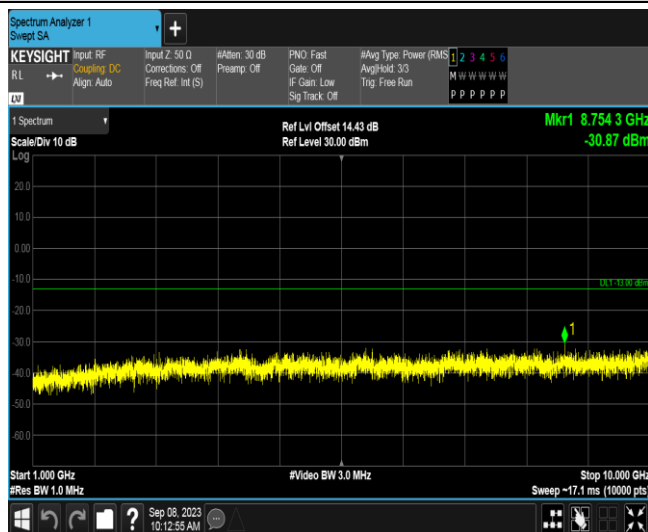

Band12-5MHz-16QAM-23095-1RB#0-Range1:30~1000MHz

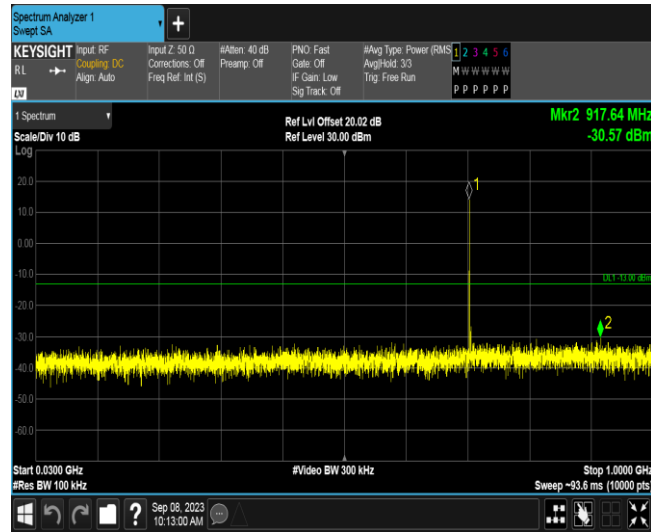

Band12-10MHz-QPSK-23060-1RB#0-Range2:1000~10000MHz

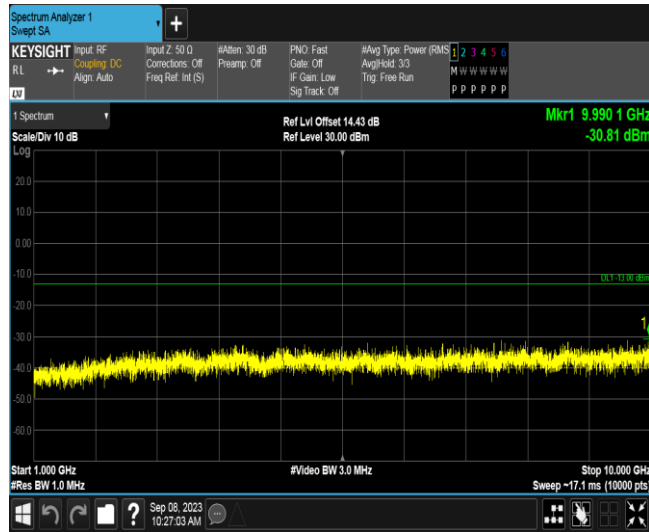

Band12-10MHz-16QAM-23060-1RB#0-Range1:30~1000MHz

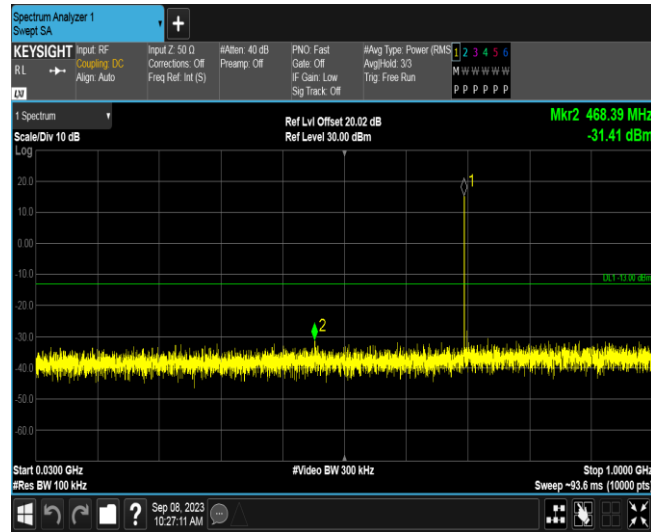
