

Installation Procedure


This PC is intended to be used within a Clear Touch Interactive Flat Panel or a Clear Digital display (if it includes the PC slot).

Because minor details can change between the printing of this document and the arrival of the product, this must be seen as a general guide. The received product will rule.


1. Unscrew the screw with a screwdriver and take off the PC slot cover plate.



2. Push the module into the slot as shown on the left.



3. Screw in the upper and lower screws to secure the Module. Install the antennas (not pictured)


