- Smoking Stopper case is designed to insert a 20 cigarettes pack, based upon standard pack size 88 X 55 X 22 mm

Required minimal configuration:

Smoking Stopper case is built to be connected with smartphones (Android or IOS).

It is strongly recommended to read this guide before using your case and download full user guide on:

By the way, think to watch closely tutorial you will find starting your application on your smartphone.

Connection to smartphone:

Case is designed and optimized to operate with Android and IOS smartphones working with 5 and subsequent Android versions and et 9 and subsequent Iphone versions as well.

Your smartphone must be also compatible with 4.0 BLE Bluetooth version minimum, check it out on your user guide or ask manufacturer.

Battery loading:

Before any use or setting, use micro USB cable connecting your case by bottom USB plug to your computer or connecting to electric network with specific adaptor (not supplied).

When connected, button on the side will blink once with green led

Complete loading timing for first loading: 4 hours

Application download:

Go to **Applestore** ou **Playstore** and select Smoking Stopper application to download. Then, follow information on screens to install your application.

Safety and use instructions:

Please acquaint and respect all the safety instructions before using the device.

- Think of protecting your device from extreme temperatures. To use between 41°F and 100°F (5° et 45°C)
- Don't forget your case on foredeck or rear deck of your car, don't let it right in the sun neither.

In addition, it is not recommended putting your Smoking Stopper case in areas where ambient temperature can be below 41°F (5°C) as cold outsides, snow, refrigerator so on...)

- Avoid putting your case close or inside heaters, high pressure containers, microwave Owens or refrigerator
- Do not touch your case when loading with wet hands.
- Case can be damaged with dust or water penetration inside. Do not submerge your case or getting contact with salted water.
- If your case is wet, dry it correctly with an appropriate clean and soft cloth.
- Keep your case in a dry area
- It is recommended, when case cover is opened, not to force this one beyond a normal opening.
- Don't let young children or pets nibble and lick the case
- Do not submerge the case
