How To Use Your Sound Stick

3. The speaker will enter into Bluetooth pairing mode with the indicator flashing.

4. Find "Pinned Golf Sound" in your Bluetooth devices list and select it to pair.

5. Once paired and connected, you'll hear an audible confirmation from the Sound Stick and the LED indicator will stay on. Your speaker is ready to use!
