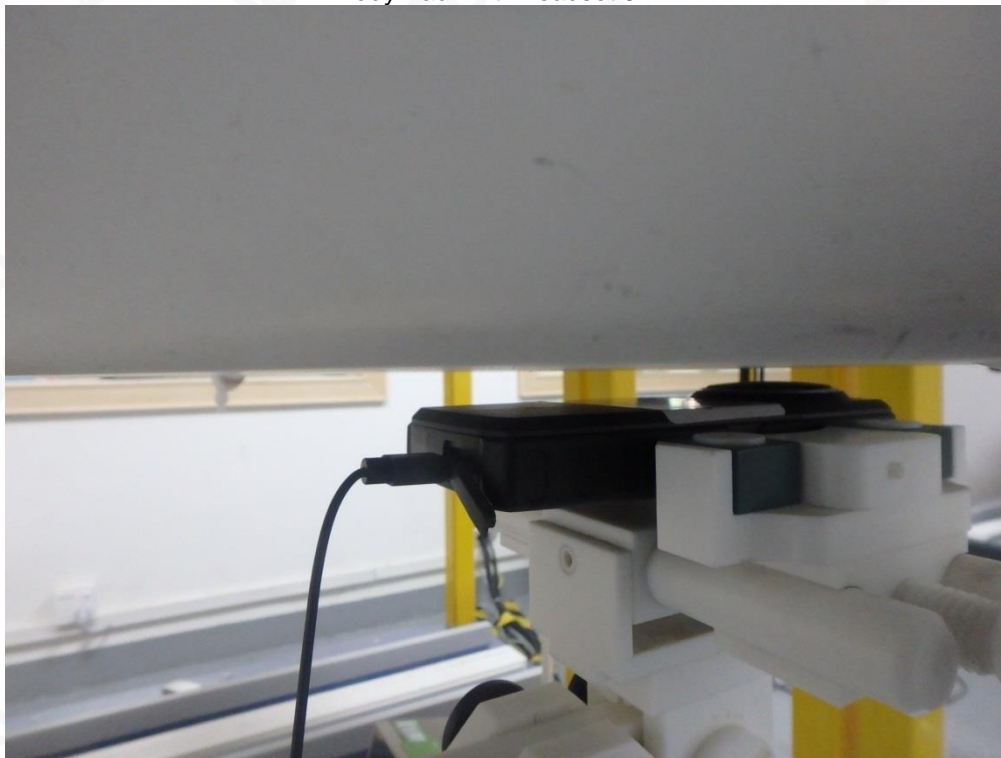

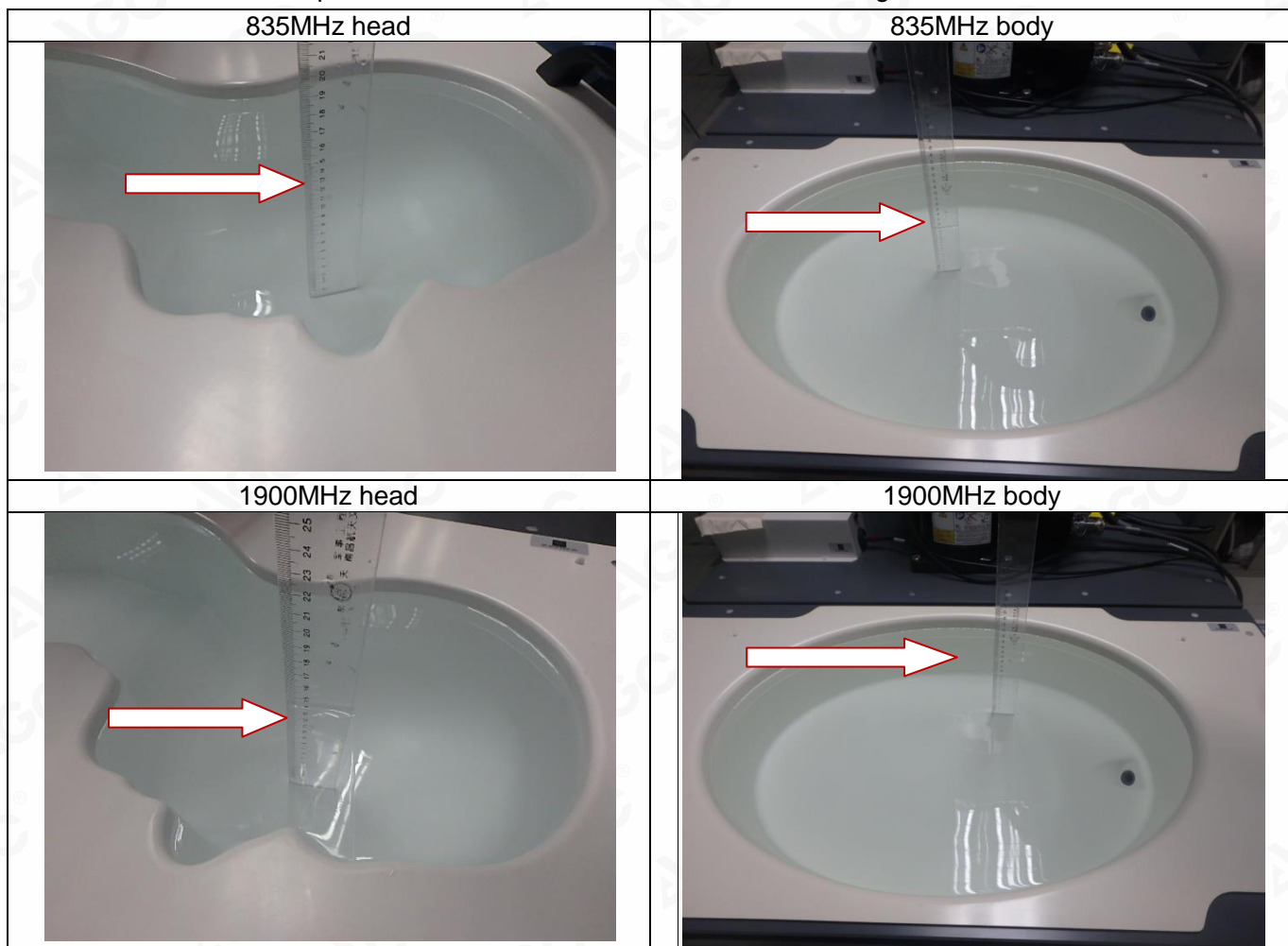

DEPTH OF THE LIQUID IN THE PHANTOM—ZOOM IN

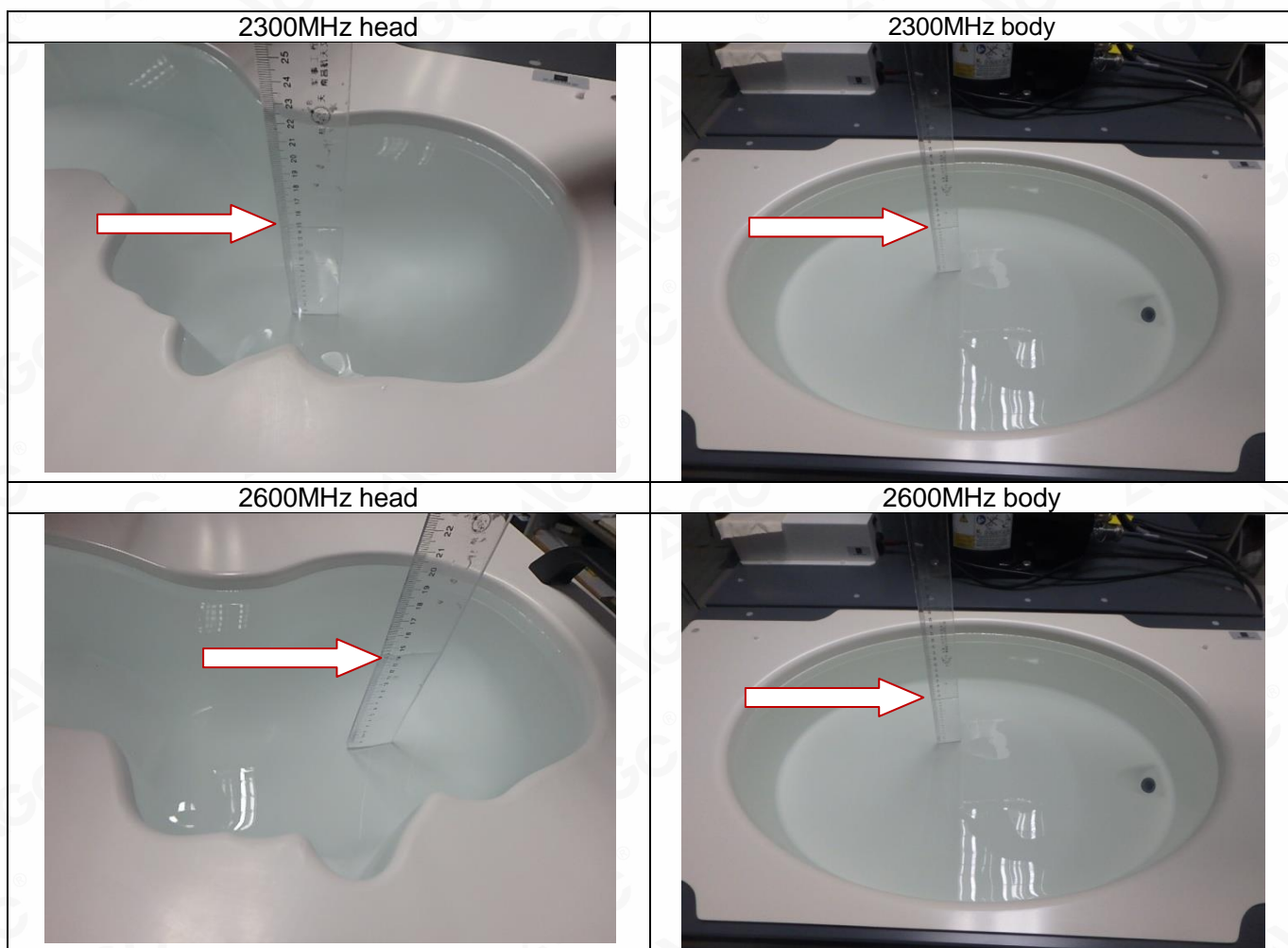
