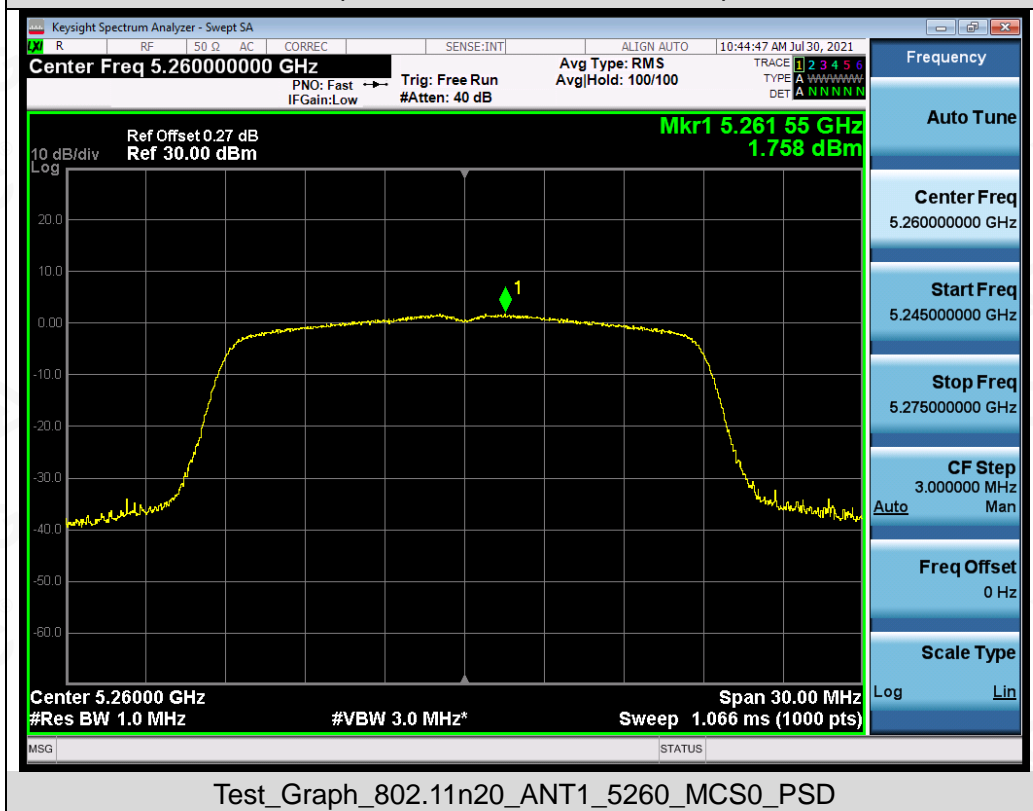

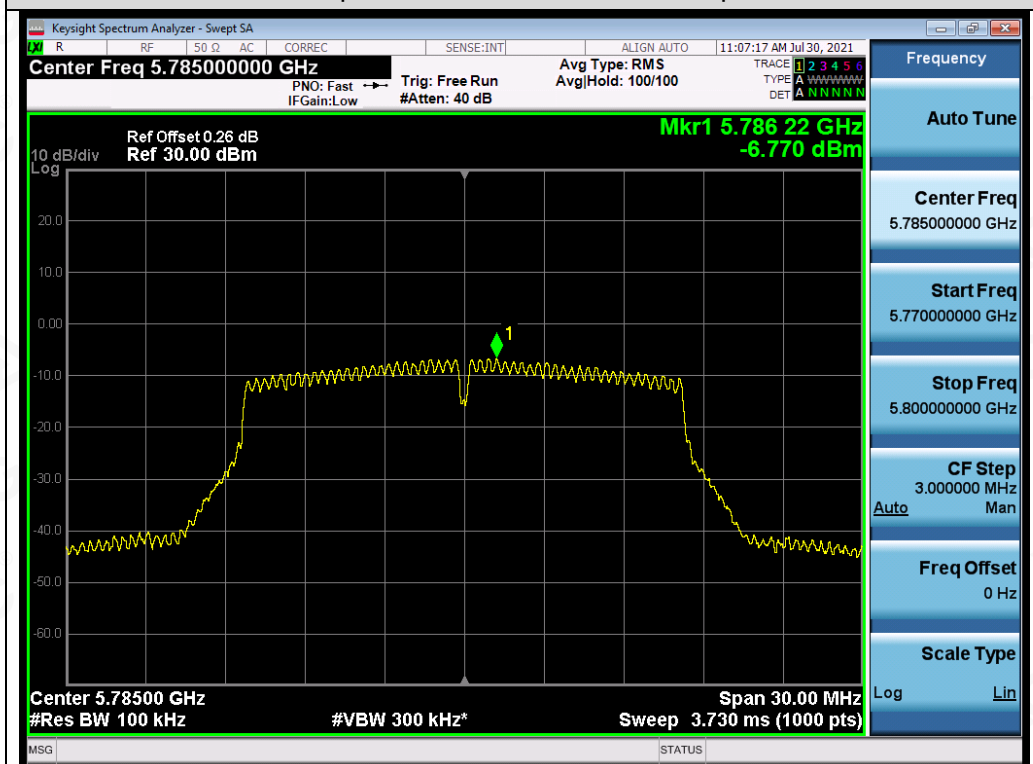




### Test Graphs of Conducted Output Power Spectral Density for band 5.725-5.85 GHz

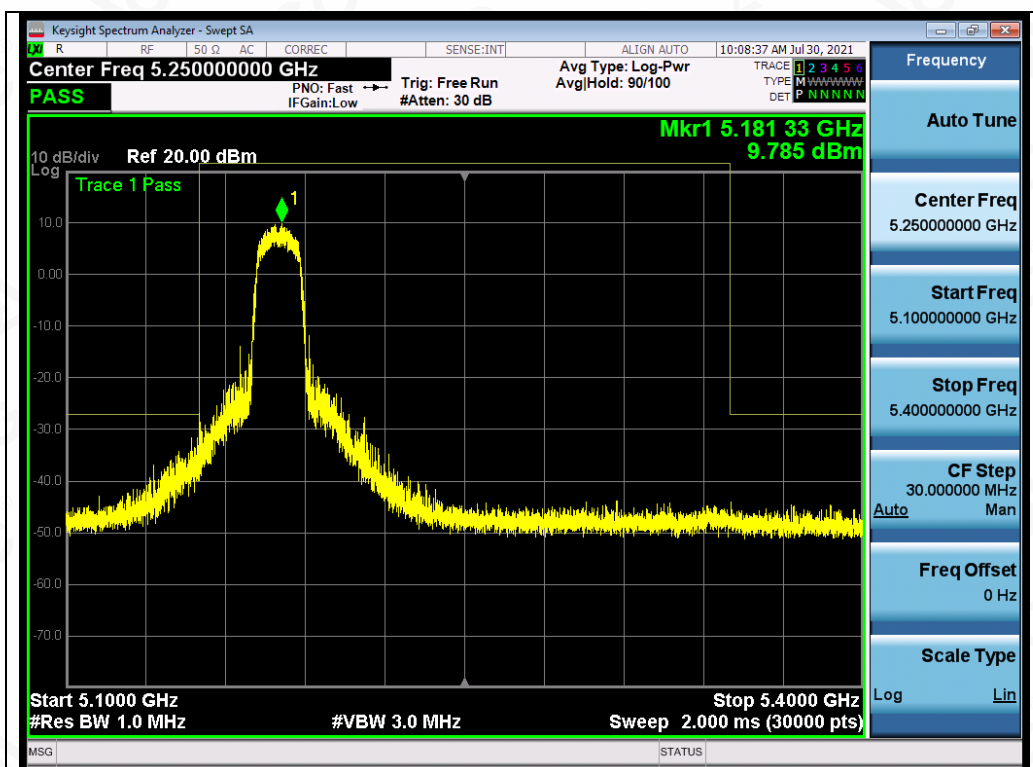


## Test Graphs of Spurious Emissions outside of the 5.15-5.35 GHz band for transmitters operating in the 5.15-5.25 GHz band

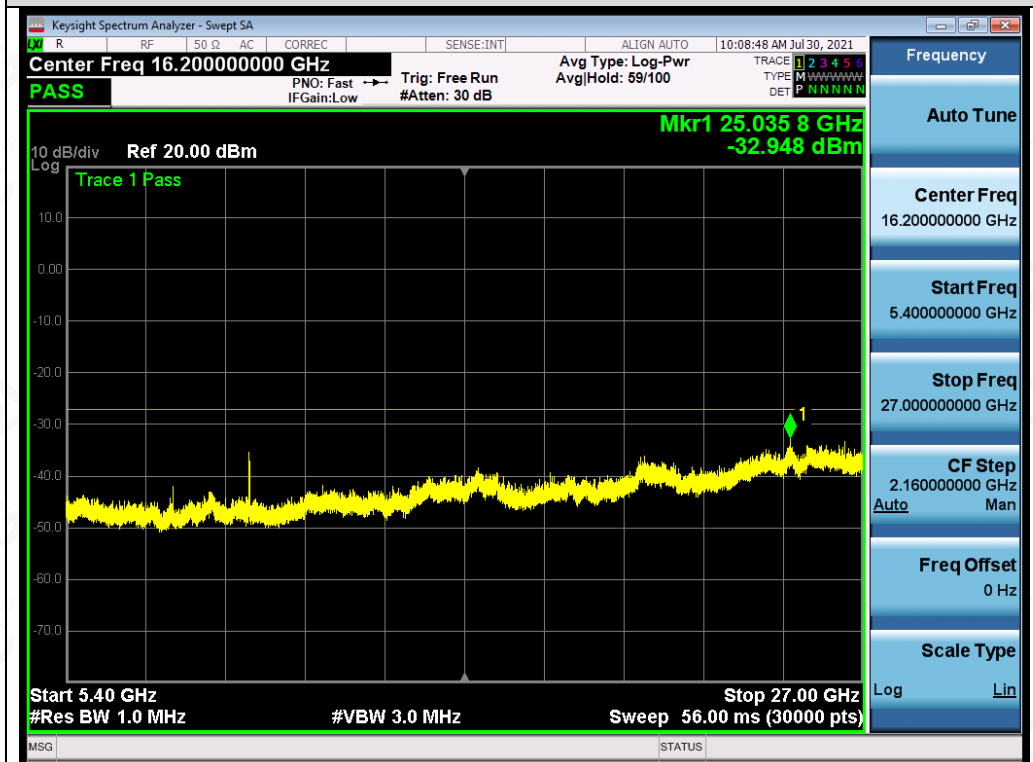

Test\_Graph\_802.11a\_ANT1\_5180\_6Mbps\_Frequency Band 3

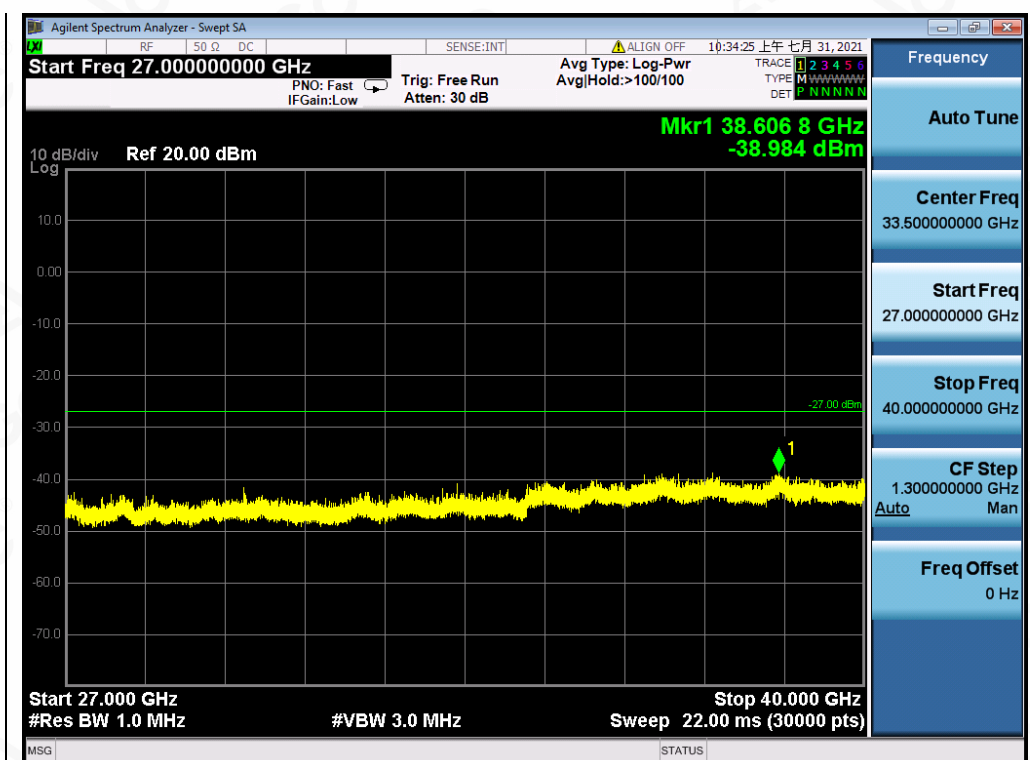

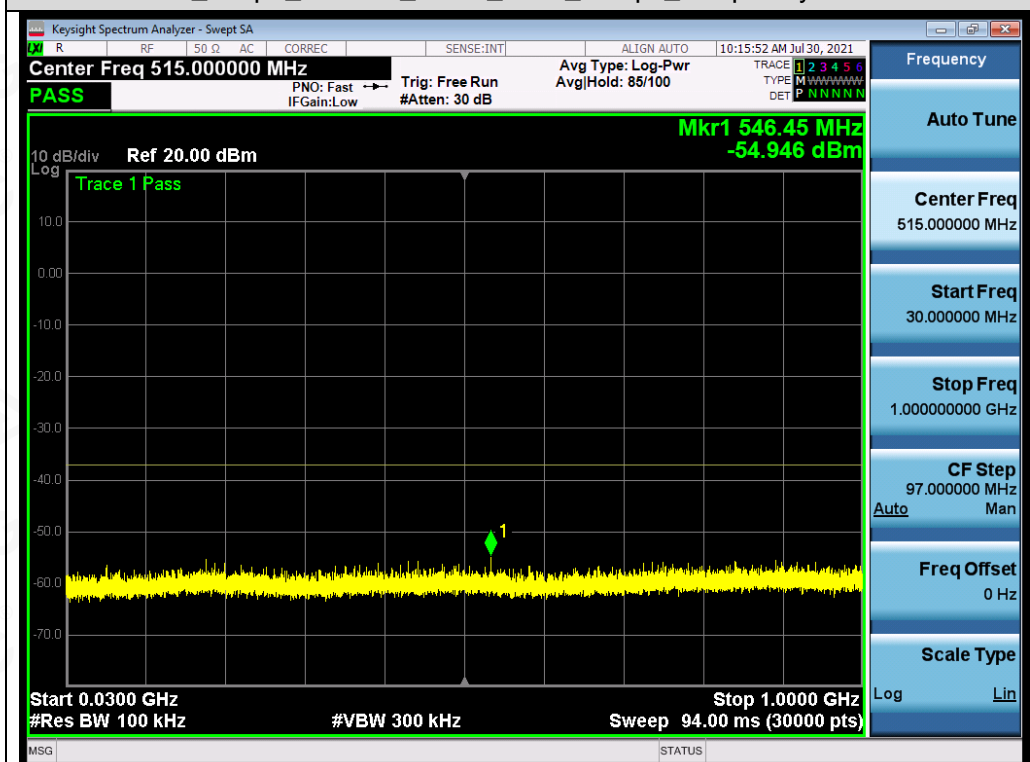

Test\_Graph\_802.11a\_ANT1\_5180\_6Mbps\_Frequency Band 5

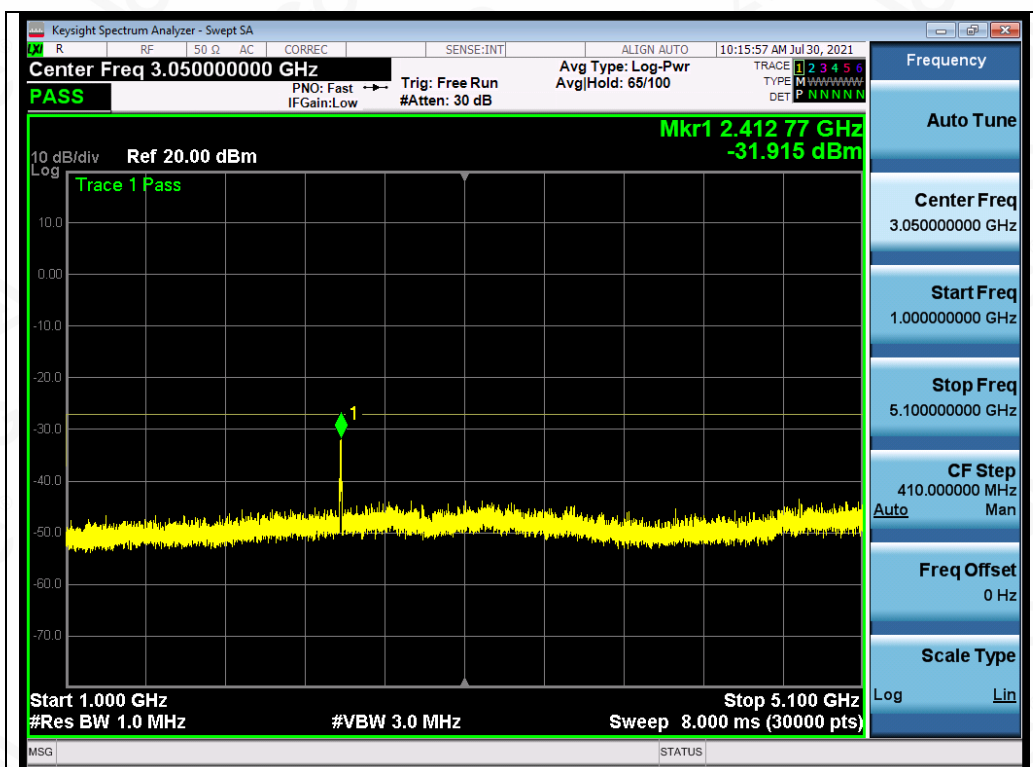

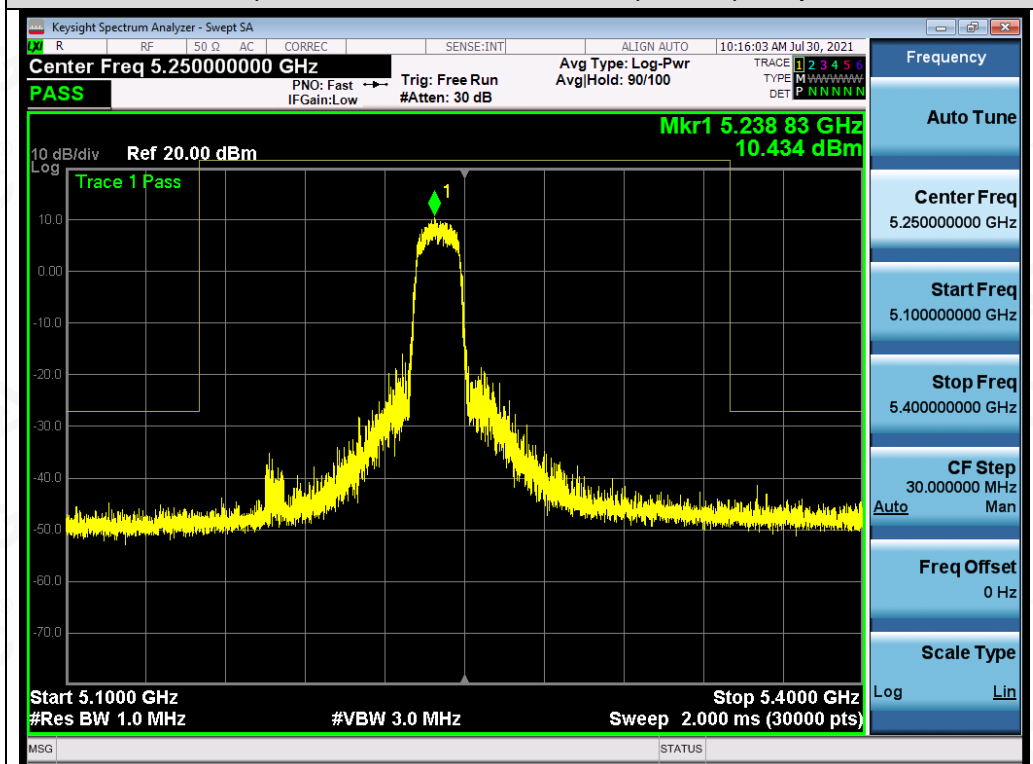

Test\_Graph\_802.11a\_ANT1\_5240\_6Mbps\_Frequency Band 2



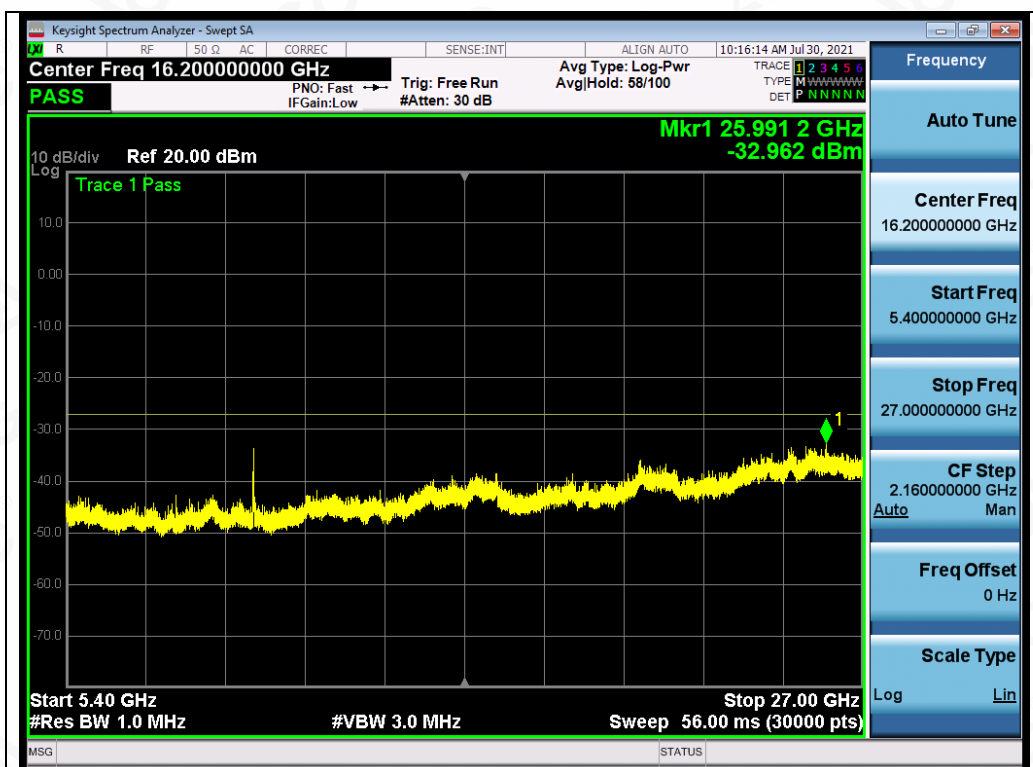

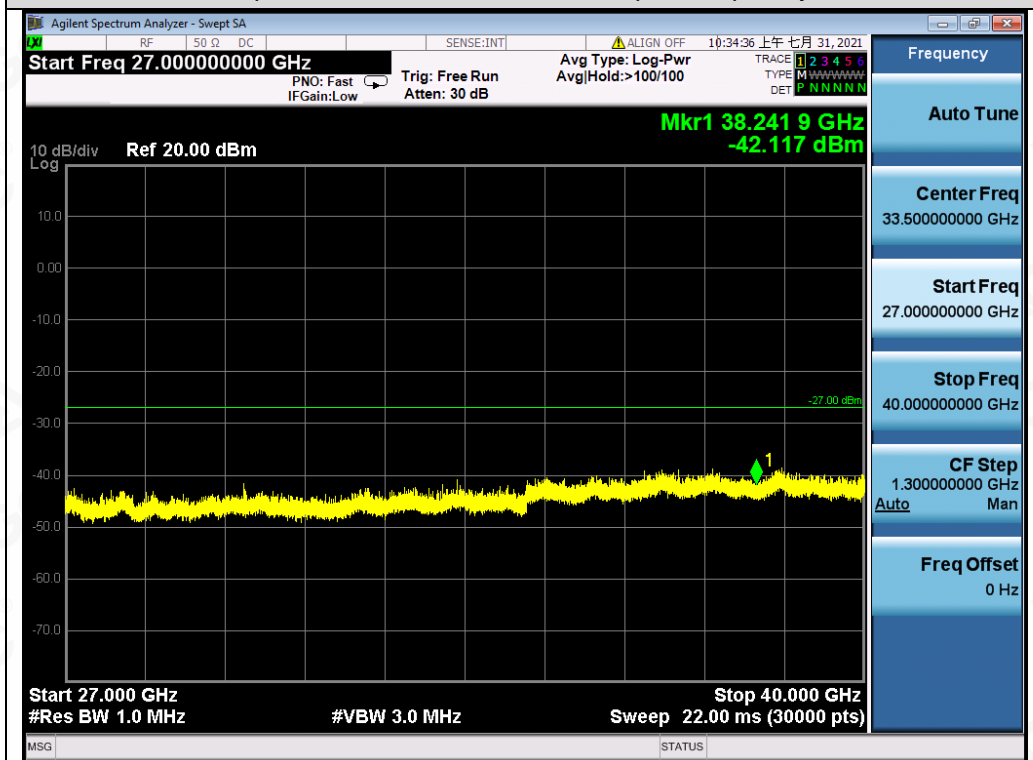

Test\_Graph\_802.11a\_ANT1\_5240\_6Mbps\_Frequency Band 4

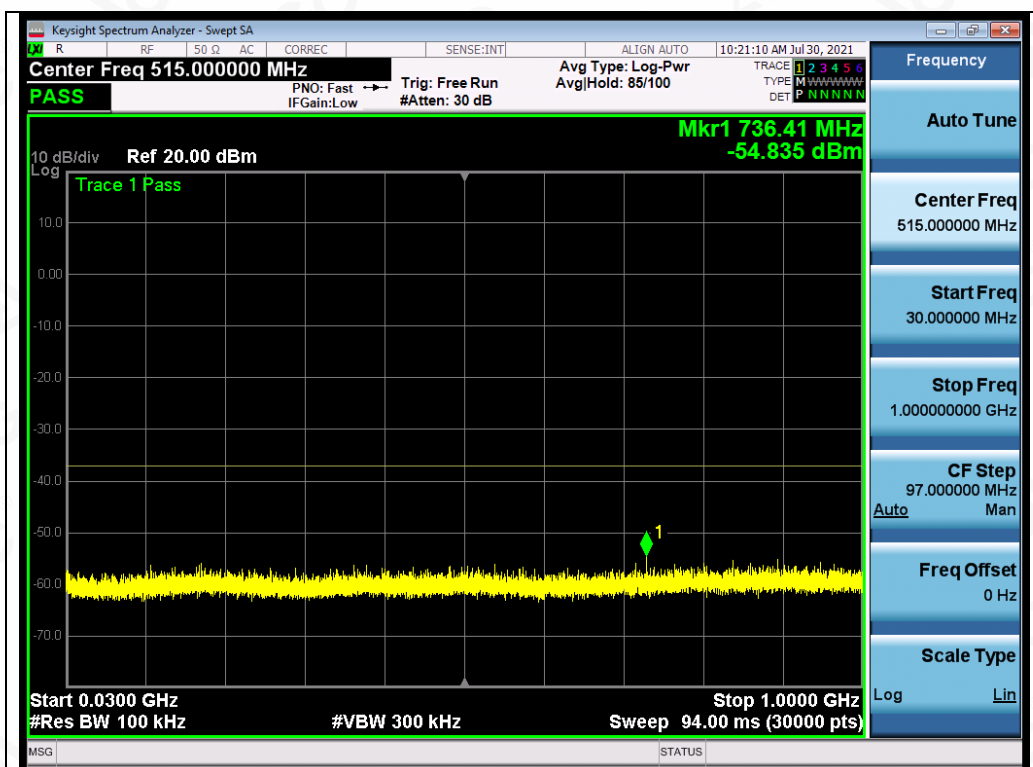

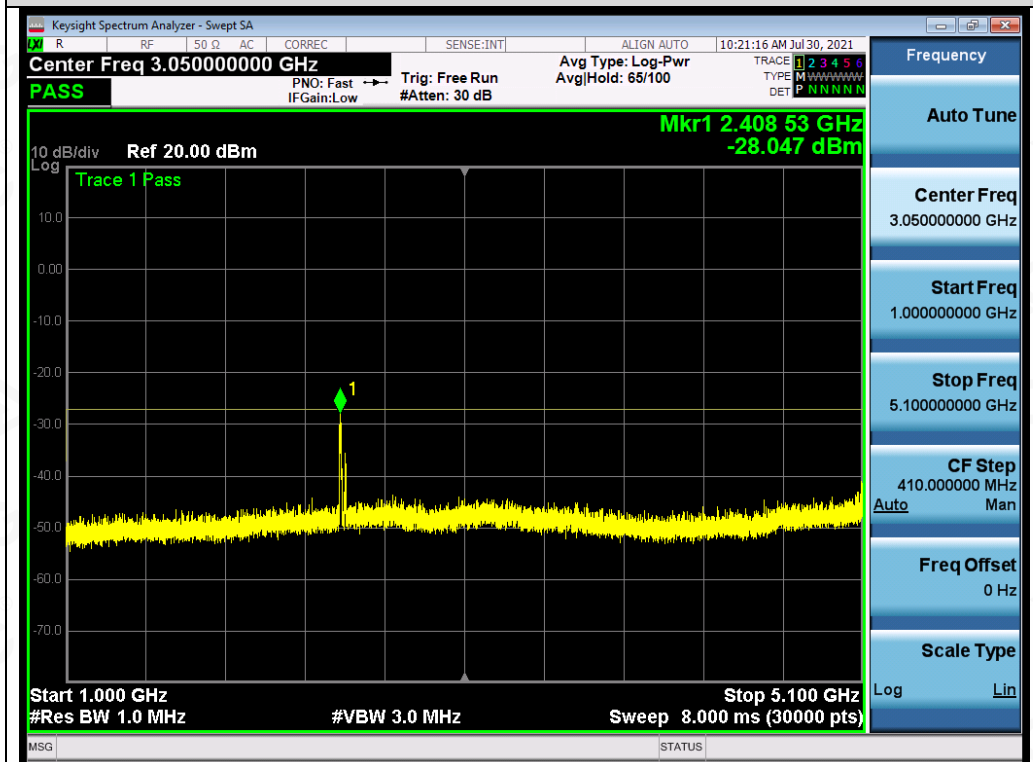

Test\_Graph\_802.11n40\_ANT1\_5190\_MCS0\_Frequency Band 1

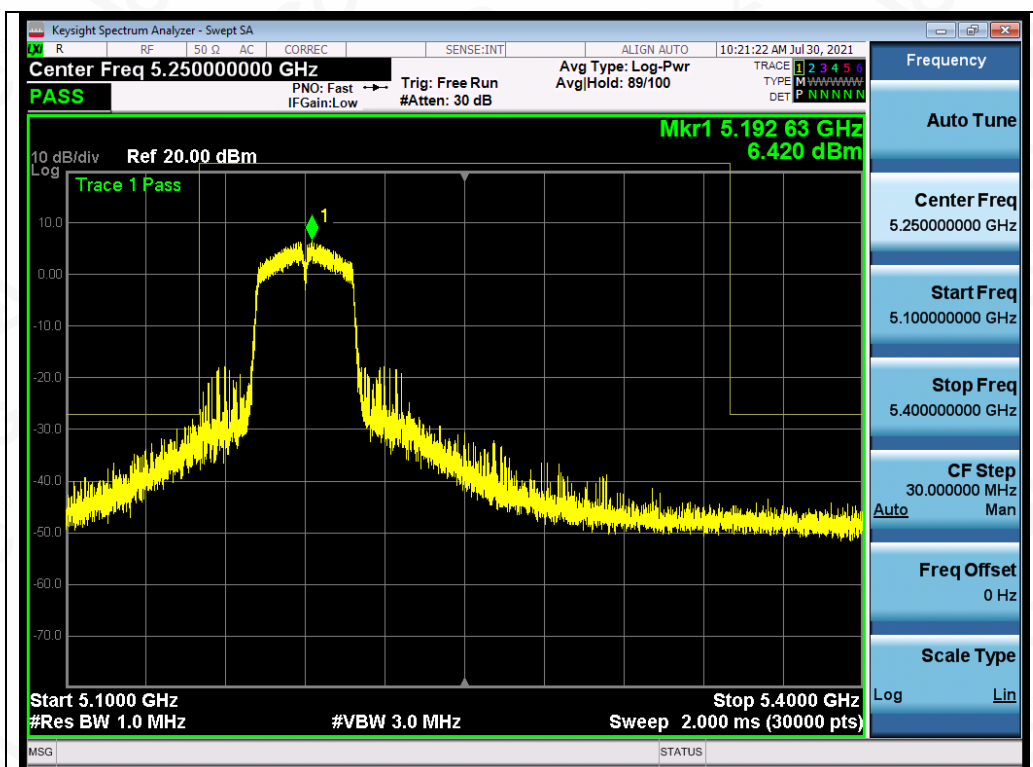

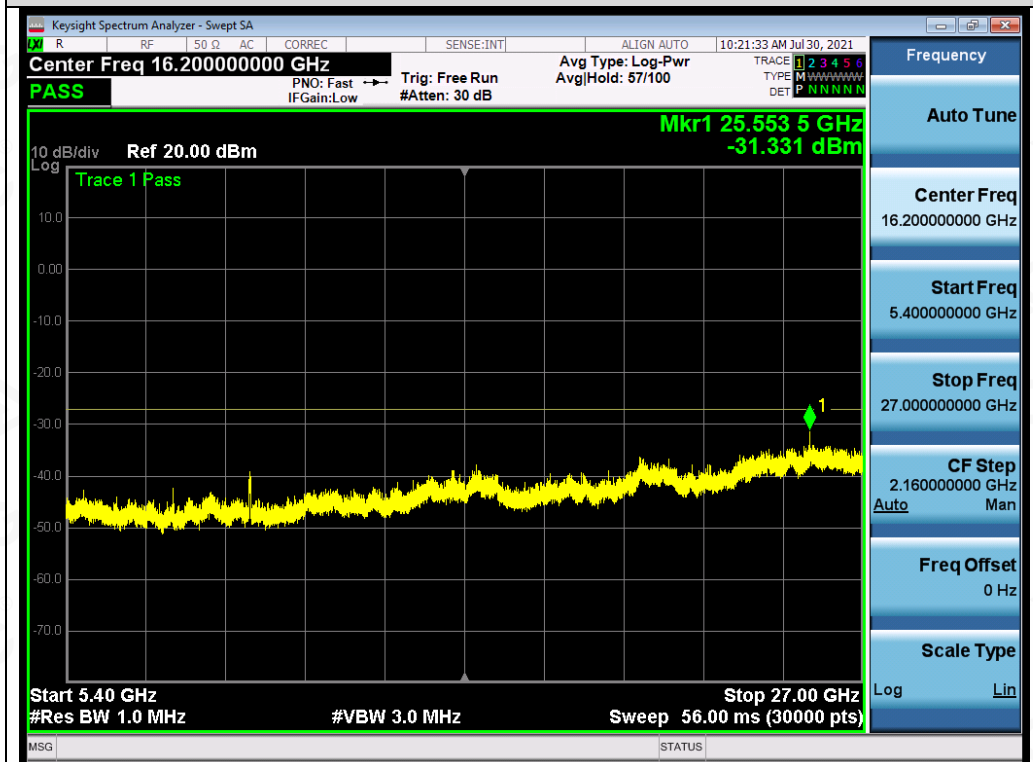
